

High Valley Horses Stable Rules

Attire

1. Barn appropriate clothing should be worn at all times when handling or being near horses. This includes close-toed shoes (Boots are required for all riding students) and long pants.
 2. All students under the age of 18 years are required to wear a properly fitted helmet at all times when riding. Students 18 years old and older are highly encouraged to wear a helmet, however it is not required.
 3. Flip flops, sandals, open toed shoes, flats, skirts, dresses, and any other 'unsafe' stable apparel is forbidden in the stables area or the arena.
 4. All students who participate in jumping lessons must wear the proper English riding attire. This includes either tall boots, or paddock boots and half chaps. Students who do not have the proper riding attire for jumping lessons will not be allowed to participate.
- Failure to meet the stable and riding apparel requirements upon start time of scheduled lesson will result in a cancellation of lesson without refund. All others on property without proper attire will be asked to remain in the viewing area, away from any horses.

Scheduling and Cancellations

5. If you wish to cancel a lesson you have scheduled, please give notice as early as possible. Lessons cancelled more than 12 hours before their scheduled start times will not be charged for. If you cancel a lesson less than 12 hours prior to your scheduled start time, you will be charged for the entire lesson in full, regardless. This applies to all mounted activities, including (but not limited to) private instruction lessons, group lessons, trail rides, etc.
 6. If you show up late to a lesson, the lesson will start and end at the time scheduled, regardless if you arrive on time and will be charged accordingly. If the instructor is late, the lesson may be pushed back to start upon arrival.
 7. Lessons can be scheduled for any person or child between the ages of 7 years and 65 years.
 8. Group Lessons involving jumping cannot exceed the six horse and rider limit.
- Failure to comply with all scheduling and cancellation policies will result in extra charges and fees.

Payment and Fees

9. Acceptable payment methods include cash, venmo, zelle, or check made out to "Cami Johnson". Pay Pal is also accepted with an additional service charge fee.
10. Lessons that have not been paid for are given 24 hours before a late fee is applied. For every 24 hours late that your lesson payment is received after time of instruction has concluded, a \$10.00 charge will be applied to said lesson fee.

Barn Courtesy and Safety Precautions

11. There is no running or screaming in or around the barn, riding area, or anywhere where horses are present.
12. Smoking, vaping, or use of E-cigarettes are strictly prohibited in the barn or arena. The use of any illegal substance on premises is strictly forbidden and any such use will be reported immediately to the proper authorities.
13. All Students must have a signed safety/liability release on file. Students under the age of 18 must have their liability form filled out by a parent or legal guardian.
14. All riders must be of sound mind and body to participate in any equine related activities.

I have carefully read all the rules and requirements of High Valley Horses and their stables. I agree to these rules, including all terms and conditions. I understand each rule listed above and agree to follow the guidelines set out for my safety the safety of my children, guests, and everyone present.
