enator Berry is a graduate of the &t. Peter and Paul High &chool, and attended the Business Administration Program at the University of the Virgin Islands. The eldest of nine children, Lorraine Berry was born on November 15, 1949 to Joseph Ledee of &andy Point, &t. Kitts and Emelda Ledee of &t. Thomas, Virgin Islands. &enator Berry currently resides in the Northside of the Virgin Islands with her husband Richard, proprietor of Berry's Refrigeration and Air-conditioning. &he is a proud parent of her daughter Roxanne, a graduate of the Master's Program at &mith College, &chool of &ocial Work, and her son Kurt, a marketing graduate of Central Florida University.

Senate President Lorraine L. Berry is serving her 12^{th} consecutive term in the Legislature of the Virgin Islands and as President; she is serving her second term in the 22^{nd} Legislature. She is currently the vice chairman of the Committee on Public Safety, Homeland Security and Justice; she serves as a member of the Committee on Rules and Judiciary, and on the Committee of Health, Hospitals and Human Services.

Among her numerous outstanding accomplishments, Senator Berry is a member of the League of Women Voters; the Business and Professional Women's Club; the American Lung Association of the Virgin Islands; the Democratic Territorial Committee; President of VIDAC (Virgin Islanders for Democratic Action Club); and Founder of the Northside Civic Organization and was the catalyst in the establishment of the Beacon Schools Program in the Virgin Islands. Senator Berry has earned many community and governmental awards including the Hope Award from the U.S. Department of Housing and Urban Development, and the American Federation of Teachers (AFT) and the Educational Feddy Award, to name a few.

Senator Berry continues to be very active in community issues, which among many includes an Annual Youth Symposium and Women's Conference. In 1997, she was named "Person of the Year" by the Rotary Club II of St. Thomas. In 2005, she was the recipient of the Wilbur "Bill" LaMotta Award from the St. Thomas/St. John Chamber of Commerce; and was honored by the Montserrat Association of the Virgin Islands for her outstanding community contributions.

inister Paula Ann Cox, JP, MP is the PLP MP for Constituency 14 – Devonshire North West. Minister Cox was first elected to Parliament as a Devonshire North MP, in a bye-election in October 1996. This followed the death of the former Opposition Leader, I. Frederick Wade, JP, MP on August 13, 1996. Currently, Minister Cox is the Minister of Finance. She has had varied experience in Government having held a number of portfolios. She has served in a number of Cabinet portfolios. Under the Premiership of the Honorable Jennifer Smith, JP, MP, now Dame Jennifer Smith, Minister Paula Cox was appointed as the first PLP Minister of Labour, Home Affairs and Public Safety. She and her father, the late C. Eugene Cox, JP, MP were unique as both were Ministers in the first PLP administration and the only serving father-daughter duo.

Minister Cox has gained respect across party lines for her brilliance as an articulate young lawyer and administrator. While the Minister of Labour, Home Affairs and Public Safety, she was named in the Bermudians' Best of Bermuda Gold annual listing as the most effective politician for 2001. She was appointed Minister of Education and Development on November 1, 2001. Following the July 2003 General Election, Ms. Cox was appointed as Attorney-General and Minister of Education. She served in this dual portfolio until January 2004. In 2003, she was again cited in the Bermudian's Best of

Bermuda Gold's annual listing as the most effective politician.

In 2003, while Minister Cox was currently serving as the Attorney-General and Minister of Education and Development, Wheelock College invited Minister Paula Cox to accept an honorary doctorate in Education. Minster Cox received this honorary degree at the May 2004 Wheelock Commencement exercise, Minister Cox was awarded the Honorary Doctorate in Education. In January 2004, after the death of her father, the former Deputy Premier and Minister of Finance, the late C Eugene Cox, CBE, JP MP, Minister Paula Cox was appointed the Minister of Finance.

In her professional life Minister Cox, as a lawyer, is Corporate Counsel at ACE Limited. She previously worked as Vice President and Senior Legal Counsel of Global Funds Services at The Bank of Bermuda Limited. This impeccable background, allows her to give the PLP Government and Party a strong voice in international financial matters, particularly with her expertise in the field of international law and international business

organization.

Minister Paula Cox for many years was one of the closest aides of the late Opposition Leader, Hon. L. Frederick Wade. She was his first Shadow Parliamentary Secretary, and at the same time the PLP's Public Relations Officer. Ms. Cox earned a Bachelor of Arts Degree in Political Science from McGill University, a post-graduate Diploma in International Law from the University of Manchester, England and is a member of the Bermuda Bar, having trained in the United Kingdom as a Solicitor.

Minister Cox is the only daughter of retired educator Mrs. F. Alinda Cox. She is married to a businessman from the Cameroon's, Mr. Germain Nkeuleu and she has two brothers, Jeremy Cox, the Supervisor of Insurance at the Bermuda Monetary Authority - the independent regulator and Robert Cox, an electrical engineer, who currently works

in the United States.



After graduation from Kingston Commercial, Jeanette worked at British American Insurance Company for eight years as the Company's Bookkeeper. In 1970, she made a permanent transition to New York. She enrolled at Monroe Business Institute in the Bronx where she studied computer programming and accounting. She graduated from Monroe after two years and went on to Pace University in Manhattan. In 1974 Jeanette received an Associate's Degree in Nursing from Pace University and then in 1978 she received a Bachelor's Degree in Nursing. They realized that Jamaican patties and Jamaican dishes were in great demand; especially, since their venue was near to Montefiore Hospital. They focused on those products and business grew so rapidly that after five years they needed a larger store. Sunshine Bakery on Dyre Avenue in the Bronx was on the market. In 1980, the HoSangs bought it and changed the name to Dyre Avenue Bakery which eventually became their Flagship Store and remains so until today. In 1987, property was acquired in Mount Vernon for Royal Caribbean Bakery (RCB) which is USDA-approved. All the products were baked at RCB until 1993 when they bought what is now the largest Jamaican-owned baking plant in North America, Caribbean Food Delights in Tappan, New York.

At Royal Caribbean Bakery, Jeanette HoSang is the President. She has expanded the pastry line by making many forgotten Jamaican favorites. Jeanette also runs a retail outlet at RCB on the retail level and Jamaican dishes are cooked and sold. Each year she participates in preparing dishes for the athletes who come up annually for the Penn Relays. Jeanette says her hobbies are collecting cookbooks and playing tennis. In her quiet, unassuming manner, Jeanette HoSang, Nurse, President, Mother, Wife says, "My motto is; I always try to be good at whatever I do."



She attended Ecole Sociale (School of Social Studies) for four years where she received her license as an educator. Four more years were spent studying in the fields of Psychology and Educational Sciences. With that foundation, Jocelyne began her career dealing with the mental health of children and their families at The Children's Hospital in Lausanne, Switzerland.

Jocelyne created a recreation center for the hospitalized children. In this center, these children were not only exposed to innovative games and theater, but also a new medium to communicate their feelings. After 15 years at The Children's Hospital, Jocelyne along with other psychologists, educators, translators and lawyers founded a not-for-profit organization by the name of L'Association Appartenances. Appartenances now has three locations throughout Switzerland. They have several departments that assist women, men and families, as well as provide translators who cover over forty languages, computer education, legal aid and research. Jocelyne works in the department known as Center Femmes (Center for Women). She is one of the Child and Family psychologists.

Jocelyne Michel not only assists in the healing and progress of the Swiss society through her works at Appartenances, but also through politics. The successes in her political endeavors make her the only woman of color on the Legislative Counsel for the Commune of Pully, Switzerland. She has been on this counsel for nine years as a member of the Naturalization Commission, where she served as President for four years. Her decisions affect the naturalization process and opportunities for many who seek to become Swiss citizens. She is the mother of one daughter, Clemence. Her philosophy is to think, to believe, but above all to be compassionate and honest. Jocelyne Michel is a true advocate for the less privileged.

Dr. Pyant graduated from New York University with a Masters in Reading Psychology, and holds second Masters in Administration and Supervision. Dr. Pyant was employed as a part-time professor of psychology teaching undergraduates at the college of New Rochelle for five years. She moved on to teach for Walden University in their Masters of Education program, where she is currently employed as a part time professor. She currently serves full time as an Assistant Principal and Special Education Supervisor, supervising Pre-Kindergarten and Kindergarten, as well as the First, Second, and Fifth grades. In addition, Dr. Pyant has a private practice where she provides therapy to families and marriages in crisis. Dr. Pyant serves as wife, minister, educator, therapist, and motivational speaker. She began tutoring children in the home in 1991 and later had the vision to use the church for a tutorial and summer camp program. The program provided jobs for women and teens in the community, and a safe, social environment for the academic at-risk children that she served. The program enrolled more than sixty students for summers of fun, as well as employed youth from the Summer Youth Program. Dr. Pyant has a strong belief that children need to develop social skills for their success and future. She trained her staff to support the children's social development, as well as provide small group tutoring. In 1998, Dr. Pyant founded the Higher Steps Day Care and continued her After-School Tutorial Program and Summer Camp. In August 2000, Dr. Pyant closed the Day Care and the Summer Camp business when she became an Assistant Principal and began her private counseling practice where she continues to provide counsel to families and youth in crisis.

Dr. Dyant says her therapy practice is designed to guide clients toward identifying and bringing forth the crisis in their lives, and helping them bring understanding to their situations so that they can move on and live. Being led by the Spirit, her untiring work with people has encouraged and fostered change in their lives. Dr. Dyant is a Dillar in her home, church, and community.

Dr. Pyant has parented eight children and raised more than twenty. She and her husband were licensed foster parents for fifteen years. Following her marriage to Alla Reddy, she moved to the United States where she became a professor at Cheyney University and a tutor for students of all backgrounds.

As a graduate from Cheyney University with a Masters in Special Education, she was the first Asian teacher in the conservative West Chester Area school district, and the first teacher in the school district to wear her traditional attire (an Indian Sari) throughout her eighteen years of service. While working with mentally, physically and emotionally handicapped students, she also engaged the school staff to actively promote multicultural awareness to tens of thousands of students during her career. Each year she would travel to schools and classes throughout the public school system to educate and expose Indian culture, customs, traditions and food.

Upon retiring from teaching, she moved to Hawaii where she found a tremendous need for teachers from the continental United States. While in Hawaii, Raji worked with students in a program designed for low achievers to help them increase their self-esteem and become responsible members of the community.

Since her first days of teaching in India, Raji has been an integral part of many students' lives from all socioeconomic levels, religions and backgrounds. She hopes to continue this pursuit of bringing education, diverse perspectives and self-confidence to children in both the U.S. and in her birth country of India.

The work that Dr. Sheridan has completed and continues to offer has prepared her for a leadership position as a physician in reducing the gap in health disparities. Dr. Sheridan proudly claims to be a Native New Yorker born of Caribbean parents. While at Buffalo, she was active in the Student National Medical Association (SNMA) and spent time in the SNMA-sponsored sub-internship programs. She returned to New York in 1979. She successfully completed her internship at Brookdale Hospital in the Department of Internal Medicine and went on to graduate from the Department of Family Practice in 1982. After a brief stint as a full-time attending physician at the Brookdale Family Practice Center, a unique clinic staffed by Family Practitioners, Dr. Sheridan entered Private Practice in the Brownsville Community. From 1993 until 1997, she was a member for the Teaching Faculty at Brookdale. As a manager and leader, Dr. Sheridan was able to interact with the resident doctors, supervise their work, and help to prepare them for the practice of Medicine.

Dr. Sheridan is a Diplomate of the American Academy of Family Practice, with affiliations at the State and Local levels. Certified 1983-90. Recertified 1990-97; 1997-2004; 2004-2011. Dr. Sheridan is a member of the Overseas Medical Assistance Team, a group of Doctors and Health Care Professionals who volunteer their time for annual trips to Underserved Areas of the Caribbean and Africa. In 1999, Dr. Sheridan was a member of a team of twenty Family Physicians who were a part of a cultural exchange with Physicians in Cuba. There they observed the Medical care in that Country and were involved in promoting healthy dialogue and exchange of ideas between Family Doctors with the objective of promoting good will between professionals.

In November 2003, Dr. Sheridan launched the Crace Family Medical Practice, where she practices solo (for the first time in twenty years) with a staff that includes a Family Nurse Practitioner and Nutritionist. Dr. Sheridan has been named as one of New York's "Top Doctors" for 2001, 2002, 2003, 2004, and again for 2005. Besides her hospital and medical duties, Dr. Sheridan is a full-time mother of two college-age daughters, and manages to make time for her other interests, which include running an e-commerce business, singing, gardening, writing, making computer art for her friends and traveling.



The Honorable Dame Jennifer M. Smith, DBE, DHumL, JP, MP, WGE

ame Jennifer is the Vice Chairman of the Executive Committee of the Commonwealth Parliamentary Association. She is the Regional Representative for the Caribbean, Atlantic and Americas Region. Dame Jennifer is the Deputy Speaker of the Bermuda House of Assembly. She represents the Constituency of St. George's North.

Dame Jennifer has the distinction of being the first Leader of the Bermuda Progressive Labour Party (PLP) to guide them to a general election victory after thirty-six years in Opposition. This victory happened on Monday, November 9, 1998. Dame Jennifer also led her Party to an historic second term on July 24, 2003. However, four days later - following a revolt by eleven of the twenty-two newly elected PLP Members of Parliament - she resigned her position as Party Leader and Premier. In her farewell speech, Dame Jennifer said that she was loathe to subject her Party to the intense internal fighting a tied vote in the Parliamentary Group would entail, just days into its second term as government.

Dame Jennifer has gained a wealth of experience in her thirty-five years as a Parliamentarian. Prior to becoming an elected Member of the House of Assembly in 1989, she had the honour of being the youngest woman to run in a general election (1972). In 1980, she became the first woman appointed to the Senate and the youngest member at that time. There, she became known as an effective and articulate Bermuda Progressive Labour Party spokesperson on Education, Health and Social Services, Youth, Sports and Recreation, and Culture. During six attempts over a period of 17 years, she changed her St. George's North constituency from a UBP stronghold into a PLP stronghold. With her election in 1989, Jennifer Smith brought dignity and distinction to the House of Assembly, dedication and diplomacy to her constituency and hope and optimism to Bermuda.

Dame Jennifer established the framework for change in Education as the Bermuda Progressive Labour Party Government's first Minister of Education. Jennifer Smith relinquished the Education portfolio on April 1, 1999, to better concentrate on the role of Premier. Dame Jennifer's political experience has been broadened through participation at various international conferences and symposiums, including: the World Economic Forum in Davos, Switzerland, the Overseas Territories Consultative Council meetings in London, The Commonwealth Parliamentary Association's Plenary Conferences and the UK/Caribbean Forum in Guyana.

Dame Jennifer's background, both by training and experience, encompasses the Arts, Journalism, Public Relations, Advertising and Communications. Her deep personal empathy for people and their concerns has helped her to transcend gender and race in all sectors of the Bermuda community. Her commitment to service and social issues over the years has included service as Public Relations Officer for the Bermuda TB Cancer and Health Association; a Charter Member of the &t. George's Jaycees; a Founding Member of Friends of the Bermuda College Library, a Founding Member of the Bermuda Heritage Association, a member of the Board of Trustees of the Bermuda National Gallery, and a volunteer for Masterworks. In addition, she is a member of the Bermuda Biological Station for Research, the Bermuda Society of Arts, The Bermuda Business & Professional Women's Club; The Berkeley Educational Society; Masterworks Foundation; Bermuda Zoological Society; Amnesty International; Bermuda Debate Society; The Bermuda Arts Centre at Dockyard; Keep Bermuda Beautiful, the Bermuda Maritime Museum and Richard Allen AME Church.
