

Mabel & Stanley Publishing Contract

- There is a one-off payment for the cost to publish your (the author's) book
- The cost can be paid in full at the beginning of the publishing process or 50% up front and the final 50% before the book is ready to go live (the book will not go live until all monies have been received)
- You (the author) have two opportunities to make or request amendments to the proof copy of your book once you agree to the proof copy any further amendments will be charged accordingly
- Once your book is live and on the Amazon platform, the contract between you and Mabel & Stanley Publishing ends
- Your work is uploaded to a platform called kdp (kindle direct publishing) before it is listed on the Amazon website
- You are able to order author copies directly from Amazon at a substantial reduction to the sale price plus delivery you are then able to sell these copies wherever you choose such as book shops
- Mabel & Stanley are not able to change certain procedures dictated by kdp or Amazon such as size options, price bands, some formatting options or technical requirements – we will endeavour to advise you of the best options available to you as the author within these guidelines
- Mabel & Stanley Publishing will not take any ongoing royalties from the sale of your book and will have no rights to your book once it is published
- We (Mabel & Stanley Publishing) do not have any responsibility for how many copies you sell nor for the marketing of your book these are entirely the responsibility of you, the author
- Mabel & Stanley Publishing can offer marketing services for an additional cost
- Front cover design is the responsibility of the author however Mabel & Stanley Publishing are able to offer advice if needed cover design by Mabel & Stanley may be charged accordingly
- Editing and proof reading are the responsibility of the author unless you commission the services of Mabel & Stanley Publishing or an independent editor
- Mabel & Stanley reserve the right NOT to publish material that it deems offensive or inappropriate such as references to extreme violence, terrorism or discriminatory and racially inflammatory content
- Mabel & Stanley reserve the right to refuse to publish any work that it deems likely to reflect poorly on the publishing house or its other authors in terms of quality ie; poorly edited manuscripts, poor composition and grammar or lack of professionalism
- Mabel & Stanley Publishing endeavour to get your work published in the shortest time scale possible whilst maintaining a high standard for the finished product but estimates of time given are only approximate and can be subject to change

- Mabel & Stanley Publishing cannot control the length of time taken by third parties with regard to the author's work; such as illustrators
- All conversations between the author and Mabel & Stanley Publishing regarding the WIP (work in progress) leading up to publication will be treated with utmost professionalism and will remain confidential unless otherwise instructed
- Mabel & Stanley Publishing will not undertake a publishing commission without receipt of a signed and dated contract (either by post or email)
- Mabel & Stanley Publishing reserve the right to maintain high standards across their published books and seek to achieve consistency. These consistencies include (but are not limited to); position of logo and ISBN code on the bottom left and bottom right-hand corners of the book's back covers respectively, the inclusion of a blurb or brief synopsis of the work or story on the back of the book, acknowledgements and about the author can be included on the first pages of the book. Mabel & Stanley Publishing reserve the right to request changes in order to meet these standards but only in consultation with the author
