March 11, 2019

The Horse Cave City Council met in regular session Monday, March 11, 2019 at 6:00 P.M. at City Hall. Present were Mayor Randall Curry, council members Maronda Gibson, Larry Bunch, Velpha Hatchett, Vickie Rogers, David Lindsey and Perry Martin.

Mayor Curry declared that a quorum was present and called the meeting to order.

A.
