#### 1. Call meeting to order/roll call

Olmedo states that the Division of Water Resources wants each water supplier to update their water conservation plan every 5 years if there is one, if there isn't one it must be created. RMPU doesn't have one so the staff is working with Nevada Rural Water Association to create one. NRWA was in Hadley on December 8, 2020 conducting a pressure test and leak test. Every quarter the sewer ponds are serviced, there has been a noted grease build up. The Town office will be reaching out to local business with kitchens to ensure they are complying with the regulations. Christmas decorating contest has 4 entries and deadline to enter is December 17, 2020, judging will be December 18, 2020, and announced December 22, 2020. Town offices will be closed December 24 and 25, 2020 for the holidays. Olmedo wants to present Musselman and Barber with a plaque for service on the board.
