STEP 1: Prepare documentation for the country you are visiting.

- Passport (image of the page with personal details).
- Recent photograph with white background
- Return ticket
- Hotel reservation/Invitation letter (e-mail and telephone)
- Completed standard form and proof of transfer
- Fee: 90€ (1E - 30D) // 115€ (ME 30D) // 140€ (ME 90D)

CAPE VERDE (residents in Spain only):

- Copy of passport (the original passport will be sent to the Embassy)
- Two recent photographs with white background (only 31-90D)
- TSA (done by the Consulate)
- Round-trip airline ticket
- Hotel reservation / Letter of invitation (e-mail & phone)
- Completed Embassy form and proof of transfer (only 31-90D)
- Fee: From 1-30D: 50€ (TSA only). Payment of 45€ at the airport of arrival.
From 31-90D: 80€ (TSA+Visa docs review 1E) // 90€ (TSA+ME Visa docs review)
- IMPORTANT: documents and payment are sent by the traveller to the Embassy. The Embassy will send back the passport to the applicant and the courier Fee is paid by him/her at the reception (it's not included in the Fee).

- Non-legalised criminal record in Spanish (adults only)
- MINORS: parental travel authorisation (National Police). No criminal record required.
- Signed Embassy form and proof of transfer.
- Fee: 40€ (1E)
- IMPORTANT: documents and payment are sent by the traveller to the Embassy. The Embassy will send back the passport to the applicant and the courier Fee is paid by him/her at the reception (it's not included in the Fee).

ZAMBIA:

- Return flight ticket
- Hotel reservation / Invitation letter (e-mail & phone + host ID)
- Cover letter addressed to the Director General of Immigration signed by the local Tour Operator
- Completed standard form and proof of bank transfer
- Fee: 70€ (1E - 90D) // 90€ (2E - 90D) // 110€ (ME - 90D)
- KAZA visa fee (Zambia+Zimbabwe+Botswana): 90€ (ME - 30D)

STEP 2: send documentation from the country you are visiting, including proof of payment.

Documentation must be sent SCANNED (mobile phone photos of documents will be rejected) to the Ugandan Consulate at visas@consuladouganda.org. Ghana & Cape Verd visas are issued by Embassies, so the documentation must be sent physically to the Embassy for processing.

We strongly advice to submit documentation 30 days prior departure to obtain any visa without stress.

IMPORTANT:

The Fee includes visa fee*, bank commission, image processing, application tracking and claim. *Exceptin Ghana and Cape Verd which are paid by the traveller directly.
