RESOLUTION NO. 12 OF 2022

RESOLUTION APPROPRIATING FUNDS FOR SATISFACTION OF THE DEPRECIATED PORTION OF CLAIMS PAID BY THE INSURANCE COMPANY FOR THE TOWN OF BENTON TO HOMEOWNERS IN PALMETTO PARK FOR REQUIRED REPAIRS RELATED TO A MARCH 22, 2022 SEWAGE BACKUP INCIDENT

WHEREAS, the insurance company, The Travelers Indemnity Company ("Travelers"), which provides commercial general liability on behalf of the Town of Benton, has processed and paid several insurance claims submitted to Travelers by homeowners in Palmetto Park Subdivision for required repairs related to a sewer backup incident that occurred March 22, 2022; and

WHEREAS, the claim payments by Travelers have included an amount of depreciation applied to the insurer's estimates of repair and replacement costs under the insurer's standard adjustment procedures during processing of the claims; and

WHEREAS, the Town of Benton, in order to fully satisfy the insurance claims submitted by Palmetto Park homeowners as processed, adjusted, and paid by Travelers, wishes under a finding of public necessity to fund for the benefit of the homeowners who have received payments from the insurer for their claims related to a March 22, 2022, sewage backup incident the amount of the depreciation applied in the insurer's estimates of repair and replacement costs as reflected in payments made to homeowners following processing of their claims; and

WHEREAS, the municipal funds for this purpose shall be appropriated from the enterprise fund maintained by the Town for sewer system operations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF BENTON, LOUISIANA:

- **Sec. 1.** A sum not exceeding \$ 40,000.00 hereby is appropriated from the sewer system enterprise fund of the Town of Benton for the purpose of satisfaction of the depreciated portion of claims paid by Travelers to homeowners in Palmetto Park related to a March 22, 2022, sewage backup incident, with this appropriation being based upon a finding of public necessity.
- **Sec. 2.** The amount of payment by the Town to each covered homeowner will be the amount of depreciation applied by Travelers to the insurer's estimate of repair and replacement costs under its standard adjustment procedures as reflected in the payment to the homeowner following processing of the homeowner's claim.
- **Sec. 3.** Travelers will provide to the Town the amount of depreciation applied to each claim as reflected in its payment of the claim, which depreciation amount shall be the full sum that shall be paid by the Town to the homeowner who submitted the claim as shown by Traveler's records.
- **Sec. 4.** This Resolution shall become effective upon final adoption and signature of the Mayor, and shall be implemented following receipt by the Town from Travelers of the required information in Sec. 3 of this Resolution

Said Resolution having been read and considered by a quorum of the Board of Aldermen, on motion to adopt by Alderman Jones, seconded by Alderman Carr, a record vote was taken and the following result was had:
