

RUNOFF OF THE ELECTION HELD ON THURSDAY, JANUARY 22, 2015

VOTING UNIT

EMPLOYEES ELIGIBLE TO VOTE:

Those eligible to vote are: All full-time, regular part-time, and casual drivers, and all full-time and regular part-time, operators, mechanics and cleaners employed by the Employer at its facility located at 4991 Factory Drive, Fairfield, Ohio 45014; who were employed by the Employer during the payroll period ending November 30, 2014.

EMPLOYEES NOT ELIGIBLE TO VOTE:

Those not eligible to vote are: All professional employees, office clerical employees, guards and supervisors as defined in the Act, any employees who have quit or been discharged since November 30, 2014 and are not rehired or reinstated prior to February 9, 2015.

DATE, TIME AND PLACE OF RUNOFF ELECTION

The election will be conducted by mail. The mail ballots will be mailed to employees employed in the appropriate collective-bargaining unit from the office of the National Labor Relations Board, Region 09, on Monday, February 9, 2015. Voters must return their mail ballots so that they will be received in the National Labor Relations Board, Region 09 office by close of business on Monday, February 23, 2015. The mail ballots will be counted at the Region 09 office located at 550 MAIN ST, RM 3003, CINCINNATI, OH 45202-3271 at 2:00 p.m. on Tuesday, February 24, 2015.
