Assessors Lyons she is all finished up and awaiting next tax season. Highway Superintendent Installed sluice pipes on Space Rd. Hauled gravel. Replaced a sluice pipe on Reservoir Hill Rd. Fixed a leaking tire. Replaced two hydraulic line on the excavator. Cleaned ditches on Space Road and Stapleton Road. Reservoir Hill Project completed. Graded Ackerson Rd, Rouse Rd, Lodge Rd, Miller Rd, Gaffney Rd, Reservoir Hill Rd. Met with numerous sales reps, including Short, Coots, Superior/Griffith Oil and Austin Construction. Talked to Dawn Sutfin NYSDOT for information to complete chips funding paperwork. Talked to Tim Leonard from Steuben Co preparing for chip seal. Supervisor Miller stated he and Councilperson Thompson rode up Reservoir Hill Rd and the ditches need to be re addressed and dug out a little bit more. Where the curve is that needs delineator needs to be installed. Jeff is also filling for \$106,000.00 forchips money and that needs to be in by the 24<sup>th</sup> of June. Jeff also spent \$86,000.00 and that comes out of the chips money. All trucking, labor, gravel is taken from the chips money. Woodhull, Addison Village, Troupsburg and Jasper helped with Reservoir Hill Rd Shared Service. Betty asked in the past shared services did not go past Woodhull. Shared service 20 days is owed to other Townships. This needs to be tracked because of expense purposes. Jeff will keep it as even as possible.Dave needs to be informed of all shared services.
