WHTA MEMBER CASH BACK PROGRAM APA / WHTA LEVEL 1 and 2 Online Courses



TERMS AND CONDITIONS

- 1. The WHTA Cash back program is a program for WHTA member undertaking APA Level 1 and / or Level 2 online Women's Health courses co-branded with WHTA Pty Ltd and APA.
- 2. The WHTA Cash Back program is offered exclusively by WHTA Pty Ltd for WHTA Member Physiotherapists, and has no commercial or legal association with the Australian Physiotherapy Association.
- 3. The WHTA Cash Back program commences on the 1st June 2020 and is approved indefinitely.
- 4. WHTA reserves the right to cancel the program at any time with one month's notice.
- 5. In the event that the WHTA Cash Back Program is cancelled, WHTA will honor all cashback applications for eligible APA online courses enrolled into prior to the date of cancellation, so long as the application is received by WHTA within 6months of the date stipulated on the APA invoice for payment.

ELIGIBILITY

- 6. To be eligible for this program the participant of the APA online course must be
 - 2.1 a registered physiotherapist or final year student physiotherapist AND
 - 2.2 have been a Member of WHTA prior to enrolment in the APA online course
- 7. To apply for a cash back rebate the claimant must send both their completed WHTA Cash Back Application Form and APA proof of payment (APA receipt/invoice) to admin@whta.com.au in the same financial year and no more than 6months after the date of payment to APA. The exception to this clause are APA online courses enrolled and paid for in June 2020. These courses are eligible to be claimed up until 30th June 2021.
- 8. WHTA will process a maximum of two WHTA applications forms in one financial year per member. After processing of two application forms no further applications will be processed until the following financial year.

CLAIMANT

- 9. The rebate will only be paid to the person or organisation who PAID for the course. Whereby the claimant is different to the Physiotherapist enrolled in the course, both the physiotherapist enrolled in the course and the claimant must sign the application form.
- 10. Claimants with Australian Bank accounts can choose to have a cash rebate paid directly into their nominated bank account or for their cash rebate to be held as Credit for future WHTA training programs.
- 11. Claimants who do not hold an Australian Bank account will have their cash rebate stored as a credit for WHTA future training programs.

RATE OF REBATE

- 12. All physiotherapists who were members of WHTA prior to enrolment in the APA online course are eligible for the base WHAT Member rebate.
- 13. Higher rebates are available for certain WHTA Members based on prior training with WHTA Pty Ltd.
 - 13.1. Physiotherapists who have completed the WHTA Introductory Women's Health 5 Day Course (either 5 days face-to-face or 1 day online plus 4 days face-to-face) are eligible to apply for the higher rebate for IWHC participants.
 - 13.2. Physiotherapists who have completed a WHTA Advanced Pelvic Floor Course <u>prior to 1st June 2020</u> are eligible to apply for a higher rebate on some courses under the "Previous attendee at an Advanced Pelvic Floor Course Category.
 - 13.3. Physiotherapists who are graduates of Australian Catholic University or who are 3rd of 4th year students of the undergraduate physiotherapy degree are eligible to apply for the higher rebate for ACU graduates
 - 13.4. Any new graduate physiotherapist registered for less than 2 years as a physiotherapist at the time of receipt of payment to the APA is eligible for the new graduate rebate.
