Advanced Education Institute EMDR Therapy Training

This is the complete EMDR Basic Therapy Training approved by EMDRIA, formerly known as Level I and Level II. Participants will learn the EMDR psychotherapy approach, the basic eight-phase EMDR protocol, the Adaptive Information Processing Model, and how to incorporate EMDR into your practice. This course will consist of didactic presentations, demonstrations, supervised practicum, and case consultations. Participants must attend the full training and five 2-hour consultation groups to receive a certificate of completion in EMDR Basic Therapy Training. Approval of partial programs will not be granted.

Required Reading: Eye Movement Desensitization and Reprocessing: Basic principles, protocols, and procedures, third edition, by Francine Shapiro, PhD, EMDR Therapy originator.

Qualifications for Attendance: A clinical background is essential for the effective application of EMDR. Attendance at the workshop is limited to mental health professionals who, at a minimum, are enrolled in the practicum phase of a Master's degree or Doctoral degree. This course is appropriate for licensed and pre-licensed mental health professionals including Psychologists, Marriage and Family Therapists, Clinical Social Workers, and Professional Clinical Counselors.

Training Information: This is a two-part training consisting of 3 days each, 6 days total. **Check the website for training location & schedule.**

After you have registered and submitted payment, you will receive a pre-training email containing the address and directions to the training location if it is not specified on the website.

Trainings start promptly at 8:30 am, coffee and morning refreshments served at 8:00 am each day.

Consultation: Consultation with EMDR 808 Pacific is included in the cost of the training. Each attendee must attend 10-hours of group consultations in addition, to the 6 training sessions. You will be provided the consultation schedule assigned to your training group. You should make every effort to attend the assigned dates. If in the event of an emergency you cannot attend the consultation you are scheduled in, you may email Tarena at emdr808@gmail.com and let her know. Tarena will send out Zoom links the day before the consultation.

Training Location: Please refer to the website for training location and please *specify on your registration form the location and dates you will be attending.*

Cost: \$1550.00 (\$100 discount for pre-licensed individuals and non-profit). Payment is required to reserve your seat.
