- c. Town Clerk, Town Justice, DCO and Bookkeepers reports were read as submitted. Town Clerk noted that there are 18 expired dog licenses as of the end of June 2022. Bookkeeper reported the following collections: Justice \$338.00, Town Clerk \$406.88, ARPA funds \$42,051.15, and 2nd Quarter Sales Tax \$36,810.12. Bookkeeper stated that the Highway Superintendent is still not identifying which hours worked were related to CHIPS. Board voted and approved motion to require Highway Superintendent to make notations on Time Sheets during the last board meeting.
