This small book is a quest to enlighten our understanding about Gog and about the Release of Lucifer from the Abyss (the bottomless pit).

Traditionally, we know that Satan will be released after being imprisoned in the Abyss for a thousand years.

We know that Satan was imprisoned at the time of Yeshua Jesus Messiah First Coming in about AD 28, (See studies about this subject on www.David4Messiah.com).

- ◆ The first question then is when was or will Satan be released.
- ◆ Next, the second question after that is when Gog and Magog will declare the war against the camp of the believers in Israel. This is called the Alliance and War of Armageddon.

I always assumed that Satan was not released except recently as we see the openness of globalization and determination to murder millions (or billions) of people through plandemics, false global vaccination, economic manipulated disasters, geo-environmental destruction of the stratosphere, and famines.

However, I thank Steven Ben Nun for applying Ezekiel 38 correctly.

Based on this Bible study, we may be surprised to know that Satan was released in the beginning of the twentieth century, i.e., about AD 1900 and that Gog and Magog are already in the Land of Israel waging war against the camp of the believers, i.e., the Messianic believers and the truly born-again Christians.

To begin: What is the true Identity of Gog and Magog?

- ◆ Ezekiel 38 speaks of the Prince of Rosh is “Prince of the Head”. This was misinterpreted as Prince of Russia.

◆ Russia is pronounced in English as (Rasha) and this is a main reason why we misunderstand this prophecy. Russia in Russian language is pronounced as (Roussia) and in French it is pronounced as (Rûssie)

Therefore, the Prince of Rosh is not the prince of Russia.
The word Rosh means "Head".

◆ Literal translation of Ezekiel 38:1-2

"And the Word of YHWH was addressed to me saying:

Son of Adam, set your face towards (against) - Gog Land of the Magog - the prince, the head of Mesheck and Tubal, and prophesy on (about - against) him."

◆ Notice:

Gog is not the prince of Rosh, but rather he is the 'prince' of the head.

The word Rosh in Hebrew means head and the intonation marks indicate that the head is of Mesheck and Tubal.

The identity of Gog is "a Prince."

Gog is prince of the head.

◆ Literal translation of Ezekiel 38:3-4

"And you shall say 'thus says the Lord YHWH,' here I am against you Gog the prince, the head of Mesheck and Tubal.

And I (YHWH) shall return you back and I shall give (put - place) hooks in your jaws.

And I shall make you come out (bring forth) you and all your powers (armies), horses and horsemen who are dressed in fine clothes (uniforms) most gorgeously, your large congregation (company), with bucklers and shields who are experts in war (handling the sword).

◆ Notice:

Gog is an evil prince, the great serpent. If the Kabbalists, rabbis, and global

Zionists are Gog, then the word "I shall return you back" means that these Jewish rabbis (Pharisees, Sadducees, and Scribes) will come back to the Land of Israel from whence they were banished during the times of emperors Vespasian, Titus, Hadrian and Diocletian and the Roman Church which is the Holy Roman Empire.

◆ Notice:

I will give you hooks in your jaws. This refers to the great serpent, Lucifer who is called also Leviathan.

◆ Job 41:1-2; 27; 33-34

1-2 "Can you draw out Leviathan with a hook, or snare his tongue with a line which you lower? Can you put a reed through his nose, Or pierce his jaw with a hook? ...

(The reference here is to Lucifer and not only to a great majestic dinosaur.)

27 He regards iron as straw, And bronze as rotten wood. (The word bronze is the same word as a serpent due to the color.)

33-34 On earth there is nothing like him, which is made without fear. He beholds every high thing; he is king over all the children of pride." (Satan is the ruler over his children, those who reject the Messiah Yeshua Jesus YHWH.)

◆ Revelation 13:6

"If any man has an ear, let him hear."

(This word is addressed to those who are truly born again, i.e., alive having an ear.)

◆ Revelation 13:7

"He that leads to captivity, shall go into captivity: he that kills with the sword, must be killed with the sword. Here is the patience and the faith of the saints (the true believers).

(Satan led people to captivity, but Yeshua Jesus liberated those who

believed on Him. Satan will be captive and will suffer the consequences of his corruptions of mankind.)

♦ The Beast is Lucifer (Satan)

♦ Isaiah makes a reference to this beast (Gog - Leviathan - Lucifer - the Serpent of Old)

Isaiah 27:1 "In that day the LORD YHWH with His severe sword, great and strong, Will punish Leviathan the fleeing serpent, Leviathan that twisted serpent; and He will slay the reptile that is in the sea."

Revelation 13:1-18

1 Then I stood on the sand of the sea. And I saw a beast rising up out of the sea, having seven heads and ten horns, and on his horns ten crowns, and on his heads a blasphemous name.

2 Now the beast which I saw was like a leopard, his feet were like the feet of a bear, and his mouth like the mouth of a lion. The dragon gave him his power, his throne, and great authority.

3 And I saw one of his heads as if it had been mortally wounded, and his deadly wound was healed. And all the world marveled and followed the beast.

4 So they worshiped the dragon who gave authority to the beast; and they worshiped the beast, saying, "Who is like the beast? Who is able to make war with him?"

5 And he was given a mouth speaking great things and blasphemies, and he was given authority to continue for forty-two months.

6 Then he opened his mouth in blasphemy against God, to blaspheme His name, His tabernacle, and those who dwell in heaven.

7 It was granted to him to make war with the saints and to overcome them. And authority was given him over every tribe, tongue, and nation.

8 All who dwell on the earth will worship him, whose names have not been written in the Book of Life of the Lamb slain from the foundation of the world.

9 If anyone has an ear, let him hear.

10 He who leads into captivity shall go into captivity; he who kills with the sword must be killed with the sword. Here is the patience and the faith of the saints.

11 Then I saw another beast coming up out of the earth, and he had two horns like a lamb and spoke like a dragon.

12 And he exercises all the authority of the first beast in his presence, and causes the earth and those who dwell in it to worship the first beast, whose deadly wound was healed.

13 He performs great signs, so that he even makes fire come down from heaven on the earth in the sight of men.

14 And he deceives those who dwell on the earth by those signs which he was granted to do in the sight of the beast, telling those who dwell on the earth to make an image to the beast who was wounded by the sword and lived.

15 He was granted power to give breath to the image of the beast, that the image of the beast should both speak and cause as many as would not worship the image of the beast to be killed.

16 He causes all, both small and great, rich and poor, free and slave, to receive a mark on their right hand or on their foreheads,

17 and that no one may buy or sell except one who has the mark or the name of the beast, or the number of his name.

18 Here is wisdom. Let him who has understanding calculate the number of the beast, for it is the number of a man: His number is 666.

Notice:

The deadly wound to the beast's head was healed.

In Ezekiel 38 we read that:

Gog is the prince of the head.

Gog will have hooks in his jaws.

Gog will return back to the land whence he was banished.

God said to the serpent (Satan) in Genesis 3:15

"And I (YHWH) will put enmity between you and the woman, and

between your seed and her Seed; He shall bruise your head, and you shall bruise His heel."

◆ The serpent had received a deadly wound in its head and was / will be healed before the end times.

◆ The deadly wound was administered by the Messiah Jesus, based on the prophecy God pronounced in Paradise: "He shall bruise your head."
I used to believe that Napoleon administered the deadly wound of the head to the Roman Catholic Church, but the prophecy in Genesis indicates that the Messiah is the one who will cause the deadly head wound of Lucifer.

Napoleon was not a believer, therefore his action against the Pope and the Catholic Church is not bruising the head of the serpent. Let us remember that Napoleon attempted to change the times by changing the week to ten days to cancel out any remembrance of the Sabbath and also he introduced an attractive women, named Marianne, and declared her to be the goddess of France. Napoleon was a tool in the hands of the Jesuits and Free Masons.

◆ As Yeshua Jesus Messiah completed His Messianic role and offered Himself as the Lamb of God on the Cross. This deadly head wound of Satan can be demonstrated in two ways:

(1) Satan (Lucifer) fell from the heavens and was bound in the abyss at the time of Christ First Coming, AD 28. Jesus testified that He saw Satan falling like lightening.

(2) The Jews were killed and scattered out from the Land of Israel for about 2000 years.

◆ Was Satan released early in the 1900?

We do not know the exact date, but as it appears and based on educated guess, Satan was released early in the twentieth century. This is based on

the intensified demonic worship, rituals, councils, dark cults, secret societies, witchcraft rituals, infiltration of governments, and also their flagrant arrogant openness. Also, Satan inspired, empowered and supported World Wars I and II as well as genocides of million Christian Armenians and million Orthodox Christian Serbs and millions of opposing people disappear in China. Added to all this, the coordinated child kidnaping and trafficking to use them as sex objects, generate adrenochrome from their blood, offer some of them as sacrifices to demonic idols and even use their flesh for food. Kidnaping and trafficking, of millions of children (eight millions in the world yearly including one million in America yearly) has become a regular (normal) phenomenon.

Before AD 1900, the evil rulers were motivated to kill and pillage people for money and power. There were magical and witchcraft practice.

After AD 1900, the evil powers intensified their murders and rituals. Now, many politicians, religious leaders, and rulers in the world are members of the Free Masons, the Jesuits, the Global Zionists, the Kabbalists, the Rosicrucian, Church of Satan, and different types of Witchcraft.

♦ And, in 1948 (the Global Zionists - the Pharisees) returned back to their Land of Israel.

Many commentators believe that the return back to the Land of Israel is a fulfillment of the prophecies mentioned in Jeremiah, Isaiah and Joel. But, let us remember that Peter the Apostle, on the Day of Pentecost at the Upper Room of the Temple, declared that this Day of Pentecost was a Day of salvation as the Apostle spoke to all the Tribes of Israel in their languages. All the twelve Tribes had already returned and they were in Jerusalem as attested by the multiplicity of languages.

♦ Let us look into the prophecies of the Return of the Tribes of Israel:

Jeremiah 30:1-3 "The word that came to Jeremiah from the LORD YHWH,

saying: "Thus speaks the LORD YHWH God of Israel, saying: 'Write in a book for yourself all the words that I have spoken to you. For behold, the days are coming,' says the LORD YHWH, 'that I will bring back from captivity My people Israel and Judah,' says the LORD YHWH. 'And I will cause them to return to the land that I gave to their fathers, and they shall possess it.'"

Jeremiah 33:11 "The voice of joy and the voice of gladness, the voice of the bridegroom and the voice of the bride, the voice of those who will say: "Praise the LORD YHWH of hosts, For the LORD YHWH is good, For His mercy endures forever"-- and of those who will bring the sacrifice of praise into the house of the LORD. For I will cause the captives of the land to return as at the first,' says the LORD YHWH."

Isaiah 44:1-4 "Yet hear now, O Jacob My servant, and Israel whom I have chosen. Thus says the LORD YHWH who made you and formed you from the womb, who will help you: 'Fear not, O Jacob My servant; and you, Jeshurun, whom I have chosen. For I will pour water on him who is thirsty, and floods on the dry ground; I will pour My Spirit on your descendants, and My blessing on your offspring; they will spring up among the grass like willows by the watercourses."

Joel 2:28-29 "And it shall come to pass afterward that I will pour out My Spirit on all flesh; your sons and your daughters shall prophesy, your old men shall dream dreams, your young men shall see visions. And also on My menservants and on My maidservants I will pour out My Spirit in those days."

◆ Notice:

"All flesh" does not mean every human being on earth, but every Hebrew. YHWH is speaking to the Jews saying "your sons and your daughters ... your old men and your young men ..." At that day, Israel had returned back to its land. All the twelve Tribes were living in Israel, although some preferred to live in the Diaspora for financial gains or because of inter-

cultural marriages.

Acts 2:4-21 "And they (the eleven Apostles) were all filled with the Holy Spirit and began to speak with other tongues, as the Spirit gave them utterance. And there were dwelling in Jerusalem Jews, devout men, from every nation under heaven.

(The expressions "Jews of every nation under heaven" indicates that the Return of the Jews was fulfilled at the time of Yeshua Jesus. They were already in the land of Israel. There were no lost Tribes).

"And when this sound occurred, the multitude (the Jews of every nation) came together, and were confused, because everyone heard them speak in his own language. Then they were all amazed and marveled, saying to one another, "Look, are not all these who speak Galileans? (The Disciples spoke Aramaean and Hebrew.) And how is it that we hear, each in our own language in which we were born? (A) Parthians and (B) Medes and (C) Elamites, (D) those dwelling in Mesopotamia, (E) Judea and (F) Cappadocia, (G) Pontus and (H) Asia, (I) Phrygia and (J) Pamphylia, (K) Egypt and (L) the parts of Libya adjoining Cyrene, visitors from (M) Rome, both Jews and proselytes, (N) Cretans and (O) Arabs (Nabateans) – we hear them speaking in our own tongues the wonderful works of God." (They spoke sixteen languages directly by the Holy Spirit YHWH.) So they were all amazed and perplexed, saying to one another, "Whatever could this mean?"

Others mocking said, "They are full of new wine." But Peter, standing up with the eleven, raised his voice and said to them, "Men of Judea and all who dwell in Jerusalem, let this be known to you, and heed my words. For these are not drunk, as you suppose, since it is only the third hour of the day.

But this is what was spoken by the prophet Joel: "And it shall come to pass in the last days, says God, that I will pour out of My Spirit on all flesh; your sons and your daughters shall prophesy, Your young men shall see visions, your old men shall dream dreams. And on My menservants and on My maidservants I will pour out My Spirit in those days; and they shall prophesy. I will show wonders in heaven above and signs in the earth

beneath: Blood and fire and vapor of smoke. The sun shall be turned into darkness, And the moon into blood, Before the coming of the great and awesome day of the LORD YHWH. And it shall come to pass That whoever calls on the name of the LORD YHWH Shall be saved."

◆ The second chapter of the book of Joel speaks of the Messiah First coming while the third chapter of the book of Joel speaks of the Messiah Second coming.

Therefore, in conclusion of these prophecies which speak of the return of the Jews (all the twelve Tribes) did occur and the Day of Pentecost was the evidence.

Thus, the return of the Global Zionists, Kabalists and Jews who hate YHWH and the Messiah is the "return of Gog."

◆ God called Gog the prince of The Head.

The Head is the head of The Serpent.

The Serpent is Lucifer.

◆ Christ's heel was wounded on the Cross.

Satan's head was wounded at the Cross.

◆ Jesus identifies for us the identity of this beast:

Jesus explains to us that the Jewish religion which is based on the teaching and customs of the rabbis (the Talmud and the Midrash) is satanic and antagonistic to the Law of Moses. The rabbis admit that when they have a difference in opinion between their teaching and customs and between the written Word of Moses, then their opinion is valid and God's opinion does not apply. Christians use the same logic to justify changing the laws of the Scriptures.

Matthew 23:29-39 "Woe to you, scribes and Pharisees, hypocrites! Because you build the tombs of the prophets and adorn the monuments of the righteous, and say, 'If we had lived in the days of our fathers, we would not have been partakers with them in the blood of the prophets.' Therefore you are witnesses against yourselves that you are sons of those who murdered the prophets. Fill up, then, the measure of your fathers' guilt. Serpents, brood of vipers! How can you escape the condemnation of hell? Therefore, indeed, I send you prophets, wise men, and scribes: some of them you will kill and crucify, and some of them you will scourge in your synagogues and persecute from city to city, that on you may come all the righteous blood shed on the earth, from the blood of righteous Abel to the blood of Zechariah, son of Berechiah, whom you murdered between the temple and the altar.

Assuredly, I say to you, all these things will come upon this generation."O Jerusalem, Jerusalem, the one who kills the prophets and stones those who are sent to her! How often I wanted to gather your children together, as a hen gathers her chicks under her wings, but you were not willing! See! Your house is left to you desolate; for I say to you, you shall see Me no more till you say, 'Blessed is He who comes in the name of the LORD!' (Barukh Habo' Bshem YHWH, Yashua Hamashiah Goël Ysrael.)"

◆ Notice:

Jesus called the Pharisees and Scribes as the children (brood) of the Serpent, i.e., Lucifer.

The Essenes were pious Jews who were abhorred with the Sadducees practices. The Sadducees represented the priests of the nations (similar to the pastors, bishops, priests, missionaries and Christian workers who claim to be carrying the Word of God falsely). The essenes were pious faithful Jews to the Torah of YHWH written by Moses, then they added a few more things to govern their new isolated society.

The corruption in the Jewish ruling teachers (Rabbis, Pharisees and Scribes), and priests (Sadducees) was overwhelming.

Yeshua Jesus the Messiah exposed them and called them children of the

devil.

The Essenes had major agreement with Yehsua Jesus.

Today, the Qaraite Jews reject the rabbis, but at the same time reject the Messiah Yeshua Jesus.

◆ Now we can link the Talmudic Pharisees (rabbis) and Scribes to Gog who after being banished from Jerusalem and the region around Jerusalem by the Romans, they came back in 1948 as the Ashkanzim who are the Khazarian children of Meshekh and Tubal to rule over Jerusalem.

1 Chronicles 1:5-7 "The sons of Japheth were Gomer, Magog, Madai, Javan, Tubal, Meshech, and Tiras. The sons of Gomer were Ashkenaz, Diphath (Riphath in Genesis 10:3), and Togarmah. The sons of Javan were Elishah, Tarshishah, Kittim, and Rodanim (Dodanim in Genesis 10:4).

Genesis 10:2-4 "The sons of Japheth were Gomer, Magog, Madai, Javan, Tubal, Meshech, and Tiras. The sons of Gomer were Ashkenaz, Riphath, and Togarmah. The sons of Javan were Elishah, Tarshish, Kittim, and Dodanim."

From this Genealogy and from the fact that the majority of the returned Jews in 1948 were Ashkinazim, we can deduce easily that Gog the Prince who is the head of Meshekh and Tubal is the Global Zionists Ashkinazim Jews.

This does not mean that all Jews are to be identified as Gog because most of the Jews are not aware of the tyrant global agenda of the few rules, the free Masons and the Global Zionists.

◆ The Ashknazim goal is not to glorify YHWH but to prevent the Messianic believers from believing in YHWH Yeshua Jesus the Savior.

Six million Jews, mostly Ashknazim, are living in Israel with less than 50,000 Messianic Jewish or Hebrew believers.

Messianic Jews who openly confess the Messiah Jesus as their Lord are not accepted in Israel and are not allowed to have the Israeli citizenship easily or at all. Some of these believers, after making Alyah and receiving the Israeli citizenship, they are stripped away of it by the Knesset.

While any person who claims to have a Jewish relative and who does not believe in Yeshua Jesus is encouraged to do Allyah and he/she receives the Israeli citizenship immediately and permanently.

This is the Knesset Zionist Law. This return to Israel is the return of the oppressive Pharisees, Scribes and Sadducees whom Jesus called children of Satan. But, let us understand that it is only a minority of leaders who are fulfilling the will of their father, Satan. Most of the population have no idea what is going on. People enjoy entertainment and are being hypnotized with simple things.

◆ The majority of the Ashknazim are good Jews who are mislead by their leaders.

The Global Zionists and the Kabbalists' goal is to rule the world and to destroy the faith of the Savior, the Messiah Jesus who is the very person of YHWH.

All the political leaders of Israel are of Khazarian origin except Netanyahu who is not Khazarian but also he is not Hebrew, and most of the religious leaders (rabbis) are of Khazarian origin.

◆ The Ashkinazim came from Khazaria. They are not of Hebrew origin, but throughout the last ten centuries, they may have intermarried with Hebrew Jews. Therefore, they are Jews by faith and maybe by blood.

◆ The Global Zionists took advantage of the Bible and used it to claim a Millennium rule of the earth. But the Millennium applies to Jesus Christ whose kingdom is for ever and ever, not to them.

◆ Let us examine the current Jews to see if they are believers or not ◆

◆ The sins of Genesis 6 were repeated again at the time of Ezra. The sins of Genesis 6 when the believers (sons of God) were mingling (intermarriage) with non-believers women, daughters of men (the Cainites). This mingling led to falling away from the faith of YHWH as one God and believing in demonic religions brought by the women and in humanism.

The daughters of men believed in Semiramis as their goddess who married her son Nino (Nimrod) and who claimed that after his death he resurrected again in the form of Tammuz.

They believe that Cain was god and son of Satan from Eve.

They had many bizarre demonic and humanistic religions.

As Eve dominated her husband Adam and caused him to sin and fall (Nefel), so also the women of men (Cain) caused the believers (sons of God) to sin and fall (Nefilim) away from YHWH.

Ezra 9:1-4 "When these things were done, the leaders came to me, saying, "The people of Israel and the priests and the Levites have not separated themselves from the peoples of the lands, with respect to the abominations of the Canaanites, the Hittites, the Perizzites, the Jebusites, the Ammonites, the Moabites, the Egyptians, and the Amorites. For they have taken some of their daughters as wives for themselves and their sons, so that the holy seed is mixed with the peoples of those lands. Indeed, the hand of the leaders and rulers has been foremost in this trespass." So when I heard this thing, I tore my garment and my robe, and plucked out some of the hair of my head and beard, and sat down astonished. Then everyone who trembled at the words of the God of Israel assembled to me, because of the transgression of those who had been carried away captive, and I sat astonished until the evening sacrifice."

Gigantism

The giants gene is normal in humanity, but it is recessive. At that time, the giants married each other and their offspring continued to be giants. When the pineal gland at the base of the brain does not give the order to stop cartilage formation, then the person continues to grow and become a huge giant.

What stops our growth to our normal height is the pineal gland ordering the calcification of the cartilages at the end of our bones. This makes the bones stop their unlimited growth.

I do not know the biological factors that promoted giant growth. But, in time, as these giants of old married normal size men and women, then the recessive gene of giant growth disappeared or became an "intron epigene."

Every now and then, a child grows as a giant due to the pineal gland loss of control.

◆ Possible Date and Connection of the Release of Satan and Gog ◆

Revelation 20:1-10

- 1 Then I saw an angel coming down from heaven, having the key to the bottomless pit and a great chain in his hand.
- 2 He laid hold of the dragon, that serpent of old, who is the Devil and Satan, and bound him for a thousand years;
- 3 and he cast him into the bottomless pit, and shut him up, and set a seal on him, so that he should deceive the nations no more till the thousand years were finished. But after these things he must be released for a little while.
- 4 And I saw thrones, and they sat on them, and judgment was committed to them. Then I saw the souls of those who had been beheaded for their

witness to Jesus and for the word of God, who had not worshiped the beast or his image, and had not received his mark on their foreheads or on their hands. And they lived and reigned with Christ for a thousand years.

5 But the rest of the dead did not live again until the thousand years were finished. This is the first resurrection.

6 Blessed and holy is he who has part in the first resurrection. Over such the second death has no power, but they shall be priests of God and of Christ, and shall reign with Him a thousand years.

7 Now when the thousand years have expired, Satan will be released from his prison

8 and will go out to deceive the nations which are in the four corners of the earth, Gog and Magog, to gather them together to battle, whose number is as the sand of the sea.

9 They went up on the breadth of the earth and surrounded the camp of the saints and the beloved city. And fire came down from God out of heaven and devoured them.

10 The devil, who deceived them, was cast into the lake of fire and brimstone where the beast and the false prophet are. And they will be tormented day and night forever and ever.

◆ Notice:

These ten verses connect the release of Satan from the bottomless pit (Abyss) to the beginning of Gog the prince which means the capture of Israel and Jerusalem by Gog.

Gog is the Ashkinazim Jews who came originally from the North (Khazaria) and who rejected YHWH the Messiah Jesus.

(See the map of Khazaria at the end of this study.)

The Balfour Declaration was a public statement issued by the British government in 9 November 1917 during the First World War announcing support for the establishment of a “national home for the Jewish people.”

About that time, Free Masonry, the Illuminati, the Kabbalism, the Spiritists, the Luciferians, and the Jesuits began to have global dark powers activated especially in the highest ruling and rich leaders.

Is it possible that the release of Satan occurred in the beginning of the twentieth century, i.e., around the year 1914, or the year 1948?

This is a possibility.

◆ Are the rulers in Israel part of Gog? Israel is collaborating with China in the Global control by vaccination. 75% of Israeli have been vaccinated. Israel is dominating by collaborating with many countries on a technological, political and financial levels. Israel is in control of many rulers and politicians of Western countries.

◆ Satan is using China and Israel and every liberal leader who cares only about their powers and moneys.

◆ Add to this another factor: The originators of the New Jewish State were all Zionists and they declared that Israel must rule the world.

◆ The Church had fallen into the same false doctrine since the middle centuries: it claims that a thousand years will be the Millennium, wherein Israel will regain its status of power and it will be the age of Israel (along with the Church). But, the rabbis say that the Christians must be made subservient to the Jews.

This doctrine pretends that every Jew will believe on Christ as Savior. But, when God said: "All Israel shall be saved," God meant all called (elect - chosen - ekklyssia) Israel shall be saved. Those who do not believe on Christ are not Israel.

God said: "Not all Israel is Israel."

Romans 9:6 "But it is not that the word of God has taken no effect. For they are not all Israel who are of Israel."

Romans 11:25-36 "For I do not desire, brethren, that you should be ignorant of this mystery, lest you should be wise in your own opinion, that blindness in part has happened to Israel until the fullness of the Gentiles has come in. And so all Israel will be saved, as it is written: "The Deliverer will come out of Zion, And He will turn away ungodliness from Jacob; For this is My covenant with them, When I take away their sins." Concerning the gospel they are enemies for your sake, but concerning the election they are beloved for the sake of the fathers. For the gifts and the calling of God are irrevocable."

♦ The Term Millennium is not one thousand but many thousands:

Revelation 20:4-5 "And I saw thrones, and they sat on them, and judgment was committed to them. Then I saw the souls of those who had been beheaded for their witness to Jesus and for the word of God, who had not worshiped the beast or his image, and had not received his mark on their foreheads or on their hands. And they lived and reigned with Christ for a thousand years (the thousands years). But the rest of the dead did not live again until the thousand years were finished. This is the first resurrection."

The word 'thousand' used here is not one thousand but thousands. It refers to eternity or uncountable number.

♦ Notice:

Revelation 20:9 "They went up on the breadth of the earth and surrounded the camp of the saints and the beloved city. And fire came down from God out of heaven and devoured them."

Revelation 20:7-9 "Now when the thousand years have expired, Satan will be released from his prison and will go out to deceive the nations which are in the four corners of the earth, Gog and Magog, to gather them together to battle, whose number is as the sand of the sea. They went up on the breadth of the earth and surrounded **the camp of the saints**

and the beloved city. And fire came down from God out of heaven and devoured them.”

◆ The Company or Congregation or Ekklyssia of the Saints is Evidence ◆

◆ The expression “The Camp of the Saints” is a key to understand that those who are returned back and who are surrounding the “camp of the saints,” the Messianic believers and the true born-again Christians are not all the Jews. The Messianic believers and the some of the Christians are the true saints when they are truly born again by faith in Christ the Messiah.

The Jews (Israelites) reject Yeshua Jesus the Messiah. Therefore, they are not the “camp of the saints.”

The false interpretation which is adopted by almost all evangelicals and all Churches is that the nations (Atheists, Christians and Muslims) will attack the Jews.

Maybe the truth is the exact opposite of what we are programmed to believe. The Jews are not saints since they rejected their Savior the Messiah Yeshua Jesus, therefore these verses in Revelation 20 is not talking about an attack against the Jews, but rather an attack against the true believers in Christ, in Jerusalem, in Israel and all over the world.

◆ Maybe this is a prophecy saying that the Ashkinazim Jews in their global government, allied with other nations, will persecute the Messianic believers and the true born-again Christians who believe on Yeshua Jesus.

Conclusion:

The return of the global Zionist Jews to the land of Israel is Gog the prince of the head of Satan returned according to Ezekiel 38.

The Zionists will persecute the camp of the saints: the true believers, the Messianic believers and the faithful Christians in Israel and in the world.

Thus the alliance and war of Armageddon will be primarily the Ashkinazim Global Zionists warring against the believers in collaboration with many nations empowered by the Free Masons, the Illuminati, the Bilderberg Council, the Chinese CCP.

While we do not know the identity of the Antichrist who will lead a fierce persecution against the “camp of the saints” the Ekklyssia (the Messianic Hebrews and true born-again Christian), yet we know that he has to be a Jew based on:

Daniel 11:36-40 “Then the king shall do according to his own will: he shall exalt and magnify himself above every god, shall speak blasphemies against the God of gods, and shall prosper till the wrath has been accomplished; for what has been determined shall be done. He shall regard neither the God of his fathers nor the desire of women, nor regard any god; for he shall exalt himself above them all. But in their place he shall honor a god of fortresses; and a god which his fathers did not know he shall honor with gold and silver, with precious stones and pleasant things. Thus he shall act against the strongest fortresses with a foreign god, which he shall acknowledge, and advance its glory; and he shall cause them to rule over many, and divide the land for gain.” At the time of the end the king of the South shall attack him; and the king of the North shall come against him like a whirlwind, with chariots, horsemen, and with many ships; and he shall enter the countries, overwhelm them, and pass through.

The key expression, in verse 37, which declared that the Antichrist will be a

Jew is: "He shall regard neither the God of his fathers ..." Therefore, the Rothchilds, the Rockefellers, the new Jewish Messiah qualify. Remember, Hitler was a Rothchild. Obama, the fake royalty in England, and Angela Merkel are related to Hitler thus the Rothchild.

His persecution of the faithful believers (the camp of the saints) will last 3 ½ years, at the end of which the Alliance of Armageddon and the war will begin.

This Antichrist will seduce, manipulate and control the whole world and many countries and peoples will join him especially in the beginning.

Above all, this Antichrist will be empowered by Satan the Dragon.

The Ashkinazim Jews

- The focus of the research in this chapter is limited to the Ashkinazim Jews because their glorious history illustrates God's work among His people.

- The Jews refer to themselves according to their ethnic and cultural origin, as:

(1) Ashkinazim are mainly from Germany. Their bloodline origin is from Khazaria. They are also in Northern France, Northern Europe, Russia, and Khazar. Their genotype indicates that many women from these countries married into them. Ashkinazim have a tiny fraction 1.7% of East Asian ancestry. Many Ashkinazim Jews reject the history of their Khazarian ancestors. But historical research is clearly decisive proving it.

(2) Southern European Ashkinazim have maternal lines to Roman and Greek women.

(3) Sepharadim are mainly from Spain. They are of Jewish blood from their ancestors. They are also in Iberia, Portugal, Morocco, North Africa, and Southern Europe. For example, the Macedonian Diaspora of the first century is usually classified as Spharade or as Romaniotes.

(4) Sepharadim Georgian Jews (Gruzinim) are a mix of Georgians and Israelites.

(5) Sepharadim Moroccan, Algerian, and Tunisian Jews are mainly Israelites.

(6) Sepharadim Libyan Jews are Israelites mixed with Berbers.

(7) Mizrahim are of Israeli blood. They are mainly the Easterner. Mizrah means East. They are from North Africa and the Middle East. Iranian, Iraqi, Sudanese, Egyptians, Libyan, Tunisian, Moroccan, Lebanese, Kurd, Syrian,

- (8) Kurdish Jewish paternal line is Israelite.
- (9) Juhurim Mountain Jews are mainly from Caucasus
- (10) Georgian and Mountain are mainly from Caucasus.
- (11) Romaniotes are mainly from Greece.
- (12) Temanim are mainly from Yemen. Dr. Dillard, professor at Westminster Theological Seminary, mentioned that they have the purest Israeli blood because of their isolation. Genetic studies showed some mixed blood with Ethiopians. They are closely related to Saudi Arabs and Bedouins mixed with small portion of East African. (In contrast, the Yemenite Muslims have West African genes).
- (13) Beta Jews are mainly from Ethiopia. Nubia in ancient times was called Nubia.
- (14) African Jews are from different parts in Africa.
- (15) Bukharan Jews are from Central Asia.
- (16) Kaifeng Jews are from China.
- (17) Chinese Jews are from different parts in China.
- (18) Indian Jews include Bene Israel, Bnei Menashe, Cochin Jews, and Bene Ephraim.
- (19) Mizo Jews of Northeastern India, the self-styled "Bnei Menashe", have no proven genetic connection to the Israelites.
- (20) Italkim Italian Jews are northern Mediterraneans and Israelites.
- (21) Dutch Jews descend from northwestern Europeans.
- (22) Palestinian Arabs are partly Israelite, according to their genotype.
- (23) Samaritans are descended from Israelite men and Assyrian women.
- (24) Lembas Jews possess the Cohen Modal Haplotype and have partial Middle Eastern ancestry. But it is distinct from the Jewish variety of this haplotype.
- (25) Buba clan of the Lembas Jews have Middle Eastern Israeli paternal DNA.
- (26) Many Spanish-speaking Latinos of the American Southwest are descended from Anusim who are the Marranos. The Marranos were Spanish Jews who were forced to convert to Catholicism.
- (27) Afghan Jews genotype matches Crimean Qaraite, Ashkenazim Jews, Sephardim Jews, and Kurdish Jews paternally.

(28) Egyptian Karaites some having genotype that matches Ashkinazim Jews.

(29) Azerbaijani Karaites sometimes genotype matches Ashkinazim Jews.

Genealogy of the Ashkinazim Jews

- In order to trace the race of the Ashkinazim we need to begin with the Scriptures:

These are the sons of Noah: (1) Sam (Shem). (2) Ham. (3) Japheth. (Genesis 10:1).

These are the sons of Japheth are: (1) Gomer. (2) Magog. (3) Madai. (4) Javan. (5) Tubal. (6) Meshech. (7) Tiras. (Genesis 10:2).

These are the sons of Gomer are: (1) Ashkinaz. (2) Riphath. (3) Togarmah. (Genesis 10:3; 1 Chronicle 1:6).

These are the sons of Javan: (1) Elishah. (2) Tarshish. (3) Kittim. (4) Dodanim. (Genesis 10:4).

- King Joseph, the Khagan of Khazaria, said that he traced his genealogy to Togarma ben Japheth ben Noah. Togarma is the ancestor of all Turkish tribes including the Khazar. Koestler points out that the Khazars are the people of Magog. Magog, according to Genesis 10:2-3 was the much maligned uncle of Togarma." Two other sons of Japheth, are progenitor of the Khazars: Meshech and Tubal, both of whom are central figures in biblical prophecies of the end times.

- Based on Genesis 10:1-4, and the testimony of Khazarian Khagan Joseph, we conclude that Togarmah's children intermarried with Ashkinaz's children, hence, the Khazarian Jews are duly called Ashkinazim.

- Hugo Freiherr said that "According to the explanation by the Talmud. Ashkinaz thus means a country near the Black Sea between Ararat and the Caucasus, within the original region of the Khazar Empire."

- The conversion of the Khazarians into Ashkinazim Jews is a fact as

documented by evidence below. Furthermore, the conversion of the Khazarians to Ashkinazim Jews is in God's plan. Jeremiah called of Khazar Ashkinaz alliance against Babylon "Set up a standard in the land, blow the trumpet among the nations, prepare the nations against her (Babylon), call together against her the kingdoms of Ararat, Minni, and Ashchenaz; appoint a captain against her; cause the horses to come up as the rough caterpillars" (Jeremiah 51:27).

Jewish Culture and Ethnicity do NOT Define Faith in YHWH

- When Jews claim that what unifies them is being a single culture or single race, then they are mistaken. The Scriptures and history proves that Jews are the believers in YHWH from every nation, with priority of Israel. Jews have multiple cultures and multiple blood origin, race. This does not minimize God's physical and spiritual promises to Israel.
- The culture a Jew from Morocco has little in common with a Jew from Russia. Yet both are Jews because their faith. And the same for the race origin; a proselyte Jew is an equal Jew from Israeli origin. The truth is that Judaism is a matter of faith only.
- Messianic Jews who follow the Rabbinic tradition, in part, claim that they do this out of respect to the Jewish culture. But this is false because the Rabbinic tradition is a matter of faith in the Rabbis more than in Moses.
- Also, when someone converts to Judaism he does not need to eat Gefilte fish. And eating Gefilte fish does not make a person Jewish.
- When a Jew converts to another religion, or to paganism or atheism, he is no longer a Jew, even if his blood remains of Jewish family. Elijah the prophet asked the Jews who were worshiping Baal, "How long will you go limping with two different opinions? If the God of the Jews is God, follow Him! But if Baal is God, then follow him!" (1 Kings 18:21). Rabbi Hai Gaon, the last of the Gaonim, stated that a Jew who converted out of the faith

was no longer a Jew. Rabbis Simon ben Zemah of Druan, Samuel de Medina, Judah Berab, Jacob Berab, Moses ben Elias Kapsali, Radbaz, Moses Isserles, Maimonides, and others agree that when a Jew converts out of Judaism, he is no longer a Jew. In conclusion, ethnicity and race are not determinant of Judaism.

The Conversion of Khazaria

- The King of Khazaria, Northern Caucasus and his family converted to Judaism along with twelve millions Khazarians, partly in order to maintain neutrality between Christian Byzantium and the Islamic world, and partly to unify the nation under one religion. This event forms the framework for Yehuda Halevi's work "The Kuzari" (AD 1140). Raymond Scheindlin said "To the oppressed Jews of the world, the Khazar were a source of pride and hope, for their existence seemed to prove that God had not abandoned His people."
- Encyclopedia Judaica stated "Groups have been mentioned as migrating to Central Europe from the East or have been referred to as Khazars, thus making it impossible to overlook the possibility that they originated from within the former Khazar Empire. The Turkish-speaking Karaite Jews of the Crimea, Poland, and elsewhere have affirmed a connection with the Khazars, which is perhaps confirmed by evidence from folklore and anthropology as well as language. There seems to be a considerable amount of evidence attesting to the continued presence (among the Jews) in Europe of descendants of the Khazars." There was a small Jewish diaspora in the Crimean Peninsula. Jewish refugees who escaped the Mazdaq rebellion in Persia, the persecutions of Byzantine Emperors Leo III and Romanus I Lecapenus.
- The Scriptures does NOT distinguish a Jew of Jewish blood or a Jew proselyte. Both are one and the same before God. The fact that the Ashkinazim Yiddish Jews are of proselyte Khazars does not make them less than any, because in God's eyes all believers are members of the

Commonwealth of the True Israel.

- Dr. Hugh Akins claims falsely that a proselyte Ashkinazi Khazarian Jew who is not of Jewish blood cannot claim to be of God's elect people. He said "A growing body of evidence points to the increasingly unavoidable conclusion that most contemporary Jews (Ashkinazim) are not even Semites at all, since they are not of the seed and lineage of Abraham but of Khazar (Eastern Europe/Turkish/South Russian) ancestry. The Khazarians were In fact, "pagan phallic worshipers from 400 BC to the 8th century AD, when they were converted to "Talmudism (Judaism)."

Who Are the Khazars

- The Khazars are the ancestors of the Ashkinazim and Bolsheviks, who seized power in Russia (AD 1917). The Khazars converted NOT to the original Hebraic faith, but to Talmudic Judaism and later added Kabbalistic Faith, which is called Jewish faith. They lived in the region between the Black Sea and the Caspian Sea (Khazakstan), and they are not of Semitic origin, but of Japhethite origin. They do not have Abrahamic blood. Yet, they claim superiority based on their, (falsely presumed), Jewish blood. According to Benjamin Freedman, this "conversion" of pagan Khazars was a relatively easy transformation even for a tribe of twelve million Khazars. Their conversion did not require a sacrifice nor an act of faith, but a cultural change from mystic phallic pagan rituals to mystic Talmudic Kabbalistic rituals.

- Dr. Arthur Koestler stated that the ancient Khazars converted to protect themselves from the onslaughts of Genghis Khan, then the Roman Catholic or Byzantine Christians and the Muslims. Then they migrated to Poland and they were called the Western Judaism. Koestler who is a Jew suggests that modern Ashkinazim Jewry has almost no ties to Abraham. But we need to know also that through the centuries (9th century through the 21th century) there might have been intermarriages with Jews of Abrahamic blood. Therefore, it is impossible to claim that all Ashkinazim

Jews are not of Abrahamic blood.

- Dr. Conrad Grieb describes from his research that the Khazars were descendants of a pagan people of mixed stock with Mongol and Turkic ethnicities. When the Slavs (Ukrainians) attacked and seized much of the Khazar territory, some of the conquered Ashkinazim Jews remained under Slavic rule while others migrated to Kiev and other parts of Russia, Lithuania, Poland, and Germany.
- Dr. Michael Hoffman and the historian Shlomo Sand affirm that the Khazarians were not of Jewish descendants, but converted from paganism to Rabbinic Talmudic Judaism.

Where Is Khazaria

- Khazaria, located to north regions of the Caspian and Black Seas. Its capital is Atila, on the Volga River. The Khazars were pagan people of from Southern Russia, Northern Caucasus, Eastern Ukraine and Crimea, Northern German and Turkish ethnicity. The Khazarians (Kuzarim) occupied large territories from the Volga-Don Steppes to the Ukraine, and from Caspian sea to the east to Northern Armenia and the Black Sea to the south. Kiev (Sambat) to the Northwest and Khersones to the Southwest. Western Kazakhstan, and northwestern Uzbekistan. Sabirs region, Bulgars region Eastern Slavs, Magyars, Pechenegs, Burtas, North Caucasian Huns. Actually, the Caspian Sea was named the "Khazar Sea."

Khazaria Old Religions

- Their religions were pagan, syncretism, Buddhism, and Tengerism Shamanism. The religion of the Mongols who invaded Khazaria was Tengri Shamanism. Tengri Shamanism incorporates the worship of spirits and the sky as well as zoolatry, the worship of animals. Tengri is their immortal god who created the world. Animal sacrifices including horses are made to Tengri.

The History of the Khazars

- Johann Ewers (1808) theorized that the Viking Varangians were the Khazar.
- From about 550 to 630, the Khazar were part of the Western Turkish Empire, ruled by the Celestial Blue Turks (Kök Turks). When the Western Turkish Empire was broken up because of civil wars in the middle of the 7th century, the Khazar successfully asserted their independence. Yet, they followed the Kök kaganate system of government.
- Medieval Kingdom of Khazaria, (652 - 1016)
- Muslim-Khazar Wars took place in the late 7th and early 8th centuries. The wars established the Caucasus and the city of Derbent as the boundary between the Khazar and the Muslims.
- The capital was Samandar (AD 720) and then became Itil (Atil) (AD 750) on the edge of the Volga River.
- In 950 Khazaran-Itil became the capital populated mostly of Muslims and few thousands Jews Diaspora, and a few Christians lived there also.
- The Khazar had a dual-monarchy system: (1) The Khagan was the supreme King. (2) The Bek was the civilian army leader. The Kagans were part of the Turkic Asena ruling family.

Before the Mass Conversion

- The Khazarians invited Byzantine and Persian Jewish refugees to settle in their country prior to the mass conversion. They constituted a very small minority. These Jews came from Armenia, Hungary, Syria, Turkey, Iraq, and many other places, as documented by: (1) al-Masudi. (2) The Schechter Letter. (3) Saadiah Gaon. There were many religions, and

Judaism was a minority among these religions.

- The Khazarians were tolerant to the immigrated Jews. Many Jews immigrated from Muslim countries, and the Byzantine Empire escaping persecution.
- There was Jewish influence at the Khazar court prior to the mass conversion to Judaism by the Khazarians. It is evident that there were Jewish emigrants in Khazar.
- The historians Ibn Fadlan and Ibn Dastah said that only the king and the nobles were followers of Judaism. The rest of the Khazar were of other religions; and the Jews were in a very small minority."
- Other historians affirmed that in Atil-Khazar, the capital had about ten thousand Muslims and the smallest group of minority was the Jews. The Jews were greatly outnumbered by the pagan masses, by Moslem and by Christian inhabitants of the cities. This indicates: (1) The majority of the mass conversion were from the pagan Khazarians while the actual original Jews were a small number, a few thousands at best. (2) Even if originally the nobles were proselyte Jews, when the King declared a unified religion for the country, then Mass Conversion was expected or forced as a definition of citizenship. Compare this with Emperor Theodosius I who defined citizenship to be Roman Catholic Christian.
- Therefore, we could safely say the proselytization of the Khazar began by the King, the Khagan, and the nobles then the entire country (AD 740).

The Mass Conversion of the Khazars to Talmudic Judaism

- The Khazarians were under constant attacks from the south and the west by the Byzantine Roman Catholics. The murderous Umayyad and Abassid Muslims threatened them from the south and east. Both the Christians and Muslim used the same type of Evangelism "convert to our

religion or die." They decided to become Jews on a large national scale. Such a move granted them to become a Third World Power. The Khazarian Jewish kingdom avoided their blood shed by the Christians and by the Muslims and thrived until they were annexed to Russia by the Russian force in Kiev (AD 965).

- The Arabic writer Dimashqi wrote that the Jews refugee in Khazaria offered their religion to the Khazar Turks and that the Khazar "found it better than their own and accepted it."
- George Vernadski mentioned that the Khazar sent ambassadors delegation to Constantinople (AD 860) seeking wisdom. Their message was "We have known Tengri the lord of everything from time immemorial. Now the Jews are urging us to accept their religion and customs, and the Arabs, on their part, draw us to their faith, promising us peace and many gifts. Another tradition states that the Khazarians received ambassadors of Byzantine Christian, of Muslim and of Jewish faiths and inquired from them of the best religion to adopt as a State Religion of Khazaria. Cyril and Methodius were sent as missionaries to the Khazar by the Byzantine emperor Michael III.
- The Khazar's conversion to Talmudic Judaism is not a surprising outcome, not only because of the concerns of the Khagan King about the moral decline, but for political reasons also. Khagan King Bulan (AD 740) was reputed to have converted to Judaism.
- The Muslim historian D. M. Dunlop from al-Bakri (11th century) described the events as follows: "The reason for the conversion of the king of the Khazar, who had previously been a heathen, to Judaism was as follows. He had adopted Christianity. Then he recognized the wrongness of his belief. He took counsel with one of his governors who told him "O king, the People of the Book form three classes. Invite them and enquire of them." The Christian Bishop came who debated a Jewish Rabbi. The Rabbi asked him "What do you say about Moses, son of Amram, and the Torah, which

was revealed to him? The Bishop replied, Moses is a Prophet, and the Torah is true." The Rabbi said to the King "The Bishop has admitted the truth of my creed. Ask him now what he believes." So the King asked the Bishop who replied "I say that Christ the Messiah, Jesus the son of Mary, is the Word, and that He has made known the mysteries in the name of God." Then the Rabbi said to King Bulan "The Bishop confesses a doctrine, which I know not, while he admits that my doctrine is true." The King of Khazar invited the Muslims, and they sent him an Imam, a learned and intelligent man who understood disputation. But the Jew hired someone against him who poisoned him on the way, so that he died. And the Jew was able to win the King for his religion."

- Koestler presents a different view and motives for the conversion of King Bulan. His position was that the king's conversion was essentially a political decision. "As the world was polarized between the two super-powers, Christianity and Islam (AD 730). Their political and military powers were part of their religion. There was no separation between State and Religion. The independence of Khazaria meant the adoption of Judaism as a State Religion, otherwise, they fall under the power of the Byzantine Emperor or the Caliph of Baghdad.
- King Bulan adopted Judaism (AD 838) for the entire country, after meeting ambassadors of the Jewish, Christian, and Muslim faiths. The Khazar nobility and most common people also became Jews. King Obadiah, was the son and successor of King Bulan, later invited many Rabbis and teachers from Mesopotamian and established synagogues and Jewish schools in Khazaria. The books of the Mishnah, Talmud, and Torah thus became important to many Khazar.
- Saint Cyril came to Khazaria (AD 860) in a Byzantine attempt to convert the Khazar to Christianity, but he was unsuccessful in converting them away from Judaism. He convinced many of the Slavs to adopt Christianity.

-
- King Bulan was the first Khazar to adopt Judaism personally (AD 730) and nationally (AD 860). Tradition claims that, because of the goodness of King Bulan, an angel appeared to him in his dreams. The angel exhorted him to worship the true God and that he will be blessed and multiply his offspring, and will make his kingdom last to the end of the world. This vision or dream matches that of Abraham. Hence, King Bulan began a New Chosen Race to be added to the Jews, i.e., the thirteenth tribe.
 - According to an ancient document entitled "King Joseph's Reply to Hasdai ibn Shaprut," King Joseph stated that, "From that time on, the Almighty God helped King Bulan and strengthened him. He and his slaves circumcised themselves and he sent for and brought wise men of Israel (Rabbis) who interpreted the Torah for him and arranged the precepts in order." The author claims a dream (or a vision): God promised King Bulan that if he would abandon his pagan religion and worship the only true God that He would "bless and multiply Bulan's offspring, and deliver his enemies into his hands, and make his kingdom last to the end of the world". Such blessing was by two Kings of Khazaria: King Bulan and later King Joseph, and it is similar to the Abrahamic blessing. The Khazarians believed that they are destined to be the Thirteenth Tribe. They say, Abraham was a Hebrew who crossed over the Euphrates and King Bulan and King Joseph were Hebrews who crossed over the Volga.
 - The king of Khazaria (AD 740), his family, his court and the whole ruling class converted to Judaism. Immediately four thousand feudal nobles were promptly converted by rabbis who came from Babylonia for the event. Then, tradition says, twelve million Khazarians converted to Talmudic Judaism. Then, King Bulan forbade all other religious pagan worship, which were described as extremely immoral forms of religious practices, among them phallic worship. Benjamin Freedman and many historians assert that the beginning of the mass conversion to Judaism was spearheaded by the Khazarian king.
 - One of the positive consequences of this mass conversion is that the

Khagan Khazarian King now has absolute authority over the people, both prelatie and judicial, which the older system of Tengric Shamanism did not allow. He, as a Jewish King assumed a role of a prophet, and a king.

After the Mass Conversion

- After their conversion, the Khazar people: (1) Used Jewish personal names. (2) Spoke in Yiddish and in Hebrew. (3) Changed the alphabet to uniquely the Hebrew language. (4) Were circumcised in masses. (5) Received many rabbis and teachers from the Diaspora in Mesopotamia. (6) Established synagogues. (7) Studied the Torah and Talmud. (8) Observed the Biblical Feasts and the Hanukkah. (9) Kept the Sabbath. (10) They built many synagogues and schools to instruct the population in the new State Religion. (11) As they moved to northern Europe and the Ukraine, they changed their name to Yiddish people, then to Ashkinazim Jews. (12) They changed the constitution so that all Khazarian kings had to be Jews. (13) Khazaria became to be known a Jewish country. (14) The Khazarian government became a theocratic Talmudic government.

- As they moved to Northern and Eastern Europe, Ashkinazim Jews began to be known as Saxons; in appearance physically, genetically and in their skin color. It is interesting and sad as I encountered many Ashkinazim Jews who claim superiority over the Sepharadim or Beta, and Mirzahim Jews who are direct descendants of the twelve tribes.

- News of the mass conversion reached the Sepharadim Jews of Spain. Rabbi Hasdai Ibn Shaprut (b. 915 - d. 970) a leader of the Spanish Jewish community, began corresponding with the Jewish Khazar king.

The Language

- King Bulan adopted the Hebrew square alphabet instead of the Khazarian Asiatic alphabets. The Hebrew characters were adopted to the phonics of the spoken Khazar language. This gave rise to a new language,

known as "Yiddish". Yiddish while it is written in Hebrew script, it is of German not Hebraic linguistic roots. The Khazar adapted words to their requirements from the German, the Baltic and Slavonic languages. The Khazar adopted a great number of words from the German language. The "Yiddish" is not a German dialect. Many are led to believe that "Yiddish" must be German since it shares so much with the German language.

- The Khazarian became known as the Yiddish and now they are known as the Ashkenazim Jews. Russia absorbed Khazaria (tenth through the thirteenth centuries).

The Khazar Saved Europe from the Muslim Caliphate Invasion

- Most historians attribute the victory of Charles Martel as the decisive event that stopped Muslims from overcoming Europe, but the Jewish Khazarians were equally essential.
- Professor, D. M. Dunlop explained that except for the conversion of the Khazar to Talmudic Judaism, the Muslims would have been able to capture all Europe. There was no barrier then. The Khazars were considering converting to Christianity or Islam, but chose Talmudic Judaism.
- Rutgers University Professor Peter Golden, one of the principal authorities on the Khazar, wrote, "Every schoolchild in the West has been told that if not for Charles Martel and the battle of Poitiers there might be a mosque where Notre Dame now stands. But if not for the Khazar, Europe might well have become a province of Islam".
- The Byzantine Roman Emperor Heraclius (AD 627) formed a military alliance with the Khazar for the purpose of defeating the Persians. The Byzantine Emperor offered, along with many treasures, his daughter Eudocia in marriage. But, the Khagan (King) Ziebel, the groom, died while Eudocia was en route to Khazaria. The wars with the Muslim ended (AD

652) with the death of four thousand Arab soldiers, including their commander, Abdal-Rahman ibn-Rabiah, and the Arab armies in complete disarray. However, after the final defeat of the Muslims (AD 730) a marriage between a Khazar princess and the heir to the Byzantine Roman Empire. They had a son who was called Emperor Leo the Khazar.

- Caliph Marwin II, in a surprise, two-pronged attack, drove the Khazar as far back in their own land as the Volga region. He demanded that either they become Muslims or they die. At the same time, the Byzantine Empire also had claims on Khazaria. In view of these two forces, the Kagan converted to Judaism. Tradition says that the Khagan (King) was already a Jew but he did not demand everyone else to become a Jew like him. Then, in view of the impending attacks by Muslims and Christians, he commanded all to become Talmudic Jews. The Muslims withdrew, probably because they could not hold the Khazarians by military power alone, unless they convert to Islam.

- Charles Martel and his Francs could not save Europe from Islam, unless the Khazar stopped the Muslim onslaught from the east.

End of Khazaria

- Koestler, the historian, recounts that the Byzantine Emperor Theodosius II wanted to have alliance with the Khazar. One of the Khazarian commanders, Karidach, wanted to have a bigger bribe and more power. Karidach made alliance with Attila the Hun instead of Theodosius II. Attila the Hun defeated the other commanders, chieftains and installed Karidach as the Khagan of the Khazar. He was given the name, Ruler of the Akatzirs. The Akatzirs are the White Khazar. Karidach treated Attila the Hun as a god, which pleased Attila the Hun. After the death of Attila the Hun, the Khazarians moved south and west and conquered many territories in Eastern Europe reaching the Danube.

- The Rus of Kiev attacked Khazaria and weakened them immensely. The

Rus Prince Svyatoslav, Grand Duke of Kiev {r. 962 - 972} was the son of Prince Igor and Olga. He did not convert to the Christian Faith, although Olga was after him, hoping to convert him. He conquered the Khazar fortress of Sarkel (AD 965) and conquered Atil-Khazaran (AD 969) and then he captured the Balkans. He annexed the region to the Ukraine. The Khazarian Jews populated the Ukraine, Northern Germany, Northern France, and Eastern Europe. They began to be known as the Ashkinazim Jews. Their blood, ethnic, origin is proposed to be of multiple origins: Slavic Subbotnik, Bukharan, Kумыкs Kazakhs, Cossacks of the Don, Krymchaks, Crimean, and Moldovian Csangos.

- Many Jewish Khazarians were taken to the Ukraine. Eventually, the kingdom of Khazaria disappeared after the twelfth century. The Khazarian Jews moved to Germany, Northern and Eastern Europe, the Ukraine and the royal family to Spain.
- The Jewish Encyclopedia stated "Many Khazars (Ashkinazim - Yiddish) intermingled in the Crimea with the local Jews; the Krimtschaki are probably their descendants. And perhaps some of the Subotniki also are their descendants. Some went to Hungary, but the great mass of the people remained in their native country. Many members of the Khazarian royal family migrated to Spain."
- At about the time of the decline of the Khazar Empire, several regions began to form as States in Eastern Europe. They developed into the modern States of Russia, Ukraine, Poland, Hungary, Romania, the Czech and Slovak republics, Austria and Germany. These countries had substantial communities of Ashkinazim Jews who migrated out of Khazaria.
- Emperor Vladimir III of Rus became a convert to Byzantine Christianity (AD 986) in order to marry a Byzantine Slavonic princess of a neighboring sovereign state. Vladimir made his newly acquired Christian faith the official State Religion of Rus replacing the pagan worship formerly

practiced since Russia was founded (AD 820).

- They attempted in vain to convert the Ashkinazim Yiddish Jews to the Russian Orthodox Byzantine Christian faith. The Yiddish people refused to convert or to adopt the Russian alphabet. Universal Jewish Encyclopedia stated "Descendants of the Khazar Jews are believed to have migrated to Kiev and other parts of Russia."

- Finally, the royal Khazarian families migrated to Spain. The last Khazarian King and his twenty-five wives (all of royal blood), and sixty concubines migrated to Spain with many family members. Some of the family went to Germany, Hungary and Poland.

- The Ashkinazim Jews are about eleven million (AD 1960) living in Ukraine, Germany, Hungary, Poland, and Northern Europe.

- The Sepharadim Jews are about half a million (AD 1960) living in Spain, South Europe, and North Africa. They were expelled from Spain by the Moslems and by the Roman Catholics.

- Today, ninety percent of the Jews living in Israel are supposed to be descendants of the Khazarians. A proselyte Jew is a Jew disregarding his blood heritage.

- The great Jewish educational centers in Poland, Russia, Eastern Europe, and America were founded and led by Ashkinazim Jews from Khazaria.

- Alroy was a Khazarian Ashkinazim Jew (12th century) who arose in Khazaria and led a Messianic movement to return to the land of Israel by force of arms.

- Solomon ben Duji, a Khazar Jew, aided by his son Menahem and an Israeli scribe led the campaign of "El Alya." They wrote letters to mobilize all the Jews in every diaspora. They claimed that "the time had come in

which God would gather Israel, His people from all lands to Jerusalem, the Holy City." Solomon Ben Duji was declared to be Elijah, and his son the Messiah. They did not succeed. Solomon ben Duji proved to be slightly delusional, or possibly hypomaniac.

(71) Seventy-One Evidence of the Khazarian Origin of Ashkinazim Jews

- Many Ashkinazim Jews reject the fact that their origin is not from Abraham and that they do not have Abrahamic or Israeli blood. Initially, I did not believe that either, but as I began investigating this subject, I came to the conclusive evidence that they are truly of Khazarian Togamra Magog origin. Again, this does not mean that they are less Jews for Judaism is by faith not by blood, according to the Scriptures. It is ironic as I met hundred of extremely racist Ashkinazim Jews who assumed that their white skin means their superiority over the Sepharadim, the Mizrahim, or other Jews of Israeli Abrahamic blood. Here is a list of evidence that is clear and decisive.

(1) Hasdai, the Spanish Jewish foreign minister wrote letters to Joseph, King of the Khazars "The Khazar Correspondence" (AD 960). Judah Halevi and Abraham ibn Daud who have converted also to Rabbinic Judaism were part of these correspondences. In these letters, Hasdai mentioned his belief that there was a Diaspora in Khazaria from the Ten Lost Tribes. Isaac 'Akrish, who first published the Khazar Correspondence, believed the same.

(2) When the Khazarian Jews went to Kiev, they found the Karaite Jews of Crimea who emigrated from Khazaria and Poland to Kiev prior to their arrival. They were Khazarian.

(3) The Turkish speaking Karaites of the Crimea, Poland and elsewhere have affirmed a connection with the Khazars. This is evidenced by folklore, anthropology and language.

(4) The Swedish numismatist, Dr. Gert Rispling (AD 2002) discovered a Khazar Jewish coin. Coins are minted only the State; it is clear also that Khazaria was a Jewish State, which was well known to had been a pagan State in the seventh century, hence, converted to Judaism.

(5) Solomon Schechter mentioned that some of the Jews sought refuge

from persecution in the land of the Khazars. They had intermarried extensively with the indigenous peoples. This means that the Diaspora disseminated among the Khazars and many Jews lost their Jewish culture and, or faith. This does not mean that all the Khazarians have Jewish blood. But it does mean that a percentage of them had Jewish blood prior to the mass conversion to Judaism. Khazaria was a refuge for few thousands of persecuted Jews prior to the mass conversion. Some escaped from Byzantium and other escaped from Mesopotamia to Khazaria. Their number is in the thousands.

(6) The Talmud states "The war of Gog and Magog will be one of the key events to usher in the Messianic Era." The Jerusalem Targum claims that, "At the end of days, Gog and Magog shall march against Jerusalem, but perish by the hand of Messiah."

(7) Some scholars believe that the Khazar, or at least some of the Khazar were originally Jews. Eldad ha Dani said "The tribe of Simeon is in the land of the Khazars." Dunlop is rejecting the mass conversion of the Khazarian to the Ashkenazim Jews, but he admits that Khazaria was Jewish. The Khazarian were not children of Abraham, hence, their conversion is evident.

(8) Ibn Fadlan, the noted Arab traveler and historian in the ninth century made the comment in his journals that "the Khazars and their king are all Jews. The Bulgars and their neighbors are subject to him. They treat him with worshipful obedience. Some are of the opinion that Gog and Magog are the Khazar.

(9) Christian Druthmar of Aquitaine, a scholar (AD 955), wrote a Latin treatise Exposition in "Evangelium Mattei," in which he reports that there exist people under the sky in regions where no Christians can be found, whose name is Gog and Magog, and who are Huns; among them is one, called the Gazari (Khazar) who are circumcised and observe Judaism in its entirety."

(10) The great Rabbi Saadiah Gaon (b. 882 - d. 942) referred to some Jews who lived in Khazaria.

(11) Professor Shlomo Sand of Tel Aviv University published "The Invention of the Jewish People" (AD 2008). His thesis was that the "Jewish people" is

an invention, forged out of myths and fictitious "history" to justify Jewish ownership of the Land of Israel (Haaretz.com, 2017). Professor Shlomo Sand's book empowered the Muslim, the British, the German, and the Neo Nazi anti-Jewish hate against the Jews. But such a thesis is not new, for since 1956, many voices began to question if the Jews who are back in their land are real Jews of origin or German Yiddish proselyte. It is important to know also that a proselyte Jew is an equal Jew and the promises of God pertains to every Jew equally. Hence, the idea about having Jewish blood to justify being a Jew is a fallacy. All Jews have the right to God's promises.

(12) Dr. Shlomo Sand did a thorough historic research and concluded the following:

(A) There was NO forcible expulsion of the Jews at the time of Titus or Hadrian or anytime thereafter. There is a total lack of any record supporting a Jewish expulsion.

(B) Jewish Diaspora is voluntary but not forced.

(C) The millions of Jews who were present around the Mediterranean and elsewhere are due primarily to the religious conversion, proselytization, of local people.

(D) Judaism, contrary to popular opinion, was very much a "converting religion" in former times.

(E) Mass conversions were first brought about by the Hasmoneans under the influence of Hellenism, and continued until Christianity rose to dominance (AD 325).

(F) It is likely that the ancestry of most contemporary Jews stems mainly from outside the Land of Israel.

(G) A "nation-race" of Jews with a common origin never existed.

(H) Judaism is a religion, and not necessarily a bloodline.

(I) Just as most Christians are converted people, Jews are also descended from converts.

(J) Judaism was originally, a proselytizing religion.

(K) Khazaria was a Jewish nation through mass conversions.

(L) Mass conversion to Judaism are also observed among the Berber tribes in North Africa, and in the Himyarite Kingdom of the Arabian Peninsula.

(M) The stories about exiled Jews or wandering Jews from the time of

Hadrian were invented by the Christian Church to spite and show God's anger against the Jews. But the Jews were never exiled from their land. Those who left Israel, did so in search for better life and better future.

(N) Following the Arab conquest of Israel (7th century), many local Jews converted to Islam and were assimilated among the Arab conquerors.

(O) Many, but not all, of the contemporary Palestinian are actually of Jewish origin who converted to Islam centuries ago.

(P) Sometime, during the nineteenth century, the German Ashkinazim Rabbis invented the National Ethnic character of the "Jews"

"retrospectively." They were motivated to create a modern Jewish people. Hence, Heinrich Graetz and other Jewish historians began to draw the history of Judaism as the history of a nation that had been a kingdom, became a wandering people and ultimately turned around and went back to its birthplace."

(Q) Shlomo Sand draws analogy with other nations, which rewrote the history to prove that they came from a "golden age" and thus they have a stronger national identity. Thus, the Jews sought the Kingdom of David as their "golden age."

(R) Prior to the rise of this National Ethnic Character, Jews thought of themselves as Jews because they shared a common religion, not a common ethnic background.

(S) The idea of El Alyah, the return of the Jews to the land of Israel, was alien to Judaism before the birth of Zionism.

(T) The Jews, for 2,000 years, stayed away from Jerusalem because their religion forbade them from returning until the Messiah came.

(U) The ancestry of Central and Eastern European Jews, the Ashkinazim, stems heavily from medieval Turkic Khazar who were converted to Judaism according to Arthur Koestler (AD 1976).

(V) Faith and Judaism do not mean shared ethnicity, essentialism. Essentialism leads to racism and arrogance. Essentialism feeds Antisemitism.

(13) Some scholars agree with Shlomo Sand: Simon Schama, Max Hastings, Eric Hobsbawm, Tony Judt, and Tom Segev. Bartal said "No historian of the Jewish national movement has ever really believed that the origins of the Jews are ethnically and biologically "pure." Arthur Koestler agrees with

the conclusions of Shlomo Sand.

(14) The scholar Simon Schama believes that the Khazar who converted to Judaism have been excised from the master narrative because of the embarrassing implication that present day Jews might be descended from Turkic converts." He further states that every young Jew and Jewess were proud of the Khazar as their origin.

(15) Genetic Studies Provide Evidence to the Khazarian Mass Conversion: Harry Ostrer genetic study proves that all three Jewish groups: Middle Eastern, Sephardic, and Ashkinazim share genome wide genetic markers that distinguish them from other worldwide populations.

(16) There is no genetic evidence contrary to the Khazar as progenitors of the Ashkinazim Jews or the Spanish Jews of the Royal Khazar house. This indicates that for the past thousand years, after the mass conversion of the Khazarians and Mediterraneans, Jews remained in tight family relationship, hence, genetically they are related to each other. This is also evidenced by the fact that each of the three groups have its common genetic markers.

(17) Another study, by Elhaik, on European Jewish population genetics was published in 2012 concluded that Ashkinazim Jews derive their genetic codes from Caucasus (Khazaria) and Mesopotamian (Babylonian) populations. This genetic scientific evidence vindicates Shlomo Sand.

(18) Dr. Dan Graur, professor of molecular evolution at the University of Houston and Elihaik's doctoral supervisor, called Elhaik's conclusion that Ashkinazi Jews originated in the Caucasus region and not the Middle East is "a very honest estimate."

(19) History, anthropology and Geneticists report that 98% of the Jews (especially the Ashkinazim Jews) are children of proselyte nations, such as Khazaria. Less than 2% of "Jews" living in Israel are actually Israelites. Dr. Elhaik, based on his research stated in an interview with Haaretz, Israel's daily newspaper "There are no blood or family connections among the Jews. The various groups of Jews in the world today do not share a common genetic origin. Their genome is largely Khazar."

(20) Dr. Eran Elhaik, geneticist researcher at Johns Hopkins University School of Medicine, found that today's "Jews" originated from Khazaria

and not Israel. They are not the physical seed of Abraham, but they can be the spiritual seed of Abraham if they believe in the Messiah Yeshua Jesus.

(21) Several genetic researches concluded that the Ashkinazim Jews are descendants of the Khazarians.

(22) Some scholars claim that the phylogeny of R1a1, which Ashkinazim Jews possess is different from the variety of phylogeny of R1a1, which the Khazars or Slavs possess. Hence, this could mean that the Ashkinazim Jews were not Khazarian. But at the same time, the Cohen Modal Haplotype R1a1 is found in the Ashkinazim Jews and equally, in the Kurds, Armenians, Italians, Palestinian Arabs, and a few other peoples, while the Sephardic Jews do NOT have it. Since it does not exist in the Sephardic Jews, then it indicates that the Ashkinazim Jews have a different origin than the Sephardic Israelite Jews. Regarding the variation between the R1a1 in the Ashkinazim Jews and the Khazar, this could be explained by the fact that one thousand years have passed since the mass conversion of the Khazars, thus the phylogeny R1a1 is modified to become unique within the closed Ashkinazim Jewish community from their progeny of Khazarians. Hence, this does not negate the Khazarian origin of the Ashkinazim Jews.

(23) Austrian historian, Matisyohu Meises confirms that the German Jews did not migrate to Germany from France across the Rhine based on the total lack of Yiddish linguistic roots in the French language. He was not aware of the Khazarian roots of the Ashkinazim Jews, but his observation brought him to see such connection. The Ashkinazim Jews did not come across the Mediterranean through Greece, or Italy, or France to Germany. The Yiddish Language is a marker, a sponge of the local culture and it does not show any markings of such countries or their linguistic roots.

(24) Ashkinazim Jews and Karaite Jews of Khazarian origin both have similar Y-DNA haplogroup Q1b1a (Q-L245). This could indicate that the Ashkinazim Jews are Khazarian, but it is not conclusive alone.

(25) Dr. Eran Elhaik, geneticist researcher at Johns Hopkins University School of Medicine, found that today's "Jews" originated from Khazaria and not of Israelite origin. The newest DNA science finding is from Dr. Eran Elhaik and associate researchers at the McKusick-Nathans Institute of Genetic Medicine, Johns Hopkins University School of Medicine. In research

accepted December 5, 2012 and published by the Oxford University Press on behalf of the Society of Molecular Biology and Evolution, it was found that the "Khazarian Hypothesis" is scientifically correct.

(26) Eran Elhaik conducted a genetic study (AD 2012) that showed the Khazarian genetic constitution of the European Ashkinazim Jews.

(27) Dr. Paul Wexler, a Yiddish expert is a proponent.

(28) Rabbi Isaac Baer Levinsohn (1788–1860) wrote one of the first references to a connection between the Ashkinazim Jews and the Khazar. He said that the Khazarian Jews who came to Ukraine spoke Russian before they spoke Yiddish. It is possible that the Khazarian who went to Northern Europe spoke Yiddish and then the Ukrainian Khazarians followed them and adopted the Yiddish as their identity language.

(29) Dr. Levinsohn mentioned that the tradition of their forefathers was that Ashkinazim Jews had earlier spoken Russian before acquiring Yiddish.

(30) Yiddish, the language of Ashkinazim Jews is evidence that their origin was not from Western Europe, but rather from Eastern Europe, Khazaria. Yiddish is an amalgamation of several tongues. It is written with Hebrew characters, but it includes much of mediaeval German and components of other languages like Slavonic. The German elements incorporated into Yiddish have been clearly shown to have originated in the east of Germany where it joined the Slavonic regions of Eastern Europe.

(31) Russian historian Nikolay Karamzin, the Russian Historian, asserts that considerable numbers of Khazar had left Khazaria for Kievan Rus in the time of Vladimir I (980–1015).

(32) Dr. Karl Neumann (AD 1847), The German Orientalist, asserts that the Ashkinazim Jews are of Khazarian origin.

(33) Dr. Abraham Eliyahu Harkavi (AD 1869) announced that there is a link between the Khazar and the Ashkinazim Jews. Abraham Firkovich, a Crimean Qaraite Jew (AD 1872) declared that the members of his Turkic-speaking sect were descended from Turkic Khazar converts to Judaism.

(34) Dr. Ernest Renan (1883) and other scholars declared that the Ashkinazim Jews of Europe originated among Khazarian Turkic refugees who had migrated from the collapsed Khazarian Khanate westward into

Europe, and exchanged their native Khazar language for Yiddish while continuing to practice Judaism. Dr. Renan stated that "Cette Conversion Du Royaume Des Khozars A Une Importance Considérable Dans La Question De l'origine Des Juifs Qui Habitent Les Pays Danubiens Et Le Midi De La Russie. Ces Régions Renferment De Grandes Masses De Populations Juives Qui N'ont Probablement Rien ou Presque Rien D'ethnographiquement Juif," which means, "This conversion of the kingdom of the Khazar has a considerable importance regarding the origin of those Jews who dwell in the countries along the Danube and southern Russia. These regions enclose great masses of Jewish populations, which have in all probability nothing or almost nothing that is anthropologically Jewish in them."

(35) Rabbi Isidore Loeb, historian and secretary of the Alliance Israélite Universelle argued that the Ashkinazim Jews are not of the Jewish race, but they are Khazarians, hence, Jews emancipation is in order. He argued that the Ashkinazim Jews, racially were no different from the Caucasians Khazarians.

(36) Rabbi Joseph Jacobs (AD 1886) is a proponent of the Khazarian origin of Ashkinazim.

(37) Anatole Leroy-Beaulieu (AD 1893) is a proponent of the Khazarian origin of Jews.

(38) Dr. Maksymilian Ernest Gumpłowicz is a proponent of the Khazarian origin of Jews.

(39) Dr. Samuel Weissenberg, the Russian-Jewish anthropologist is a proponent.

(40) Dr. Leroy-Beaulieu believes in the connection between the Ashkinazim Jews and the old nomads of the Steppes (Khazarians).

(41) Dr. Hugo von Kutschera (AD 1909) declared based on his research that the Khazars formed the foundational core of the modern Ashkinazim Jews.

(42) Dr. Maurice Fishberg (AD 1911) declared the Khazarians as the proselytes and progenitors of the Ashkinazim Jews.

(43) AT the Versailles Peace Conference, a Jewish Zionist called Palestine the land of the Jewish people's ancestors, Joseph Reinach, a French Jewish member of parliament who was opposed to Zionism, dismissed the idea,

arguing that Jews descended from Israelites were a tiny minority of the current Jewish populations. In his view, mass conversion (proselytization) had played a major role in the expansion of the Jewish people. Joseph Reinach declared also that the majority of Russian, Polish and Galician Jews descend from the Khazar, a Tatar people from the south of Russia who converted to Judaism in mass at the time of Charlemagne".

(44) Dr. Yitzhak Schipper (b. 1884 - d. 1943), the Polish-Jewish economic historian and General Zionist declared that the Ashkinazim Jews are of Khazarian origin. He wrote it while in the Warsaw ghetto. He was murdered, a victim to the Holocaust at Majdanek.

(45) H. G. Wells (AD 1921) was a proponent of the Khazarian origin of Ashkinazim Jews.

(46) Dr. Roland B. Dixon (AD 1923), a scholarly anthropologist, argued that the main part of Jewry is not of Israelite origin.

(47) Dr. Sigmund Freud (AD 1931) wrote to Max Eitingon that the sculptor Oscar Nemon, who was a Slavic Eastern Ashkinaz Jew, revealed to him that his Jewish genealogy in his family records is Khazarian Kalmuckian.

(48) The East European Congregations of the Qaraite Judaism adopted officially that their origin is Khazarian. They were proud of their history and origin.

(49) Rabbi Seraja Szapszal (b. 1873 - d. 1961), Hakham of the Polish-Lithuanian Qaraite Community had begun to implement a thorough reform policy of dejudaizing Qaraite culture and traditions and transforming along Turkic (Khazarian) lines. He was passionate about the Qaraite language, Karaim, and its Turkish tradition.

(50) Dr. Corrado Gini, a distinguished statistician (AD 1934), concluded that the Ashkinazim Jews arose from "Turko-Tatar (Khazarian) converts to Judaism."

(51) Dr. Abraham N. Polak (Poliak) (AD 1943), professor of the history of the Middle Ages at Tel Aviv University, published a Hebrew monograph in which he concluded that the East European Jews came from Khazaria. Anita Shapira disagrees with Shlomo Sand.

(52) Hans F. K. Gunther, the Nazi, concluded from his research that the Ashkinazim Jews were descendants of the Khazar.

(53) Dr. Gerhard Kittel agreed with Hans Gunther regarding the Khazarian origin of the Ashkinazim.

(54) The Qaraite claim that their descendants are from Khazaria, was eventually accepted by the Nazis who exempted them, unlike the Crimean Krymchaks with whom they had historic ties, from the policy of genocidal extermination on these grounds.

(55) Dr. Leon Poliakov (1955) declared that the Jews of Western Europe resulted from a "panmixia" in the first millennium, while Europe's Eastern Jews descended from a mixture of Khazarian and German Jews.

(56) Dr. Salo Wittmayer Baron supported the conclusions of Leon Poliakov. He concluded that the Khazarians conversion to Judaism was the "largest and last mass conversion", involving both the royal house and large sectors of the population. Jews migrated there to flee the recurrent intolerance against Jews and the geopolitical upheavals of the region's chronic wars, which often proved devastating to northern Asia Minor, between Byzantium, Sassanid Persia, and the Abbasid and Ummayyad Caliphates. After the dissolution of Khazaria, Baron sees a diaspora drifting both north into Russia, Poland and the Ukraine, and westwards into Pannonia and the Balkans where they established Jewish communities and paved the way, ironically, for the Slavonic conversion to Christianity.

(57) Rabbi Ben-Zion Dinur supported the conclusions of Leon Poliakov.

(58) Dr. Paul Wexler the linguistic researcher was a proponent of the Khazarian origin.

(59) Dr. Raphael Patai was a proponent of the Khazarian origin of Ashkinazim Jews.

(60) Dr. Boris Altschuler (1994), a researcher was a proponent of the Khazarian origin.

(61) Dr. Kevin Alan Brook, a researcher was a proponent of the Khazarian origin of Jews.

(62) Dr. Koestler argued that his findings would mitigate European racially based Antisemitism. But Zionists opposed him and accused him of Antisemitism.

(63) Austrian Dr. Hugo Kutschera, assert that Eastern European Jewry was not part, but entirely of Khazarian origin.

(64) Nebel genetic study (AD 2001) proves the Khazarian origin of Ashkinazim Jews. It reported a low-level European gene flow contributing to Ashkinazim paternal gene pool. It suggested that this influence might be reflected in the Eu 19 chromosomes common in Eastern Europe Ashkinazim Jews, which means that it might descend from Khazar.

(65) The Behar Genetic study using the high frequency haplogroup R1a1 NRYs with Paul Wexler's "theory of relexification," concluded that the Khazarian origin is a probability not just a possibility. Dr. David Goldstein asserted the Khazarian ancestry of Ashkinazim Jews.

(66) Another study of Behar et al. (AD 2013) of Ashkinazim Levites found a high frequency of haplogroup R1a-M582 among them (64.9% of Ashkinazim Levites) pointing to a paternal ancestor common to half of them. The R1a is typical Eastern European Khazarian (not Israeli). On the other hand, the M582 opens other possibilities of origin could be Iranian Kerman, Iranian Azeri, Kurds from Cilicia Anatolia and Kazakhstan. However, they cannot be of Iraqi, Bedouins, Druze, Israeli or Palestinians origin.

(67) Eran Elhaik and Wexler Genetic study (2012 - 2016) proves a strong Khazar link to Ashkinazim Jews. Eran Elhaik said "Strong genetic evidence for the Khazarian ancestors is the clustering of European Jews with those of ancient Khazaria: Armenians, Georgians, and Azerbaijani Jews. Both populations were relatively isolated. These findings imply a shared origin for European Jews and Caucasus populations.

(68) Dr. Kevin Alan Brook believes in the Khazarian progeny.

(69) The Khazarian were described by the Arab chronicler Ibn-Said al-Maghribi as having white complexions (white skin color), their eyes are blue, their hair flowing and predominantly reddish, their bodies large and their natures cold. Their general aspect is wild. The Ashkinazim Jews were called initially "Red Jews" because of the frequent red hair of the Khazarian Ashkinazim.

(70) The British politicians John Hope Simpson and Edward Spears (AD 1947), joined by Faris al-Khoury and Jamal Al-Husseini, argued that the Jews are not of Israeli origin, but rather of pagan and Khazarian origin, hence, they are denied the right to return to the Promised Land.

(71) Dr. Ariella Oppenheim of Hebrew University found, in 2001, that the "Jews" came from the Khazar rather than the Israelites ancestors. Dr. Oppenheim even found that some of the Palestinians have the chromosomes proving they are "Cohen," related to the ancient Israelites who worked in the Synagogue and Temple.

- Zionists refuse to accept that their origin, the Ashkinazim Jews origin, is NOT from Israel or from Abraham. Some people continue to reject and refuse to believe that the Ashkinazim Jews are of Khazarian origin and it is only a myth, contrary to all evidence. Some scholars who object, yet do not provide scientific or historic evidence are: Daniel Lazare, Hillel Halkin, Shaul Stampfer, Carlo Strenger, Peter Golden. "Haggai Ben-Shammai, Bernard Weinry, Bernard Lewis, Marcus Feldman, Harry Ostrer, Michael Hammer, Dan Graur, Anita Shapira and other Zionists.

Persecution - Anti Jewish discrimination and the Khazarian Origin Factor

- There can be no antisemitism once the people recognize that the racist Aryans are of the same origin as the Ashkinazim Jews who are also of the Khazarian Caucasian origin. Such knowledge renders the epithet "anti-Semitism" "void of meaning." added to this, the Arabs and many Persians are Semitics. If they are antisemitic then they are anti-self.
- In debates leading up to the United Nations plan (AD 1947) to partition Palestine into Jewish and Arab states, The British politicians John Hope Simpson and Edward Spears, joined by Faris al-Khoury and Jamal Al-Husseini, argued that the Jews are not of Israeli origin, but rather of pagan and Khazarian origin, hence, they are denied the right to return to the Promised Land.
- But, we need to understand that a Jew, whether he is of Jewish blood or of Proselyte parents is a true Jew entitled to the spiritual and physical Promises of God to Abraham.

- We need to understand, that the true believers in Yeshua Jesus the Messiah are the true Jews, disregarding their blood origin. In this latter sense, only the Messianic believers: Messianic Jews and Messianic Hebrews are the heirs of the promises of God to Abraham, the physical and the spiritual.

- There is a true and legitimate Chosen People of God. The Scriptures describe them as:

"And if you be Christ's (Messiah's)
then you are Abraham's seed and heirs
according to the Promise" (Galatians 3:29)

The Christian Identity Racist Movement

It began to take form (1940 - 1970). Its main tenets are: (1) Rooted in British Israelism. (2) Believes that the Jews are no longer Jews but Khazarians. (3) Associated Revelation 2:9 and 3:9 with the Khazars. Jeffrey Kaplan calls these two passages the corner stone of "Identity Theology." (4) Teaches that the Jews are literally satanic. (5) The writings of Francis Parker Yockey and Arthur Koestler are regarded almost as holy scriptures.

Russians Anti Jewish Racism

- In Russia, because of Stalin position and hatred to the Khazarians, the Russians regarded them as parasitic. They considered the Khazarians as synonymous of the Jews in the Russian nationalist lexicon, it is used as a euphemism for Jews. This inflamed the Russian Antisemitism and persecution of the Jews.

Racism Both Ways

- Professor Abraham N. Poliak, Tel Aviv University said that the Ashkinazim Jews are descendent from the Khazarian have settlement in Europe, and many have emigrated to the United States and to other countries and some went to Israel. They constitute the grand majority of

world Jewry. What is interesting is that some, but not all Ashkinazim Jews are both Zionists and racists against other olive skin Jews. The olive skin Jews, Sepharadim and Mizrahim have Israeli blood, yet some of the Ashkinazim Jews feel and act as superior to them. Every few years, in Israel, the Jews who are not Ashkinazim, i.e., Sephardic, Mizrahim, and Beta organize public protests against the "White" Ashkinazim Jews who are keeping the best financial positions for themselves in Israel. Such protests in Israel solve some discrimination but there is a lot more to be solved to reach true equality.

- I have met hundreds of Ashkinazim Jews, and I was profoundly surprised with their intense spontaneous racism against other Jews based solely on skin color. Whence does such hatred come from, if they are both Jews?

I was also in Messianic Jewish synagogues led by Ashkinazim and I found the same phenomenon; while pretending to be of the same family (Mishpahah), yet denigrating slander and gossip prevails against those with olive skin or black skin. The Ashkinazim have no claim to superiority, as the olive skin have true Israelite blood than them. It amazes me how can people have such intense and instantaneous vial reaction just by looking at someone new with olive or black skin color.

The driving force behind such racism by Ashkinazim whether Zionists or not, is both in the psyche of man and in demonic powers: (1) In the psyche of man, as each man is blindly conceited assuming in her or his superiority, which is false. (2) In demonic manipulation as any racist person cannot be truly regenerate or born again from heaven, and as such an open field for demonic suggestions and manipulations.

- When we look at Racism, we find that many people of all backgrounds do practice or approve or tolerate and accept discrimination and racism, which is very sad. I found consistent racism and systemic discrimination in most Churches by some of the leadership, the Clergy, and by some of the members. Racism is an evidence of false belief in Christ.

• I pulled my membership out of the Messianic synagogues, until such a time when all the family of God have honest and true love to one another as a real family. Sadly also, vial discrimination and racism is predominating in most Churches. How can one claim to love God, yet hates the image of God in man who may have different skin color or different accent or different age or different physical features? "If a man says, I love God, and hates his brother, he is a liar: for he that loves not his brother whom he hath seen, how can he love God whom he hath not seen? And this commandment have we from him, That he who loves God love his brother also." (1 John 4:20-21).
