DIRECTIONS FOR USE

Directions: Do not use undiluted.

Light build up: dilute 1:8 with cool tap water. Regular build up: dilute 1:4 with cool tap water.

Heavy build up: dilute 1:3 with cool tap water.

Using a mop, generously apply to your floor, allow the solution to stand for 1-2 minutes and agitate by re-mopping or with a low speed machine and a black pad. Use a wet-vac to pick up stripper solution. Rinsing is not mandatory, however, it is recommended.

HANDLING AND STORAGE: Store at room

temperature. Keep cap tightly sealed when not in use. Protect from contamination, evaporation and freezing. Keep cap tightly sealed when not in use. Protect from contamination, evaporation and freezing.

Personal Protection: Practice normal hygienic practices after handling. Thoroughly wash hands with soap and warm water after using.

Packaging: Whenever possible, bottles and pails made from recycled plastic (10-25%). Can be recycled where facilities exist. Boxes made from recycled cardboard (94-100%).
