September 12, 2018

Regular meeting for September 12, 2018 was held at Bridgehampton Township Hall Carsonville, Michigan. The meeting was called to order at 7:02 pm by Sonck, welcome, followed by The Pledge of Allegiance to the Flag. Roll call by Sonck, present were: Innes, McCarty, Hewitt, Kelly, and Sonck. Guests were present.

Motion by Hewitt to accept the amended Agenda, with the additions of the County Commissioners Report, Tucker Cemetery Bids, and the July 11 Election Commission Meeting Minutes, supported by Innes. All Ayes

Motion by Hewitt to accept the August 15, 2018 Regular Meeting Minutes as presented, supported by Kelly. All Ayes

Motion by McCarty to accept the June 6, 2018 Planning Commission Meeting Minutes as presented, supported by Hewitt. All Ayes

Motion by Kelly to accept the July 11, 2018 Election Commission Meeting Minutes as presented, supported by Hewitt. All Ayes

Innes read the Treasurer's report into record as of August 31, 2018. General Fund account balance \$3,067.58, Investment account balance \$114,760.63, Tax Checking account balance \$254.73, and Tax Savings account balance \$46,979.65. The balance difference in the General Fund and Investment account from August 31, 2017 to August 31, 2018 is -\$27,462.93. Motion by McCarty to accept the Treasurer's report as presented, supported by Sonck. All Ayes

Commissioner Heberling reported that the jail sustained considerable damage during last weeks storm, taking out the network controller and their computers. The damage is in excess of \$30,000, but it will be covered by insurance. Currently Commissioner's Heberling, Dean, and Administrator Tara Griffith are working on the final stages of the 2019 Budget. Heberling said there will be a 1.5% increase over last year's budget due to elected officials step raises and the probate & circuit court clerks being awarded raises. Commissioner Heberling thanked anyone that may have voted for the Drug Task Force Millage, they appreciate those funds immensely. Also, just a reminder to make sure PA116 applications are filled out completely. The Sanilac County Planning Commission has been receiving many incomplete applications. Lastly, there's been an issue of concern regarding a culvert in our township and hopefully the right people have come together to see that the issue gets taken care of. The farmer shouldn't be left with a culvert that he can not use. One last thing, Heberling reported Paul Mitchell was on a plane with President Trump and two other Michigan Senators and signed a bill to put a new 1300' addition on the Soo Locks.

<u>Communications Received:</u> Innes received a notice from Semco Energy about a meeting before the Public Service Commission to request reconciliation on the 12 month gas costs and revenues.

McCarty received the FOIA request from the United Impact Group LLC for the ballots from the November 2016 election, a PA116 for Johanna Colesa for 40 acres on N. Loree Rd. Section 13, and the ballots to be proofed for the November 6, 2018 election.

Old Business: We received 2 bids to stake the Tucker Cemetery driveway. The bids were from Polaris of Capac for \$1,800 and John Milletics of Sandusky for \$265. Motion by McCarty to accept the \$265 bid from John Milletics, supported by Hewitt. All Ayes

The Sweet Extension Drain FOIA from the Sanilac County Drain Commission revealed what the Township Board had suspected, the Drain Commissioner is out of compliance with the drain code. Alexander spent \$24,000 on 1.136 miles or 6000' of the Sweet Extension Drain. Proper notification wasn't given to the township and Alexander changed the apportionment from 25% to 10% because anything over 20% would need a resolution from the township board, which Alexander didn't get. The Drain Commissioner can spend \$5000 per mile as maintenance on a drain, anything over that amount must have a resolution. Beings that the Sweet Extension Drain is only between 3 & 4 miles, Alexander still far exceeds the \$5000 per mile even at 4 miles. The Sanilac County Commissoner's will be made aware of the issue.

<u>New Business:</u> The Board talked about a new purchasing policy and will review it further at next month's meeting.

Regular meeting for October 10, 2018 was held at Bridgehampton Township Hall Carsonville, Michigan. The meeting was called to order at 07:00 PM by Sonck, welcome, followed by The Pledge of Allegiance to the Flag. Roll call by Sonck, present were: Innes, McCarty, Hewitt, Kelly, and Sonck. Guests were present.

Innes read the Treasurer's report into record as of September 30, 2018. General Fund account balance \$803.41, Investment account balance \$100,248.49, Tax Checking account balance \$1,067.05, Tax Savings account balance \$25,911.11. The balance difference in the General fund and Investment account from September 30, 2017 to September 30, 2018 is -\$35,824.20. Motion by McCarty to accept the Treasurer's report as presented, supported by Kelly. All Ayes

Public Comment: Commissioner Heberling gave his report of the county activities for the month. As County Treasurer, Trudy Nicol would like to be involved in the Budget Committee. She has concerns about the Delinquent Tax Account and would like to have input regarding the same. Commissioner Heberling said Act 206 1897 authorizes the Commissioners to move funds from one account to another and the 2019 budget will be a 1.5% increase over 2018. At the Commissioner's last meeting they approved a fulltime weighmaster position that will have shared duties with the Sheriff's Dept., but will be fully funded by the Sanilac County Road Commission. Last, but certainly not least, there's great concern over a woman by the name of Kelly who has control over the Treasury Department for the State of Michigan. She's increased the fee for assessor training from \$400, that was done at Delta College, to \$2,500 and now the training must be done in Lansing. They're trying to push bills SB1169 & HB6049 through Lansing that would allow the state to take away assessing from the local assessors which would mean less money to the counties. That concludes Commissioner Heberling's monthly report. Sonck asked what the Drain Commissioner's budget would be? Heberling stated \$175,000 and Alexander wanted \$25,000 more, but was denied.

<u>Communications Rec:</u> McCarty reported she had finished the audit for Accident Fund Insurance and they will be refunding \$21 to the township in overpayment. Also, McCarty has received her 1st Federal Post Card Application for an Absent Uniformed Service Member.

Sonck received a call from a man from Thumb Electric regarding a land split for John McConnachie. He was asking for a letter of guarantee that the resulting parcel would be guaranteed electricity. The gentleman stated it was a landlocked parcel and Sonck replied

that if there wasn't any road frontage the split would not be approved. The gentleman from Thumb Electric was going to call the attorney who had contacted him regarding the aforementioned parcel.

Meetings Attended: McCarty attended the October 2, 2018 County Commissioner's Meeting.

Hewitt attended the Township Planning Commission Meeting on October 2, 2018 where they went over the solar update and started reviewing the master plan.

Sonck attended the County Commissioner's Meeting on October 2, 2018 where he issued the complaints the township has with the Drain Commissioner. Sonck doesn't know what the response will be to our complaints, however he wasn't cut off at the 3 minute mark and he was speaking during public comment. There was some feedback after the meeting from the Commissioner's that said not only did the Drain Commissioner spend \$10,000 of the township's money that wasn't budgeted, he also spent \$80,000 of the counties money that wasn't budgeted either. Sonck did contact Michael Homier for an estimate as to what it would cost to have him review the FOIA response and let us know what the penalties are for the violations Alexander is accused of. Homier estimated it would take approximately 4 hours to review the case which would be \$1000. More discussion with Homier is tabled, pending discussion with other townships.

Old Business: Review of Board Policies: The front page is void and can be deleted. Reva Wallace does not have the deed to the hall and Innes will look for the key to the safety deposit box. Collection of delinquent personal taxes by treasurer can be struck, that is state law. Recording policy, we'll strike tape recorder and change to audio recorder. Innes does not have backup disks, that will be deleted. Extra meetings for zoning board members and the rate of pay should be updated. Policy for purchases over \$20,000, no one is aware of the policy. Purchasing policy should be changed to anything over \$5000 would require publishing and sealed bids, under \$5000 would not require publishing, will call for bids. Ditching agreement is fine. Sonck will make necessary changes to consider at next month's meeting.
