ABOUT THE PROGRAM

Path programs have succeeded in putting experience and expertise to work to meet the needs of homeless people who have mental illnesses by engaging the services of community health providers, community-based social service agencies, health care providers, and substance use treatment providers.

The Path program was authorized by the Stewart B. McKinney Homeless Assistance Amendment Act of 1990. PATH is a formula grant program administered through the Substance Use and Mental Health Services Administration (SAMHSA). There are over 480 local PATH programs nationally. Virtually all states use PATH funds to provide outreach services to contract and engage people who are not connected with mainstream services and resources.
