#### Latest updates on exhuming Boundary Road Superfund Site, Expanding Orchard Ridge Landfill in Menomonee Falls

WEAL submitted public comments to the Wisconsin



DNR and EPA on Waste Management of Wisconsin's (WMWI) Orchard Ridge Landfill, Southern Unit Landfill Expansion Feasibility Report on 5/28/2021. The comments included a request to allow the formation of a Community Advisory Group (CAG) for the

Boundary Road Landfill (BRL) which is a federally designated Superfund site. The EPA website states: "A CAG is designed to serve as the focal point for the exchange of information among the local community and EPA, the State regulatory agency, and other pertinent Federal agencies involved in cleanup of the Superfund site. Its purpose is to provide a public forum for community members to present and discuss their needs and concerns related to the Superfund decision-making process. A CAG can assist EPA in making better decisions on how to clean up a site. It offers EPA a unique opportunity to

hear-and seriously considercommunity preferences for site cleanup and remediation." On 6/07/2021 the EPA informed WEAL the DNR is the lead agency for the BRL and our request was forwarded to the regional supervisor for Community Involvement Coordinators and the national CAG coordinator for review.

Over the past 16 months, WEAL has emailed and/or called the DNR several

times asking when a public notice would be issued to solicit interest in the formation of a CAG. Ultimately, the DNR decided to issue one public notice on

7/31/2022 that included an opportunity for individuals and stakeholder groups interested in forming a CAG to submit comments expressing interest. The public notice also offered an opportunity to provide comments for the upcoming Fifth Five-Year Review Report for the BRL Superfund site. WEAL submitted comments supporting a CAG and provided comments on the Fifth Five Year Review. As of 10/05/2022 WEAL has not been notified regarding the status of the CAG request or a response


to comments for the Five-Year Review. WEAL is not aware of any individual or group receiving notification of a DNR decision. On 9/29/2022 the DNR finalized the Fifth Five-Year Review Report for the BRL Superfund site. The report states: "the responses to the public notice also expressed



support of, or interest in, forming a CAG due to the proposed project. WDNR and EPA value these responses and continue to coordinate on-site activities." WEAL emailed the DNR on 9/29/2022 asking if enough statements of interest were submitted to support forming a CAG. WEAL also asked when the DNR would notify interested parties.

WEAL has not received a response. When WEAL has more information on CAG status, it will be posted on the WEAL website at www.weal.org.

Additionally, the DNR received an Addendum (#1) to the Plan of Operation from WMWI on 9/16/2022 and a second Addendum (#2) from WMWI on 9/30/2022.


packet, a couple of bulbs or a plant. We look forward to meeting new members or saying hi to old friends.

#### WEAL joins campaign to update municipal waste combustion standards

On 10.4.2022, WEAL joined 273 local, state/regional, and national groups signing a <u>letter to the White House Council on Environmental Quality</u> (CEQ) urging the CEQ to the direct the U.S. Environmental Protection Agency (EPA) to update municipal waste combustion standards and close various loopholes that have allowed a number of waste burning incinerators to operate without the most up-to-date pollution control systems. The letter also includes recommendations for specific changes the EPA should undertake.

#### Cost-effective Zero Waste Systems able to cut emissions by 1.4 billion tons

The Global Alliance for Incinerator Alternatives (GAIA) held a worldwide <u>virtual webinar</u> on 10.4.2022 to launch a new groundbreaking report entitled <u>Zero Waste to Zero Emissions – How Reducing Waste is a Climate Game Changer</u>. The report demonstrates how implementing cost-effective Zero Waste Systems in cities around the world can cut total emissions from the waste sector by more than 1.4 billion tons, which corresponds taking all vehicles in the U.S. off the road for a year.
