### **TERMS & CONDITIONS**

### EVENT SET UP AND TEAR DOWN

A booth space of 10' x 10' will be provided at the event for each vendor. Vendors are responsible for providing their own tables, chairs, tents, and other necessary booth furnishings. Electricity will not be provided.

Booth set-up will be on Saturday, September 17, 2022 between 8:30 and 9:30 a.m. Vendor will provide volunteers who can assist them to unload and reload booth materials and move the materials to and from Vendor's booth. Immediately following the event, please make arrangements to have all items out of the venue no later than 3:30 p.m. or an additional fee will be applied. All belongings and waste must be removed from your booth and disposed of in trash containers. Any merchandise or display material left after the event shall not be the responsibility of the management and will be removed from the property on Sunday evening.

#### RESPONSIBILITY OF VENDOR

The Vendor will staff the booth at all times during the event. The Vendor understands that other Vendors with merchandise similar to Vendor's may also have booth space at the event. The Vendor understands that we, in our sole discretion, may refuse Vendor's request for booth space.

# RESPONSIBILITY OF HOSTING PARTY
