



## Request for HUD Data Plate/Compliance Certificate

**Both will be ordered to satisfy Manufactured Home Guidelines. Here is what you are ordering:**

### Label Verification Letter

Is a letter that provides the following information: Label Number, Serial Number, Date of Manufacture, Name of Manufacturer and Plant Location and Location of First Destination. It does not contain the wind zone, roof load or thermal information.

### Data Plate/Performance Verification Certificate

Provides Serial Number, Date of Manufacture, Name of Manufacturer and Plant Location and Wind Zone, Roof Load Zone and Thermal Zone for which the zone is designed. The certificate is based on the zone requirements in effect at the time the home was manufactured for the location of the home's final destination. It does not contain the Label Numbers.

If your appraisal is missing information or the following questions are marked No, you will need to request the coordinating Certificate or Label from IBTS.

HUD DATA PLATE	The HUD Data Plate/Compliance Certificate is located on the interior of the subject and contains, among other things, the manufacturer's name, trade/model name, year manufactured and serial number. The HUD Certification Label is located on the exterior of each section of the home.
