Fishing and Marine Industry Forum

Explore Cooktown 2017

Estimated \$53,648 income to date. Estimated outgoings of \$43,000 Moved Gary K, seconded Hamish H that Blackstar Radio be offered a contra deal for advertising in the brochure in exchange for promotional opportunities on the radio for CCCT activities. Carried

Visitor Information Centre

Council has advised that the VIC contract has been awarded to the Kindred Café at Nature's Powerhouse.

It was unanimously agreed that a letter be sent to Council expressing the Chamber's concerns about the lack of consultation with the business community and the apparent lack of capability for the Kindred Café to deliver the services required by the Expression of Interest document.

Tourism (directional) Signage - joint project with CSC

It was agreed that a review of signage, including online and mapping, is required for the Cooktown region. A review of previous studies is to be undertaken and a project brief prepared by CSC. CCCT is to assist and provide advice when requested

CYSF/Tourism Cape York

It is believed that Council has requested a meeting with the CYSF Board on 16 Jan 2017. It was agreed that the Chamber should also request a meeting with the Board on that date and that the CCCT Management Committee meet on the 11 January to determine expectations of TCY as the LTO

Consumer Shows

Gary K advised that Council will be investigating participating in up to four consumer shows in regional Queensland that are seen as vital source markets. CCCT may consider participating in these shows and reduce the number of shows attended by Pro-Active Marketing on behalf of CCCT

General Business
