Luke Johnson led a brief discussion on the lowest ranking priority items and proposed that they be removed from the official MRC platform and the remaining items become non-priority platform items. MRC members discussed and debated these items.

Paul Gerde made a motion to remove the Death Penalty, SWCD Funding, and Rural Crime from the MRC platform. Second by Bob Kopitzke. Motion adopted.

7. 2023 Meeting Dates

Luke Johnson reminded members that they have a new handout that includes locations for the January and October, 2023 meetings. No action was taken.

8. 2023 MRC Delegates and Invoices
