#### **CITY CONTROLLER BROOKS REPORT:**

Councilman Geyer instructed Controller Brooks to remove the Police Pension Drop Plan from the General Fund Assets. Geyer noted according to the City auditor, it is no longer a General Fund asset. He added it should be put with the Pension Fund because it is not cash for the City to utilize.
