NCAP Standard Operating Procedures Swim Lesson Program: Fall 2021 -Version 1, August 12th, 2021-

American University

• PPE requirements:

- 1. All staff will wear masks at all times while in the facility.
- 2. All instructors will wear face protection during lesson instruction.
- 3. All swimmers will wear masks when entering and exiting the facility, and while on deck until such time as they are instructed to put their masks in their designated basket.
 - a. Exceptions will be made for swimmers with conditions that prohibit them from wearing a mask pending medical documentation.
- 4. All NCAP staff are required to have hand sanitizer & cleaning products available.

Facility procedures:

- 1. There will be a separate entrance/exit for NCAP families allowing swimmers to enter directly onto the pool deck.
 - a. NCAP members will not be permitted to enter through Bender Arena.
- 2. Locker rooms will be limited to emergency restroom use only.
- 3. The facility will be cleaned daily following all lessons.
- 4. Parents are required to take swimmer's temperature prior to coming to lessons.
 - a. Swimmers with a temperature of 100.4 degrees or more should stay home and will not be permitted to attend their lesson.

• Athlete/family protocol:

- 1. Swimmers must arrive and depart in their swimsuit.
 - a. Swimmers will not be able to utilize the locker rooms at the facility.
- 2. Swimmers will not be permitted to enter the facility until 5 minutes before their lesson start time.
 - a. If they arrive early, they should wait in their car until the appropriate time to enter the facility.
- 3. <u>Parents/spectators will not be allowed to watch lessons</u>. Swimmers must be able to separate from their caretakers for the duration of their lesson.
 - a. We will have additional staff to greet families at the entrance and then escort the swimmer to their class.
 - b. Exceptions to this policy will be made for the swimmer's first class, so parents may escort their child to the pool and meet the instructor.

Please note: Parents will not be able to stay and watch the lesson.

- 4. Criteria that must be met by swimmers and anyone residing in their household to be eligible to attend swimming lessons:
 - a. No contact with anyone who has tested positive for COVID-19 in the last 10 days.
 - b. Has not had a temperature over 100.4 degrees, a cough or difficulty breathing in the last 10 days.
- 5. Any athlete or staff member experiencing any symptoms of a fever, recent cough, unusual fatigue,

headache or has had any exposure to someone who has any symptoms should remain at home and seek medical treatment.

- a. If any swimmer or staff member has a fever or symptoms of illness<u>es</u>, they may not attend lessons until cleared by a medical professional.
- b. Swimmers and staff must see a physician and be cleared for work & lessons after being diagnosed or suspected to have COVID-19.

• Covid-19 Exposure and Positive Test Procedure:

NCAP considers anyone as having "close contact" or possibly exposed if they were within 6 feet of an infected person (masked or unmasked), 2 days before illness onset (or, for asymptomatic patients, 2 days prior to test specimen collection) until the time the person is isolated.

- Family MUST keep their athlete(s) out of lessons **and** notify NCAP immediately in all circumstances listed below. NCAP will contact trace and confirm what NCAP members have been potentially exposed, as defined by the CDC (see above).
- 1. A member of a swimmer or staff member's immediate household is exposed to COVID-19:
 - a. The member can wait 5 days from exposure to get tested and receive negative results OR
 - b. The swimmer or staff member must quarantine for at least 10 days after the date of exposure.
- 2. A member of a swimmer or staff member's immediate household tests positive for COVID-19:
 - a. The swimmer or staff member must quarantine for 10 days and isolate themselves from the members of their household to the best of their ability.
 - b. The swimmer or staff member must receive a negative test result no sooner than 48 hours prior to the return to lessons. *Approved test date will be confirmed by NCAP*.
- 3. A swimmer or staff member is exposed to COVID-19 from someone outside of their household:
 - a. The swimmer or staff member must quarantine for 10 days OR
 - b. The swimmer or staff member must get tested 5 days from the exposure and provide NCAP with documentation showing a negative test result.
- 4. A swimmer or staff member tests positive for COVID-19:
 - a. The swimmer or staff member must quarantine for 10-14 days.
 - b. NCAP will email all families registered at the same time slot to let them know a member tested positive for COVID-19.
 - i. NCAP will then complete the contact tracing process and follow up with families whose swimmer is considered a close contact based on the definition above.
 - ii. Anyone that has been identified as exposed has two options to return to lessons:
 - 1. The swimmer or staff member must wait 5 days from exposure to get tested and provide negative results to NCAP $\rm OR$
 - 2. The swimmer or staff member must quarantine for 10 days after the date of exposure and may return if they have not experienced any symptoms.
