No partnership is created hereunder between Contractor, Forester, and/or Owner.

Contractor is required to name Owner and Heritage Habitat & Forestry, LLC as additionally insured on Purchaser’s General Liability Insurance Policy with minimum coverage of \$1,000,000 prior to the start and for the duration of operations. General Liability and Worker’s Comp. are required upon finalization of Contract #0001-PM.
