Norfolk Convention & Reunion

Day One — Wednesday dawned to a rainy, dreary day. Spirits were high and the renewal of old acquaintances began. Soon it was time to depart for the first tour — USCG Support Center in Portsmouth, Va. The crew was composed of two bus loads of rubberneckers. The base provided tour guides and split up the crew into three parties.

One group went aboard the vessels while another had lunch and visited the base exchange, and the third paid a call on the buoy depot. The groups rotated until it was time to return to the hotel and, except for the rain, a good time was had by all. The guides

were friendly and knowledgable, the galley food was delicious, and the base Commanding Officer, CAPT Weaver, was a perfect host.

Upon our return to the hotel, preparations were well underway for the Opening Ceremony. Jane Maxwell and Nancy Burke were busy making up the food that the CGCVA Auxiliary had graciously donated. The Atlantic Fleet band arrived, set up and began playing some up tempo music.

Ceremonies began as everyone was called to order. Al Grantham and the 5th Coast Guard District Commander, RADM William Ecker, were escorted to the platform with the band extending honors. The USCG Training Center Yorktown Color Guard, clad in Revolutionary War-period uniforms, presented the colors.

The band played the National Anthem and Ed Burke made a toast to the flag, followed by the Pledge of Allegiance, led by Edith Courter.

It was a pleasure meeting many of our members at the Norfolk Reunion and an honor to be elected National vice-resident. In this capacity I am committed to promoting our association, researching our history, and doing my part to pass it on to future generations.

On the weekend following our convention, I traveled to New London, Ct. to visit the Coast Guard Academy Museum. It is rich in history and I highly recommend you visit also. On display are Greenland Patrol, Atlantic and Pacific Invasion, and Vietnam artifacts. The museum adjoins the Academy library. I walked down the rows of bookshelves and was pleased to see our history well preserved. For museum hours, call (203) 444-8511.

I recently visited the Intrepid Air-Sea Museum in Manhatten and was disappointed with the almost nonexistence of the Coast Guard in the World War II exhibits. The museum is quite large, consisting of several ships, including the aircraft carrier Intrepid and the CGC Tamaroa. There's several aircraft on the carrier's flight deck, including Coast Guard "Albatross" fixed-wing and "Sea Guard" rotary-wing aircraft. On the hangar deck are numerous display cases containing artifacts from the Atlantic & Pacific theaters and a full scale mock-up of the Normandy Invasion, complete with landing craft, but alas, no Coast

Guard! I contacted John Stamford, our Northeast Membership Rep. and proposed a meeting with the Intrepid Museum director. John has several friends there and a meeting is in the works to propose a Coast Guard display that we would maintain. The museum is open year-round and takes several hours to tour.

In the Dec. '94 issue of the Naval Institute magazine, Naval History, there appeared an article about the Nantucket Life Saving Museum. Coast Guardsman Bob Caldwell, WWII CGC Spencer crewman and native Islander, donated the land for the museum and his large collection of srtifacts to get it started. I spoke with Bob and will send him a membership application, along with a copy of The Quarterdeck Log. The museum is open from June 15 through Sept. The phone there is (508) 228-1885.

Secretary's Notes

First I want to say that I am very proud to be your National Secretary for the next two years. I will try to continue doing the job to your satisfaction, however, there is one official task I have that will probably get about 275 of you mad at me — that of providing support documentation to substantiate that you are a Coast Guard combat veteran.

As I keep saying, this is a requirement of our By-Laws and the IRS could revoke our tax exempt status if we are not in compliance with the rules they set down when they granted us that status. Simply writing a detailed accounting of your service on the reverse of the application form does not qualify as support documents. I have accepted everything from a copy of your discharge (DD-214), medal awards letters, pages from a ship's log where

the member had signed as OOD, even a statement from a member in good standing that he served with the applicant. There are a number of ways to satisfy this requirement but arguing with me about it isn't one of them. So please, protect our tax exempt status by providing something for our files if you haven't already done so.

Membership

Congratulations to each and every member of the CGCVA — you truly getting the word out about our fine organization. Although I never served there, I strongly resented the implications and seemingly total lack of awareness about our Service in Vietnam.

Well, we (the Coast Guard and our fine organization) have come a long way toward getting the word out about Coast Guard combat veterans. But we still have a lot more to do and, by the time you read this, our membership drive

will be in high gear. We plan on a nationwide drive to reach all the Coast Guard combat veterans out there just waiting to be found so that they can get together with another fellow Coast Guardsman.

Award May Qualify Many For CGCVA Membership

At a White House awards ceremony Dec. 22nd, President Clinton presented the Armed Forces Expeditionary Medal (AFEM) to one member of each branch of the Armed Forces, they representing those members

of their respective services who served in or directly supported Operation Uphold Democracy. The stablished opening date is Sept. 16, 1994 with no closing date set.

The AFEM was established in 1958 and has been awarded for 22 different operations, the last being Operation Restore Hope in Somalia. Criteria for the award requires that U.S. Armed Forces must have participated in a military operation in significant numbers and that those forces either encountered foreign armed opposition or otherwise were placed in such a position that hostile action by foreign armed forces could have been imminent, even though it did not occur.

There were numerous Coast Guard units involved directly and indirectly with Operation Uphold Democracy and, if these units are approved for the AFEM, it could mean that all personnel receiving the award would be eligible to join the Coast Guard Combat Veterans Association. The VFW has already confirmed that personnel awarded the AFEM for Operation Uphold Democracy would be eligible to join that organization. This could certainly result in many new members and perhaps even entire units joining the CGCVA.

New Membership & Information Forms

An updated Membership Application Form and General Information Sheet for the CGCVA are included in this issue of The Quarterdeck Log. Please clip them out, make additional copies as needed, and use them to sign-up new members. Also, discard any previous versions of these forms. And don't forget to stress to potential new members the importance of providing verifying documentation along with their application for membership — without that their application can't even be processed.

Posting New Members

Many of you have indicated that you miss the listing of new members with information on their units. Hopefully, this will soon be again included in *The Quarterdeck Log*.

We now have in place six new area membership chairmen, so if you would rather not get directly involved with the paperwork or logistics involved with recruiting, refer the applicant to the appropriate chairman or myself. During WWII we used to say that if we carried an oar on our shoulder and started walking inland, that we would settle down as soon as the first person said, "What's that thing?" Well, maybe you'll find a potential member in that location. At any rate, let's go find that lost shipmate and get him signed up today!

To help you out, here's some examples of the official standard forms of documentation that may accompany an application for membership:

- USCG Honorable Discharge (copy of both sides).
- NAVPERS 1650/65 showing awards and decorations that you are entitled to.
- NAVCG-533 Notice of Separation from the U.S. Naval Service - Coast Guard.
- DD-214 Report of Separation from the Armed Forces of the U.S. (Be sure it indicates your awards earned).
- An official document, letterhead or page from Service Record with signature.










Throughout the Reunion/Convention, members were able to see memorabilia of the Coast Guard wartime experiences through various medium.



A Final Farewell

The below news story documents two who never arrived at our Norfolk Reunion but had intended to. May they rest in peace!

Couple's reunion after 50 years ends in death

QUANTICO, Va. — They met in 1944 and fell in love, but she turned down his proposal and they soon lost track of each other.

This year, they reignited their friendship.

This week, they lost their lives together on a busy highway.

Paul Lester Flanagan and Dorothy Thompson had just finished eating pizza and were walking back to their hotel Wednesday when they were struck while crossing a seven-lane stretch of Route 1.

He was pronounced dead at the scene; she died at a hospital a short time later. Flanagan, 71, was from San Jose, Calif.; Thompson, 69, was from Owensboro, Ky.

The pizza dinner marked the Soyear anniversary of Flanagan's marriage proposal to Thompson, said Lisa Rihn, Thompson's daughter. Thompson had turned him down, saying she was too young and he was going overseas the next day with his Coast Guard unit.

The two had dated for two years after meeting at a USO dance. Flanagan and Thompson had vowed to look each other up after the war, but didn't speak again until they began exchanging letters earlier this year. She was widowed in 1987; he was divorced.

They decided to meet in Pittsburgh earlier this month, visit Civil War sites along the East Coast, then attend the 50-year reunion of Flanagan's Coast Guard class.

Rihn said she spoke to her mother on the telephone Monday, and the

reunited friends were enjoying their trip. "To put it plainly, you couldn't understand a word she was saying because she was giggling so much," Rihn said yesterday. "I talked to Paul, too, and he said he lost his Dottie 50 years ago, and he wasn't going to let her go now."

Rihn said her mother had shown her old photos of Flanagan when she was growing up. "There was just a special bond she had with him," she said.

The couple had traveled to Stafford from Gettysburg, Pa., in a rental car and were going to see Manassas National Battlefield Park, said Michael Thompson, her son. He said his mother planned to introduce him to Flanagan on Thursday.

"She called my two sisters and told them she was having a great time, really enjoying herself," Thompson said. "This is just a real tragedy."

Before the accident, the couple checked into the Days Inn Aquia-Quantico and walked across Route 1 to Pizza Hut. They were celebrating Flanagan's birthday.

After dinner, at 8:50 p.m., they tried to make their way across the road to return to the hotel, said David Good, a Virginia trooper.

Troopers said the driver was not speeding and had no warning when the couple stepped into the path of her car. She was not charged.

"This is one of the worst, if not the worst, crashes I've ever investigated," said Good, "They died terrible deaths."

COAST GUARD COMBAT VETERANS ASSOCIATION CONSTITUTION AND BY-LAWS

PREAMBLE

Being mindful of the traditions, duties and purposes of the United States Coast Guard, our day to uphold and defend the Constitution of the United States of America and believing that through social association and mutual acquaintance, we may further perpetuate the memory of our fallon comrades, assist their widows and orphans, assist honorably discharged and retired Coast Guard Combat Veterans, premote and enhance the image and posture of the United States Coast Guard. Therefore, we do associate ourselves together and declare the following Articles to be the constitution and By-Laws of the Coast Guard Combat Veterans Association.

CONSTITUTION

We, past and present Officer and Balisted members of the United States Coast Guard believing in our right to Form an Association consistent with the precepts outlined believing in the Presentis above, do hereby declare the formation of such an association to be known as the "Coast Guard Combat Veterans Association".

BY-LAWS

ARTICLE I-Organization

This Association formed under the authority of the foregoing Constitution will be organized as provided hereinafter. That all meetings including the biennial meeting will be conducted in accordance with ROBERTS Rules Of Order.

- 1. Name: This Association shall be called the "Coast Guard Combat
- Veterans Association".

 2. Purpose: The primary purpose of Association shall be to foster good fellowship and social activities. We further assume the responsibility for maintaining the gravesite of Signalman First Class. Douglas A Munro, USCG First Class.

Honor, located at Cle Elum, Washington and to accomplish the programs as outlined in the Preamble.

3. Association officers: The Association shall be governed by a Prenident. Vice President: Secretary, Treasurer, and an eletted Board of Directors consisting of five (5) regular to be a member of the Association.

4. Term of Office: Offices shall be nominated and elected for a two (2) year term in office at each regular biennial meeting of the membership.

- e. In cooperation with the Secretary, maintain records of Association property with a description and location of all items.
- f. Provide a biennial financial statement to be audited and presented at the membership business meeting by a committee appointed by the Chairman of the Board of Directors.

5. Board of Directors:

- The Board shall consist of not less than five (5) members
- b. Of the four (4) elected Board Members, two (2) shall be elected to a Four (4) year term at each reunion conventor. The members of the board will select a chairman of the board from their elected body for a two year period. There will be no succession rule for the Chairman.
- c. The fifth (5) member of the Board shall be the seating of the immediate Past President replacing the prior Past President.
- d. The Board shall direct the President as to the time and place to convene the Reunion/Convention.
- e. The Board of Directors shall meet at the discretion of the Chairman. These meetings may be person to person, via telephone conference or by correspondence.
- f. Approve expenditures of Two-Thousand dollars (\$2,000.00) or more.
 g. Review and if acceptable Approve the annual Budget of the Association.

ARTICLE V-Committees

- Standing committees shall be appointed by the President but shall not exceed the tenure of the President's term in office.
- The Chairperson of all committees shall be designated by the President.
 The Chairperson shall appoint members to serve on the committee.

ARTICLE VI-Voting

 Regular members, in good standing, in attendance at properly assembled Association Reunion/Conventions shall be eligible to vote on matters limited to Association business.

ARTICLE VII-Changes And Corrections

- 1. Changes: A request for change in the By-Laws may be submitted by any member in good standing. Requests for changes must be submitted to the Board of Directors at least six (6) months prior to a regularly scheduled reunion/convention. A change is defined as any alteration that materially affects the intent and/or meaning of the Article being considered.
- Corrections: A request for correction to the By-Laws that change neither the meaning nor the intent of the Article under consideration.
- 3. Procedures:
- a. Corrections as defined above shall be considered by the Association officers. Notice of such corrections will be presented and read to the membership at the next regularly

"Show of Hand". The newly elected officers and appointees shall be aworn into office at ceremonies during the banquet held on the final evening of the reunion/convention. The offices of the President and Vice President shall not be succeeded by the same person more than one (1) time. The offices of the Secretary and Treasurer due to the necessity of a consistent continuance of record management for the Association may be succeeded by the person duly nominated and elected by the membership without limitation to the succession rule above. The offices of the Board Members are covered in Article IV,5. below. In the event of a vacancy of any office or Directorship caused by resignation; illness, death or removal for "cause", a replacement shall be selected to serve in the vacated position until the next regularly scheduled meeting of the membership. The selection shall be made by a committee appointed by the President.

- S. Auxiliary: Effective 16 July 1988, there shall be an Auxiliary providing for the membership of spouses of members in good standing. Such Auxiliary to provide their own Organization and By-Laws shall not conflict with the Constitution and By-Laws of the Association.
- 6. Headquarters: There is no permanent Headquarters site or location. The President shall designate a Headquarters location. Administrative office(s) shall be designated by the President and will in most instances be the residence of the Secretary or Treasurer or both as needs predicate.

ARTICLE II-Membership

Membership in this Association shall be limited to:

- Active duty members, retired members and honorably discharged former members of the United States Coast Guard or United States Coast Guard Reserve who served in, or provided direct support to combant situations recognized by an appropriate military award while serving as a member of the United States Coast Guard.
- The Widow or Widower of those listed in 1. above shall be considered members and shall be dues free without voting privilege. These members shall not hold office.
- The Commandant of the United States Coast Guard and the Master Chief Petty Officer of the United States Coast Guard if not otherwise eligible shall be recognized as Honorary Members without voting privilege.
- 4. The President, with the consent of the Board of Directors, may authorize additional Honorary Membership without voting privilege to any person who has performed in an "Outstanding" manner for the betterment of either the United States Coast Guard or the Association. Such Honorary Membership will be accomplished by the issuing of a Certificate of Appreciation and Honorary Membership suitable for framing. Any member in good standing may make a recommendation to the President for an Honorary Membership. recommendation shall be in writing and accompanied with supporting information substantiating individual's qualifications.

Four Chaplains Services

Remembrance services and ceremonies are held across the country during February to honor and remember the Four Chaplains who laost their lives after giving up their life preservers to four soldiers of the *USAT Dorchester*, which was sunk Feb. 3, 1943 off Greenland.

The Dorchester was part of a convoy being escorted by the USCGC's Comanche, Escanaba and Tampa when it was torpedoed by a German U-boat. The Tampa proceeded on to Greenland with the convoy while the Comanche and Escanaba picked up 93 of the 133 survivors, eight of them Coast Guardsmen, while 26 Coasties were lost.

The Coast Gaurd is generally recognized at services for the Four Chaplains so it is an opportunity for CGCVA members to proudly wear their caps and lapel pins.

Let's Go Shopping

World War II veterans have the authority by the U.S. Army, Air Force and Coast Guard to shop and purchase certain items at those service's Military Clothing Sales Stores. Items include service medals, ribbons and campaign hats. To secure this special privilege, veterans must obtain the approval of the specific base commander in order to shop in the base's store. Veterans should be prepared to provide a copy of their Discharge Certificate (DD Form 214) and a list of specific desired uniform items for purchase.

USCGC Citrus Decommissioned

After nearly 52 years service, the USCGC Citrus (WMEC-300), was decommissioned at ceremonies at Coos Bay, Oregon.

Built at Marine Iron & Shipbuilding Corp., Duluth, Minn., the 180-foot buoy tender was launched on Aug. 15, 1942 and commissioned May 30, 1943. The Citrus was originally used for general aids to navigation and icebreaking duty on the Great Lakes, homeported in Detroit. The cutter served on the Greenland Patrol during WWII but spent most of its service life in Alaskan waters.

After repairs in 1982, the Citrus took on patrol, search and rescue, and law enforcement duties, stationed in Coos Bay until its retirement.

United States/Coast Guard First



At 0800 EDT, 22 August 1994, the Coast Guard cutter Polar Sea (WAGB-11) became the first United States surface vessel to reach "0" degrees North latitude — The North Pole. The 399-foot polar

breaker was in company with the Canadian icebreaker Louis S. St. Laurent. The feat was achieved during a joint U.S.-Canadian multidisciplinary scirntific study.

Granite Markers Now Available

Veterans and their families now have a choice of either granite or marble when applying for a traditional, upright headstone to mark a veteran's grave. Initially, granite headstone markers will be available only to mark veterans' graves in private or state-run veterans cemeteries. The granite stones will be the same size as the marble headstones and their weights will be comparable. The granite used will be light gray in color, the same as the flat granite markers now available.

Spousal & Dependent Burial Costs

Many veterans and their families have falsely concluded that interment of veterans' eligible dependents in state veterans cemeteries is free of charge. Be aware that state cemeteries differ from National Cemeteries.

While many state veteran cemeteries are co-developed by cost sharing between individual states and the Dept. of Veteran Affairs, eligibility criteria and the determination of related costs for interment of dependents is the responsibility of each state. There are no nationally set policies or costs for such interments.

Some states do not allow burial of individuals other than veterans in their designated state veteran cemeteries. Other states prohibit the interment of eligible dependents prior to the death of the veteran.

Costs for eligible dependent interment are determined legislatively in each state. Currently, there are 48 state veteran cemeteries located in 24 states. Your local funeral director can advise you on the availability of a state veteran cemetery, its eligibility requirements and related costs for eligible dependents.
