

Dear President of the ADL of France,  
Dear ADL members around the world.

Report on: Reserve Fund for rice seed collected for emergency situations, as well as funds to support the animal breeding for the population from the year 2018, which not has arrived among the population.

For the above-mentioned fund, there is a rule that it is intended for those who work directly with the harvesters in the villages so that they can access them in emergency situations. The rule is as follows:

- 1.1 The Reserve Fund is there to buy rice for people in need in 47 poor cities, from the stocks of other municipalities. This rice is intended for harvest and seeders used in the village by the population. The amount of collected rice must be accurately recorded, as well as the quantities delivered. In doing so, a committee of the city should work together in the emergency situations concerned.
- 1.2 In addition, the Fund should be used to support animal breeding. It is also in support of the rice paddy season, planting vegetables such as peppers, cucumbers, and other vegetables, which is used daily by the population. The fund will also be used to support plant breeders in the Champassak province, such as coffee plantations and the like. In the case of animal breeders of cows, pigs, chickens, sheep and ducks, the fund serves to improve the quality of life.
- 1.3 The Fund is mainly financed by the *Asia Development Bank (ADB)*, other financiers are: *UNO*, *World Food Organization ONUAA* and others. The fund is first handed over to the prime minister's office, after which the president's office draws up a plan and then sends it to the vice-minister's office, which is responsible for the economy. This is currently *Mr. Sonexay Siphandone*. The fund then moves to the central bank of Laos, which in turn transfers the money to the Bank for Development. The money must be proven to reach the population who are in need.
- 1.4 In reality, however, these protocols are falsified by the government. The falsified logs are then transmitted to the ADB, as well as to the donor countries and organizations. After that, the money is distributed by the government to its cadres. The amount of the above funds is over five thousand billion (Kip?)

Special features: The money receivers are usually great entrepreneurs who are well known to the Government and together with the Government of which get a good profit. It's the following persons:

1. *Mr. Sichantha Thammavong*, he is the son of *Mr. Thongsing Thammavong* the former Prime Minister of the Lao PDR currently in the authority worked in Ministry of planning and investment.
2. *Company Khamphayxana*, contractors and other companies.
3. *Company Bothong inter*, Construction Company.
4. *Mr. Kamboun*, former head of the provincial of the province of Salavanh
