Proof of Notice having been furnished, the Public Hearing on the 2023 Preliminary Budget was called to order at 6:00pm. Supervisor Thompson asked all to stand for the Pledge of Allegiance.

Supervisor Thompson asked if anyone wanted the Budget read line by line, all board members and attendees declined. Supervisor Thompson then asked if anyone wanted to speak in favor of or against the 2023 Preliminary Budget.

Several board members disagreed with Councilperson Conklin's interpretation of the Opinion.

Total to be raised by Taxes is \$432,220.87 which is a 0.805% increase. Roll Call taken: Thompson - Aye; Weale - No; Conklin - No; Lyons - Aye, and Trappler - Aye. Motion Adopted 3-2.

Motion by Councilperson Trappler, seconded by Councilperson Lyons, that the meeting be adjourned at 6:16pm, and next scheduled meeting is Monday, November 21, 2022 7:00pm at the Town Hall.
