

### **Release of Liability Agreement**

In consideration of being permitted to participate in the Summer Science & Sports camp sponsored by (CHESSIE) at (Calvary Chapel, Charlottesville) 1284 Sunset Avenue Ext Charlottesville, VA 22903-7862, or at Azalea Park off Old Lynchburg Rd, Charlottesville, VA 22902 for the week of June 6-10 or June 20-24, 2022.

[hereinafter referred to as "family" agree to the following:

1. Release, covenant not to sue, waive, and discharge, Kathy Pierson and her employees, or other families participating in the CHESSIE camp classes (hereinafter referred to as "Releasees"), and the Calvary Chapel Charlottesville Church officers, staff, and members from all liability for any loss or damage and any claim or damage on account of injury to the person or property or resulting in death of a Family member while Family is participating in the CHESSIE camp activities or any other activities on the premises of Calvary Chapel Charlottesville Church (1284 Sunset Ave Ext, Charlottesville) or Azalea Park (on Old Lynchburg Rd., Charlottesville, VA 22902).
2. Family agrees to indemnify Releasees from any loss, liability, damage or cost Releasees may incur due to the presence of Family in or on the premises of Calvary Chapel Charlottesville Church. Family realizes transportation to and from Calvary Chapel Charlottesville Church or any time off campus is the Family responsibility.
3. Family assumes full responsibility for risk of bodily injury, death or property damage while in or on the premises of 1284 Sunset Avenue Ext Charlottesville, VA 22903-7862, and/or while working for any purpose or participating in the CHESSIE camp activities.
4. Family expressly agrees that this release waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Virginia and that, if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
5. Family, in consideration of being permitted to participate in CHESSIE camp for Family, and Family's heirs, executors, administrators, and assigns, releases and forever discharges all Releasees, and their heirs, administrators, and executors of and from any and every claim, demand, action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death or property damage during participation in the CHESSIE camp or any activities in connection with CHESSIE.
6. Family states that both Mother and Father of Family have carefully read the above release and know the contents of the release and sign this release as Family's own free act.
7. Family releases all officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered Family during participation in CHESSIE camp.
8. CHESSIE camp classes operate under Biblical guidelines and believes that the Bible commands us to make every effort to live in peace and to resolve disputes with each other in private or within the Christian church (Matthew 18:15-20; I Corinthians 6:1-8). Therefore, the parties agree that any claim or dispute arising from or related to this agreement shall be settled by biblically-based mediation according to Biblical conduct. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement or any dispute arising out of any activities or events associated with CHESSIE camp Classes and expressly waive their right to file a lawsuit in any civil court against one another or against another CHESSIE camp family for such disputes, except to enforce an arbitration decision.
9. This agreement shall be binding on each member of the Family, their personal representatives, assigns, heirs, and next of kin.
10. This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.
