Featured Grant

The following is just one example of how our foundation gives back to the students in the community.

"Inspiring Innovation Through the Use of 21st Century Technology: Fab Lab"

John Maresh and Jennifer Reinhardt at Prior Lake High School were recently awarded this grant.

Summary of the grant request

Students will learn to identify needs in their community and invent solutions by developing designs and creating products utilizing technology, software, and 21st Century manufacturing processes. Students will also learn business/entrepreneurial aspects of running a business by applying business skills and strategies to market the products to consumers. The funding from this grant would be used to acquire a new vinyl printer and cutter.

Intent of the project and the impact or effect on the community it serves

Students will gain "real world" experiences as they learn to use 21st Century manufacturing processes that are used in the business world. Students will gain business skills as they identify needs, develop products, and market the goods. As more manufacturing is being brought back to the United States by major corporations, our students will gain insight into the skills, knowledge and attitudes that a company, like 3-M, is looking for in its new manufacturing employees. Students will also gain insight into careers through our collaboration with the University of Minnesota as a part of this project.

The vinyl cutter that would be acquired with these grant monies would be used to produce vinyl graphics like those seen on the sides of athletic helmets, "PL' window clings, and similar items. This device can also print posters 20" wide and up to 12" in length for clubs, organizations and other district departments.

The Fab Lab opened at Prior Lake High School with an inaugural class of 28 students. The name of the course is Build, Design and Sell: Innovations, Inc.
