Dear BWWGA Members,

As our golf season is soon coming to an end I would like to communicate with you a summary of the 2020 season and inform you of current news and tentative plans for 2021.

As you all know the 2020 golf season was greatly affected by the COVID virus and its impact altered our routines and complicated our lives in ways we never thought possible.

Please note that due to the restrictions imposed by the State of Maryland, the BWWGA committee has decided to cancel the Annual General Meeting and luncheon, scheduled for Sunday, November 8th.

This letter and its attachments will serve as a substitute to our Annual General Meeting.

Annual Program

In 2020 the BWWGA Committee met monthly, often outdoors, masked and safely distanced to plan and adapt the 2020 BWWGA calendar. Once golf course closure restrictions were lifted we were able to reschedule and resume playing some of our favorite tournaments. Time, COVID restrictions, and competition for available dates forced cancelations of more than half of our other 2020 activities including meetings, luncheons, the Member Guest, and a host of other tournaments. Because of all these extenuating circumstances, the committee unanimously agreed that the BWWGA 2021 annual membership fee would be waived next Spring. You will therefore not be billed next March. We anticipate a return to normal golf activities next year and are planning a full

schedule of events. We ask for your patience and flexibility should current conditions persist.

The committee also decided to cancel all of the end-of-year awards as the season was shortened by COVID.

The terms of four of our committee members (Sue Edwards, Youky Kwon, Laura Chen, and Christine Ebrahimzadeh) will expire in November. We thank them for their service and dedication.

The committee decided to decrease the committee size and therefore will only replace two of the outgoing members - with approval of the revised by-laws attached to this letter.
