You must submit the following with your application:

- If the person who provides your eligibility is alive, they must be a member of The American Legion, eligibility documentation is likely not necessary; however you do need to provide his or her American Legion member ID number and Post information on your application. If they are not currently a member, please speak to someone to find out how they can become a member.
- 2. If the person who provides your eligibility is deceased, acceptable eligibility documents include:
 - a. DD-214 Discharge Papers (not issued until after the Korean War)
 - b. Official Military Orders
 - c. Official Military Service Citations/Awards
 - d. Letters related to the veteran's military service. Must be on official government letterhead
 - e. Certificate from the VA records center in St. Louis
 - f. Data from the back of older discharges
- 3. <u>If you are a female veteran</u>, and fall within the eligibility dates of the American Legion, you can also be a member of the Auxiliary. Your husband is also eligible to become an Auxiliary member as well.

Once your application has been reviewed and accepted, you will be submitted for approval at the next General Meeting of the American Legion Auxiliary Unit 490.

Meetings are held on the 2nd Wednesday of the month at 6:30 p.m.

At that time you will receive your temporary membership card. Once your dues have been processed through the ALA Department of Texas, you will be assigned a membership number.
