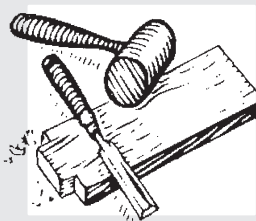

The Corner Garden

Merry Christmas!

- If rainfall amounts are high and temperatures are mild watch for brown patch fungus disease in lawns.
- Have soil tested for a Spring lawn or garden. Testing every 3 to 4 years usually is enough to tell if lime is needed.
- This sample will give an overall view of what your lawn or garden needs.
- Late December is the ideal time to begin transplanting plants if the weather has turned cool. If there has not been cold weather, do not begin transplanting until the plants are dormant.
- Prune roots 4 to 6 weeks before digging by severing roots with a spade just inside the root ball to generate new root hairs and reduce transplant shock.
- Vegetables to plant now: Beets, broccoli, cabbage, carrots, Chinese cabbage, bulbing onions, bunching onions, and radishes.
- Annuals to plant now: Carnations, digitalis, pansies, petunias, shasta daisies, and snapdragons.

St. Augustine Shores Service Corporation Board Meeting

November 13, 2014

The St. Augustine Shores Service Corporation's Board of Directors meeting was called to order at 7:00 P.M. and a quorum established.

Minutes of the October 9, 2014 meeting were presented and approved.

Treasurer's report showed solid financials with \$397,117 in operating and \$520,153 in reserves ready to do planned substantial pool and pool bath house renovations. No assessments will be needed. The ACC report was presented showing approval of 1 Commercial Building, 2 fences, 1 patio cover, 3 pool enclosures, 3 pools, and 1 shed. 108 total approved during the year.

Managers' Report

Old Business

Pool Resurfacing Bid Presentation

The General Manager provided the Board with a copy of the specifications developed with Wet Engineering covering the basis for holding a sealed bid process for the job. The General Manager opened the sealed bids and presented quotes to the Board. After discussion about differing surfacing preparation the Board awarded the contract to Capital T Enterprises.

Revised Policy Manual Discussion

Suggested revisions:

- ServCorp Pers 052 intentionally left blank
- Accountability chart moved to ServCorp Adm/Ops 006. Downward slash inserted from Board of Directors to committees.
- ServCorp Adm/Ops 002 Accessibility Of Records. We are going to add that any requests to copy more than 10 pages will be charged a fee of \$.10 per page.
- ServCorp Adm/Ops 003 Records Retention. We will change wording in third paragraph to read: Records not specified by Florida Statute 720.303 shall be maintained no longer than the current fiscal year and we will remove the four sheet guide attached.
- ServCorp Adm/Ops 023 Deed Restriction Violation Reporting. Third sentence will read Code Enforcement violations will be introduced to the PRIDE system.
- Section B number 1 we will add (certified) after the word letter. We will add a sentence to number 1 that reads: Letter states that any noncompliance to the Deed Restriction will be corrected and the charges applied to the homeowners account.
- Section B number 2 we will add (certified) after the word letter.
- ServCorp Adm/Ops 024 Pool Policy. We will replace the text with the Rules and Regulations page as provided.
- We added Members are allowed to bring (5) house guests for free. Group rate passes can be obtained at the office for an additional 5 house guests. Special event passes will be referred to the Riverview Coordinator.
- ServCorp Adm/Ops 025 Motorized Vehicles. We added the sentence: Posted official NO TRESPASS signs being enforced.
- ServCorp Finan 001 Collections. We changed the General Managers authorization from 6 months to 12 months.

After Board discussion the Board accepted the changes to the Policy Manual as discussed.

Pool Bath House Project update

The General Manager presented an Architectural Rendition of the proposed renovation to the pool bath houses. The Board instructed the General Manager to have the Architect prepare a materials list for bidding the job.

Riverview Facility Curbing Project Status

The General Manager indicated pavers were installed on top of concrete in flagpole area of Center Island.

Landscape Project Deltona Billing

An invoice has submitted to Deltona Corporation for financial contribution from Tony Gram as requested.

New Business

ACC Personnel Replacement:

The Board confirmed appointment of Richard Nowell to the ACC Committee to fill a vacancy.

Bookkeeper Function Project

The General Manager informed the Board of the current status of the Bookkeeper position, which has been expanded to better utilize new software as recommended by the auditors in their recent report.

Discuss Fence Issues Relative to Possible Action

The Board was informed of two major fence issues which were referred by the ACC. Management is working on action plans.

Deed Restriction Report.

The General Manager provided a Deed Violation packet to each Board member that included the initial report of the violations, a printed copy of the entry into the Pride system, a printed copy of the follow up detail from the County Code Enforcement Department and a follow up report on violations reported in the prior month. The General Manager explained the process.

Discussion Landscaping Contract

Because of budget preparation for the 2015 - 2016 fiscal year, the Board discussed options for the General Landscaping Contract. To rebid or to renegotiate the contract currently held by J. M. Baker Company. The Board unanimously decided to renegotiate which is legal under the terms of Florida Statute 720.

Don't Become A Holiday Season Statistic

The holiday season is an exciting time of year for all families. To help ensure you and your family have a safe holiday, here are a few tips.

Look for and eliminate potential dangers from holiday lights and decorations that could lead to fires and injuries.

Each year, hospital emergency rooms treat more than 8,000 people for injuries, such as falls, cuts and shocks related to holiday lights, decorations and Christmas trees. In addition, Christmas trees are involved in about 400 fires annually, resulting in deaths, injuries and an average of more than \$15 million in property loss.

Make sure your Christmas tree is mounted on a sturdy base so children, elderly persons or family pets cannot pull it over on themselves.

Check the wiring of Christmas lights on your tree to ensure the wiring is not damaged or frayed. Many fires are caused by frayed or damaged wiring.

If you have a live, fresh cut Christmas tree in your home, place it in water or wet sand to keep it green.

When purchasing an artificial tree, look for the label "Fire Resistant." Although this label does not mean the tree won't catch fire, it does indicate the tree will resist burning and should extinguish quickly.

More than 10,000 candle-related fires occur each year. Discourage burning candles in your home and keep matches, lighters and candles away from

children.

Do not burn wrapping papers in your fireplace. A flash fire may result as wrappings ignite suddenly and burn intensely.

We know crime is everywhere. To help you be more careful, prepared and aware during this holiday season, the LAPD Crime Prevention Unit has prepared a list of do's and don't's:

Shop during daylight hours whenever possible. If you must shop at night, go with a friend or family member.


Dress casually and comfortably. Avoid wearing expensive jewelry.

Do not carry a purse or wallet, if possible. Keep cash in your front pocket.

Theft is most often a crime of opportunity - if your car looks easy to break into or steal, thieves will be drawn to it. Park your car in an area that is well-lit and near lots of people. Keep the windows rolled up and the car locked, even if it's parked at your own house. Hide valuables and recently purchased packages in your trunk.

Check Out This Year-end Financial Checklist

As 2014 draws to a close, you may want to look back on the progress you've made this past year in various areas of your life — and that certainly includes progress toward your financial goals. At the same time, you may want to make some end-of-year moves that can close out 2014 on a positive note while paving the way for a productive 2015.

Here are a few such moves to consider:

- Boost your retirement plan contributions. This actually isn't an "end-of-year" move because you have until April 15, 2015, to contribute to your Roth or Traditional IRA for the 2014 tax year. Nonetheless, the sooner you get extra dollars working for you in your IRA, the better. You can put in up to \$5,500 to your IRA (or \$6,500 if you're 50 or older) for 2014. If you are self-employed, or run a small business, you also have until April 15 to contribute to a retirement account, such as a SEP IRA or a SIMPLE plan. In addition to helping you build resources for retirement, these types of plans can offer you some tax advantages — so if you haven't established a retirement plan yet, consult with your financial and tax professionals

- Sell your "losers." If you own investments that have lost value since you purchased them, you can sell them before 2014 ends and use the tax loss to offset some capital gains you may have earned in other investments. If you don't have any capital gains, you can use up to \$3,000 of your tax losses to offset other ordinary income. And for a loss greater than \$3,000, you can "carry over" the excess and deduct it from your taxes in future years. If you still liked the investment that you sold at a loss, and you want to keep it

in your portfolio, you could repurchase it, but you'll have to wait 31 days to avoid violating the IRS' "wash sale" rules. Keep in mind that these suggestions only apply to investments held outside your employer-sponsored retirement account; you can't take a tax deduction on capital losses in a 401(k) or similar plan.

- Evaluate your 401(k) investment mix. You may be able to adjust the investment mix in your 401(k) as often as you like. So when evaluating your 401(k), make sure your holdings aren't concentrated in just a few investments, and try to determine if your portfolio is still appropriate for your risk tolerance — not too aggressive or too conservative. Also, if your plan offers a "Roth" option, consider taking advantage of it — with a Roth, you won't be able to deduct your 401(k) contributions from your taxes, but once you retire, you won't be taxed on your withdrawals.

- Review your insurance coverage. If you've experienced any changes in your life in 2014 — new spouse, new child, divorce, new job, etc. — you may need to review your life insurance coverage to make sure that it's still sufficient for your needs and that you have the correct beneficiaries in place.

By making these and other moves, you can say a fond farewell to 2014, knowing that you've done what you could to help bolster your financial position — for 2015 and beyond.

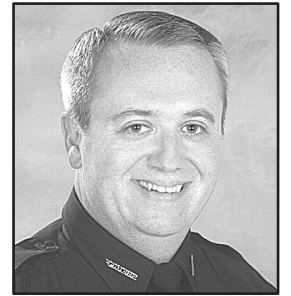

Toy Vehicle Safety Tips And Holiday Crime Prevention



We are coming up on one of the most festive times of the year for families with the celebration of several holidays. During this time, many youngsters receive motorized gifts and then don't know where they can be driven.

We in law enforcement receive many inquiries on where a child can drive a motorized scooter, 4-wheeler, or a mini-bike. The main thing for parents to be made aware of is where that child can ride. It is simple, on private property only. Any child under legal driving age is NOT permitted to drive any vehicle with an engine of any kind on county or state roads. Please keep this in mind when purchasing a motorized toy vehicle for a youngster this time of year.

Taking a look at ATV's and some important guidelines involving them. Remember that ATV's are very powerful and potentially dangerous vehicles. They can travel at speeds of over 60 mph and can weigh over 700 pounds. They can easily roll and tip over and are very unpredictable in off-road conditions. All riders should always wear a helmet when riding an ATV. According to ATVSafety.gov, about one-third of ATV-related deaths and injuries involve children. Anyone younger than 16 years of age should never be on an adult ATV. Remember to stay off paved roads and avoid unfamiliar terrain. Never carry a passenger on a single-rider ATV and never drive an ATV while under the influence of alcohol or drugs.

Now on to another subject. At this

time of year, when most people are filled with goodwill, there are criminals who relish taking advantage of it. Crime statistics always rise during the holiday season and I wish to pass along a few tips to help you avoid becoming a victim. Business experts tell us that again this year the number of people who shop online for gifts will increase dramatically and therefore so do the opportunities for those who use new technology to take advantage of unsuspecting victims. The cyber-crimes that become more popular during the holiday shopping season include fraudulent auction sites, resale of stolen or counterfeit gift cards and reshipping merchandise purchased with stolen credit cards. One of the most common internet scams involves using an auction site or classified pages to advertise an item at a bargain price. If you place an order the crook will charge your legitimate credit card for the order then use a separate stolen credit card to purchase the product and have it shipped. This could make you liable for receiving stolen goods. I recommend if you wish to purchase a gift through an auction or classified site insist on paying with a reputable third party payment service. That way your credit card number and personal information is not shared with the seller.

Most of you already know the safety tips for traditional retail shopping:

- Take your purchases to your vehicle frequently and lock them in the trunk or out-of-site.
- Carry purses with the strap going over one shoulder and the purse against your body on the opposite side.
- Carry billfolds in a side pants pocket.
- Pay by credit card or check if at all possible.
- If you must use an ATM always shield the keypad when entering your PIN and put cash away promptly in your purse or wallet.

Home burglaries are more common during the holidays and sadly the thieves target the gifts under the tree. If you are going to be away from home, leave some lights on and a radio or television to make it appear and sound as if someone (continued on page 10)

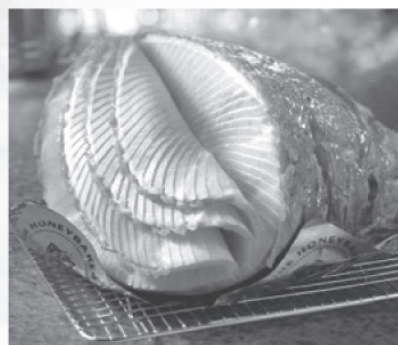

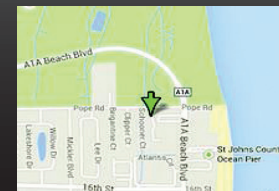
