RJ - CCTV signs, Mark

MC – I've got them

RJ – you've just got to get them to us all now to put up

MC - we could have sorted it out the other day if you had spoken to me when you came down.

RJ – you were sat in Dave's car.

JE - do the signs need to be put up have they go to be errected?

RJ - Mark can give them to the different field stewards to be put up

JE – so its agreed Mark will give them to the field stewards to be put up.

RJ – yes.

### **Discussion recorded for 2.2**

RJ – Pasqu, right Virgin Money

PDS – yes, to get the preferential rate I have to do this online, its a bit tricky but we can have a few signatories. Now when we spoke about it Russell, you said about having you, myself and Dave as signatories, is that correct?

RJ – yes if Dave is happy

PDS - Dave if you are happy I can open it up and have you as a bank signatory as well

DF – yes no problem

PDS - Ok I will proceed with that then, if you are happy for me to push the button

RJ – yes

PDS - any issues I will speak to you Russell, is that ok?

RJ – if you need a hand just give me a shout

PDS - thank you.

Shane Webster joined the meeting at this point

### Discussion recorded for 2.3

RJ – Ive started talking to people about the alarms and creating an email to advertise them found that Specification states they do not operate below zero

PC – they do

RJ – well not according to the spec

PC-, yeah according to the spec but try speaking to someone who has one of these alarms for years SW – sorry I didn't hear that last bit – heard Pam say they do work

RJ – the spec that was sent over says they don't but Pam says they do

SW – the spec does say they don't work below zero but whether they do or not in reality I don't know but that is what the spec say – that's where we are.

AVM – these are the ones that are going inside sheds, inside the main sheds

SW -Intention was to put inside a shed as cheaper without the casing – we can purchase outdoor insulated casing but they were slightly more expensive – it was agreed we would go for the ones without the casing. AVM – we can make a casing

SW – yes we can, once the casing is put on it might insulate them more so that they can operate at a lower temperature

AVM –I would have thought that once they are inside the sheds and the casing it shouldn't be a problem as its not going to go below zero should it.

RJ – the sheds go below zero.

AVM- the sheds are not the only thing Russell, they will be inside a casing inside the sheds

RJ – ours are probably going to be alright but we were going to promote them to the members to see if the members would take enough so that we could get the discount. All the wooden sheds go below zero. PC- but we have already agreed to purchase for the fields

SW – well all lve done is spoken to them to find out about the discount . I can ring them up again tomorrow to ask them if they operate below zero.

PC - I don't see what the problem is,–I bought them to the committee as they have been working well on site at Washbrook Rd and has worked successfully over many years and has saved many members lots of money. I don't understand what the hesitation is about.

I would like to reiterate that if we had put the alarms in quickly as agreed it may be the case that it would have prevented the theft of the ride on mower at HR. Because of the hesitation, we didn't and so access was granted to steal that mower.

AVM – so we are unlikely to get any more members interested if they don't work below zero –if we put them in the sheds they won't work.

RJ –we don't know what the tolerance is

AVM –I have to say Russell we seem to be making a mountain out of a mole hill on every single action item we do. We have been going backwards and forwards over this one month after month and we will continue to do so unless we say let's go ahead and then speak to the members later to see if they want to get alarms. We need to make a decision.

RJ – if we get them in and then they don't work below zero for most of the year when we are most vulnerable, then what

AVM -suggested that casings made and insulated which should keep the temperature above 0 degrees.

RJ- we can't bring them in if they don't work below zero so we can't promote them to the members

PC – but they do work Russell, its proven

RJ – we can use that to promote them the alarms

PC- they are outside, not even in a building

AVM – we are going round in the same circle again, yes get them, promote them, we can put them inside a little case to stop them going below zero, but you are saying Russell, that in sheds its going to go below zero so they wont work. Oh why do we bother.

RJ – what we need to know from the manufacturers, Shane, if the spec says they wont work below zero, what does that actually mean.

PC- this is absolutely ridiculous

AM –We've already voted to have the alarms anyway

PC – yes we did Anita

AM – so why don't we just get them then?

PC – get them then

AVM – now it looks as though we cant promote them to the members because if they don't work below zero, they wont want them, we are going round in circles yet again

AM – we can get ours and then if the members want them, they can get them after

AVM – well there is something about a discount if the members buy them

PC- we you are probably talking only pennies

DF – is it a lazer beam

PC – yes

DF- we you can power a lazer beam in space, and its pretty below zero there isn't it

PC well said

DF – I don't think temperature would affect a lazer beam

AM – we've got sensors on our plot and they work below zero

SW - what temperature does the shed go down to

PC – well put it like this, I leave water in my shed and it has holes and gaps and it never freezes, even when it snows – it never freezes.

RJ –we've had frost in the big shed

PC- yes but its not going to affect it (meaning the alarm)

AVM – so what do we need to do

RJ – just check with them Shane

PC – then we can waste another month

SW- bear in mind Russell, if I ring these guys up in Northampton, they stock millions of different alarms so they are not going to be experts on one particular brand of camera so they are going to turn round and say they may work at minus 5 or minus 7, so I think unless we are going to go into Nordic type temperatures they are going to be alright

RJ – so you knock up an email for the members starting with the price with no discount and hopefully we will get enough take up and include the fact that if we get enough of us, its going to be cheaper.

SW - what I can say if there is enough of us, there will be approximately a 10% discount

DF -how much are these cameras Shane

SW – I haven't got the file

AVM £79.95 without the sim card

RJ - £91.95 with sim card Dave

DF - well if we put one on each of the store sheds, we are not even spending 400 quid

PC - this is what we agreed last time, and that we would just order them

SW – so why don't we order 5 and get them set up in the next few days and then discuss this as a members thing at a later date when we can say we have them and have been using them in various places and that we have had no break ins

AVM – I'm not sure how many members would spend £80 odd for an alarm for an ordinary shed and how quickly would people be able to respond, but because of the expensive equipment in the corporate sheds the alarms should be put in those sheds. Dave's got some expensive kit in his shed, so we should put one in now

JL – we have a brand new mower at Highfield Rd so the quicker we put one in as a deterrent

AVM – are we saying we should put them in the field steward's sheds

MC – yes – are we really debating that we should spend 90 quid to protect a £2k mower? Its ridiculous, we have four of five of them, so why don't we just get them in.

RJ – I wasn't disputing us having them Mark I bringing up the fact about the members

PC -so I will ask the question then why we haven't got the alarms yet as it had already been agreed

AVM - we have already agreed and seem to be going round in circles

AM – asked if there needed to be a show of hands however, RJ reported that the committee had already agreed for them to go into our own sheds

RJ –who is going to ordering the alarms

PC – we decided that you are because you are the moneyman, you wont let any of us order them

RJ - Shane, do you want to go and order them

AVM – done How many do we need then

MC – We need at least 5

SW - I will order them

AM – do we need a show of hands or not

RJ – No we have already agreed to purchase for our own sheds. It was just the question around doing them for our members.

SW – how many do I order then?

AM – we need 5, Do you need to pay for them first or after you have picked them up? You'll need to sort out with Pasqu for the payment

AM –

SW – I will ask for an invoice

PDS – send me the receipt and I will pay it back to reimburse you

### Discussion recorded for 2.4.

RJ - Dave your road plainings

DF – I spoke to him last week and he said he had planings there but they needed to go through the crusher and he said when do you want them, so I said yesterday. He said he would get back to me before the end of next week which is this week now. He said he would let me know when they were done and when he can deliver them.

PC – excellent

AVM – so once you are happy they are all there, we will get back onto stablehire for the gear we need DF – absolutely, when I spoke to the bloke at Stablehire he said the little bit of equipment you want will be no problem and that we can have it whenever we want.

 $\mathsf{AVM}-\mathsf{just}$  give me a call when you need help with all that  $\mathsf{Dave}$   $\mathsf{DF}-\mathsf{OK}$ 

### **Discussion recorded for 2.6**

RJ – Pasqu, you sent out the forms didn't you

PDS – yes Ive sent out the claim forms for business miles. If you feel passionate about claiming business miles if you pick up things – its 45 pence a mile. You don't have to do it but you can if you want.

DF - when did you send the form?

PDS – about 3 to 4 weeks ago

JE – don't worry Dave, I will include with the appendices with the notes from this meeting so you've got it again

JE – Russell, have we done the spare keys or have I missed that ?

RJ – No I'm just coming to that

JE – that's alright then, its fine.

### **Discussion recorded for 2.5**

RJ – I need to meet up with Mark as the spares we have now acquired we need to get the forms for people to sign for them. Put that down for MC and RJ to do.

### **Discussion recorded for 2.7**

AVM – John how's your dog fouling JL – I haven't seen any around the field and it seems as though they are picking it up AVM – good RJ – that can come off now Jayne

### **Discussion recorded for 2.8**

RJ – the rubbish on the fence line Alan

AVM – Mark and Anita, and I had a look at all of this – issues with security because no fence as everyone could get into the area with the rubbish and into the field beyond.

AVM - the area is a cheese wedge shape from the edge of Pam's chickens all the way up to my partner next doors plot there is absolutely no fence whatsoever. There's an awful lot of rubbish, a lot of wood that can be burnt, but there is also lots of sharp metal and broken glass.

AVM –Dave has suggested fencing the area that is within the Society boundary, which would include the area with rubbish, as there is a risk of injury to anyone trying to gain access to the site by walking over the glass and metal. The rubbish is on our land. We will need a fair number of skips, 6 or a dozen.

PC – we aren't gaining much space without removing trees and stuff.

AVM – we won't remove the trees, but there is a bit of land between the back and the barbed wire fence.

AM – 8-10 feet between barbed wire and back of plots – narrower at the lower end by PC's plot.

PC- the number of kids I have to shout at as they come over the brook and straight over to my plot.

AVM – I am surprised to find at your end Pam that there is very little to stop people getting in

PC - there is nothing at all .

AM – if Mark can get in anyone can

AVM – that's what I said, and I did say to Mark that anyone, teenagers or that sort of age would have no problems getting over and into our field.

SW – is there anything valuable in there?

PC – there's a load of singer sewing machines in there behind mine

AVM – There's one thing that concerns me that we found, we don't know what exactly it is but Mark thought it was possibly asbestos shed roofing sheets. I thought that the specialist asbestos guy was supposed to have removed the asbestos from the fields a few years ago, however, this may have been missed and it looks like there may be some all the way down there.

RJ – we removed some asbestos sheets from down there, so sounds like someone has dumped some.

AM – they have been down there a long time.

AVM – we don't know for sure do we that it is asbestos but is certainly looks like it

SW - a specialist should be called in to look at this material -

PC – it may be £10-15 thousand

AVM – I don't know if it will be £10-15 thousand but it wouldn't be a bad idea for someone to look at it because if it is asbestos we need to know.

AVM – there is a lot of metal and scrap metal men might take away the metal items including window frames AM – yes the metal man will take it, there is a lot of metal window frames

AVM - its a real tip

AM – if the rubbish is cleared and the fence extended, it will be possible to extend the plots to the full extent of our land.

RJ – If it is asbestos we must get a specialist company in to remove asbestos – previously the Society had to get a company in to survey all of the fields.

AVM – we should have it checked

AM – the rubbish finishes next to the barbed wire fence that is our perimeter, so we can fence off and keep the rubbish inside, then we can clear the rubbish

SW – is it fresh rubbish

AM – not its years and years old

RJ and SW discussed if the rubbish was a fly tipping area but it was established that this was not the case

AVM –Dave told me that many many years ago, people would just take rubbish and throw it into that area. PC – I have a car bonnet on mine

AVM - Russell can we have an action and a proactive approach to check out the asbestos

RJ – we need to get someone. We paid for a survey of every site last time, but for this situation and one spot they might come and give us a quote.

AVM – but Russell, yes it is one spot but there are bits not just behind mine but behind the others

RJ – Alan what I was trying to say was there was a law change and we had to get them in to do a survey of the land and that was literally walking to see if there was any- we think we got it so we need a quote for removal AVM – can we arrange that?

JE – we had a problem in Wellingborough with asbestos and I can get the details of the firm in Higham Ferrers from Shaun

RJ – we used a company via the council from Higham Ferrers and it was probably the same.

MC –I don think its worth getting someone in to check it yet as all we are going to do is wasting someone's time, we have got 200m of fencing and we have been in 10 m of it and we have found some asbestos, so if we get someone in to look at the bits we have found and then we clear a bit and find some more and will have to get someone back again. And again when we find another bit.

AM – yes we don't know far it does down

MC- surely we get a team together to clear the area, cut the trees, cut the grass and move the rubbish and metal rubbish identify if there are any other pieces of asbestos in the area although this may require members to move some of the material and put it in a pile. MC thought it would be more sensible to clear the area fully to ensure all suspicious material is visible and then look at the asbestos in the railway carriage at Grafton Rd as well.

RJ – which we have boxed or bagged up

AVM – Is it ok to 'play around' with the stuff

RJ- no

MC - its not ok to play with it, or touch it, but it needs to be made wet so that it doesn't give off dust, and then work around it.

AM – and wear masks and gloves

MC - Its not ideal whatever we do. What Russell is proposing, is that we get someone in to look at it, so are we going to get someone in just to look at that piece?

AVM – sorry no mate, that was my suggestion

RJ – they will look at the whole fence line

MC – I don't disagree but I am just thinking

AJ – you are not touching it

AVM - as far as I can see if he sees that thing and confirms its asbestos

MC – I can confirm it is asbestos for you Alan. Its the same thing that was on shed roofs. We saw enough of it the last time when it was being cleared, its the same stuff that was on the tractor shed roof, so yes it is asbestos from the roofs. The advice given before for the roof of the sheds is to paint it to seal it, it will be ok, as long as you don't drill it or break it. It shouldn't be broken up but if you do touch it its got to be wet it can be moved, that was the advice given by the chaps that came to remove the other stuff. We could put it all in a pile and then let them move it from there. We can't leave it. It doesn't need testing it need moving,

RJ - it depends on what sort of asbestos it is

DF – I agree with that Mark

AVM – OK guys, if you agree with that , I'm quite happy to go along with that

RJ - I don't want anyone to play with the stuff we need to get a quote for its removal, the whole lot

AM – we don't know how much of it there is Russell

RJ – its for them to sort that out and then they can give us a fixed price quote

AM - are they going to walk 200m where you can't actually get in to see if there is any more

MC - Russell, they can't get in at the minute as there is too much other stuff in the way

RJ – I don't want anyone to start to play with it. It's ok if its only the stuff off shed roofs but what if there is any other types of asbestos in there.

AM – thats all there is, the corregated sheets.

MC – they won't be able to get in because of the brambles and rubbish

AM – there is only the roof sheets and they won't be able to see along the 200m if there is any more because of the rubbish and trees.

RJ - we need to see how much it will cost, have you measured the line along the fencing?

AM - will they give you a free quote?

RJ – Im going to ask to see if a survey can be done for the removal

AM – if you have to pay them to come in to have a look its not worth it until we have some more on show

AVM - you don't have to pay them to come and have a look if they want the job

AM – it's been there a lot of years

MC - this isn't new, it would have been there when they came out last time

AM – and its literally just over the fence

SW – how much was the quote last time for them to clear it

RJ- I cant remember because there were other things done.

AM – they cleared a lot from the A6

RJ - last removal was £1500-£3000 for all of the Society's fields.

AM – was it £3000 to remove it last time or something like that?

RJ – yes possibly, it was a few years ago, I know there was snow on the ground

AM - I remember them coming out as they were picking little bits up

DF – when they took that little bit in the trailer away from the guys from Higham hill took that little bit it was £700 to remove 5 sheets from another site

AM – you need to wear masks and paper suits if you are going to move asbestos so we can move it to one side AVM- well if it is asbestos my field is about 1 yard from the nearest bit so we have a problem straight away. So if we can move all the rubbish from around it and just leave that bit there so there is access for people to have a look, that would be better as far as I am concerned rather than it being moved. Can we not move all the rubbish and metal bits from the area.

AM - problem is you have to stand over it to get to the other stuff

AVM – not the bit near my plot as one end of it is partly under the ground.

DF – It's been there for years a years.

MC- the bit behind down from my plot, behind Tony's, there were bits of asbestos everywhere. As part of the asbestos clearance last time, we had rubble type bags to put the stuff as we picked it up.

 $\mathsf{AVM}-\mathsf{well},$  we need to agree on an action guys because this is going on and on

RJ – whether we move it or not, we will have to pay for it to be taken away.

MC – aren't we storing some of it anyway?

RJ – sorry

MC – are we storing some of it anyway

RJ - yes we have some sheets, it's hardly anything.

MC – why are we storing that up there anyway?

RJ – because we were waiting for another large collection of it – there is a minimum charge for the amount they pick up, if you have one sheet picked up it's the same price

AM – well if you get a quote

RJ - well that will verify what it is, there are several types of asbestos and some of it is relatively safe

AM – This is all corrugated roof sheets

MC - it's like what you have at Grafton Rd in the railway carriage

 $\mathsf{AM}-\mathsf{yes}$  it's the same as that

AVM – we can go back and have a look at the area to see what we can do. We should just be able to get rid of the metal frames and stuff.

RJ – there is a minimum charge to remove the asbestos – there is some in Grafton Rd in the railway carriage that also needs to be taken away. Could all be done under one quote

MC – we could get hold of the fencer to get quote and to ask them to measure the gap as suggested by PC. Yes we need to get the stuff moved but we need a final goal and that will be to put a fence up.

AVM – it's easy for someone to get onto the field now

MC - I have thought that for the last 4 years

PC – it's scary how easy it is for someone to get in

MC – let's get the fence finished

RJ - so you will have to go and measure it, we have to cost all of this up

AM – all we can do is measure up on the road because you can't get over at the back of all of the plots to measure it

PC – Anita have you got the contact details of the fencer?

AM - I have yes

PC – can you get him down to quote for it

AM – I think they have a set price per metre and you tell them how many metres you want so they quote you on that.

PC – so you do a physical walk along and that's that

AM- yes

PC – if we can get that and a time, we can work towards clearing it and getting the fence installed

AM – yes then we will know how long we've got to do it – and that will mean the field will be all secure doesn't it. RJ- and the skips?

AVM – skips needed, probably at least half a dozen

RJ – of what size?

AVM - I know they do them in yard or something

DF – 12 yards

PC - the largest

AM – Dave has someone specific who picks up our scrap metal, we don't just let anyone in. He will help come and clear it, he'll drag it out.

RJ- is there any other general waste over there?

AM – yes

RJ - how many skips do you think you will need Alan?

AVM – Mark do you think 6 will do it?

MC – I can t put a figure on it Alan difficult to know, if we clear your bit first we will have a much better idea. If we go in with a strimmer and a chain saw to clear a tunnel, we'll have a much better idea when we have done that . AVM – flowing the line of the barbed wire

MC - The fence could be erected on the barbed wire as there isn't any rubbish the other side of the barbed wire fence. Technically, the fence could be erected now as I can clear the area with the chain saw and a strimmer which means we can then clear the rubbish at our leisure. I can't say that for definite, as we've not cleared it. We've got to get the agreement to go along it with the strimmer and then we'll have a much better idea wont we? PC – we will measure it, get quotes for the fence and get that approved and get it done, set a date for instalment then remove all of the rubbish. I think that's the best way to go.
