RELEASE, INDEMNIFICATION, AND AUTHORIZATION TO USE LIKENESS ("Release")

In consideration of Participant's participation in a camp operated by Pittsburgh Elite Officiating Camps, LLC ("PEOC"), Participant, intending to be legally bound, for himself and his heirs, personal representatives, executors, administrators and assigns, forever releases and discharges any and all rights, demands, claims and causes of suit or action, known or unknown, whether arising now or in the future, that he has now or may have in the future against PEOC and any of its administrators, instructors, independent contractors, any property owners associated with PEOC, and any other participating sponsors and any officers, employees and agents of such parties, for any and all injuries, including death and property damage in any manner arising in any way out of his participation in camps operated by PEOC. Participant attests and verifies that he has full knowledge of the risks involved with officiating ice hockey and engaging in physical activity, that he assumes those risks and that he will, without limitation, assume and pay any medical and emergency expenses in the event of an accident, injury, illness or other incapacity, regardless of whether I have authorized such expenses. **PEOC strongly recommends that Participant consult their physician before engaging in any physically strenuous and/or dangerous activities such as officiating ice hockey and otherwise participating in camps operated by PEOC.**

Participant further agrees, on behalf of himself and his heirs, personal representatives, executors, administrators and assigns, to indemnify and hold harmless PEOC and its administrators, instructors, independent contractors, any property owners associated with PEOC, and any other participating sponsors and any officers, employees and agents of such parties with respect to any and all claims (including any claims brought by Participant or by any of his personal representatives, successors or assigns), losses, liabilities or damage (including, without limitation, attorneys' fees) that arise out of or relate in any way to Participant's act(s) or omission(s) in connection with his participation in PEOC.

Participant hereby authorizes PEOC to use his voice, name, and likeness in connection with any and all promotional and educational materials, including without limitation, videos, advertisements, website materials, social media posts, photographs, posters, brochures, and any and all other materials in any medium created by PEOC or its agents, and that Participant shall be entitled to no compensation whatsoever for PEOC's use of the same.
