Application to race:

I, the undersigned, of my own free will hereby apply to Ultimate Rock Crawling Pty Ltd (“Course Operator”) for the permission to enter and use the property The Rock Farm (“the track”) for the purposes of competing, testing, reconnaissance, recovery, pit work and repairs, as a spectator, crew or any of these combinations.

Warning of Risk:

I acknowledge and agree that competitive driving is dangerous and that accidents can and often do happen. I agree the course operator has the right to terminate any event/test session at any time for whatever reason it sees fit at the time. I declare that I have read and understood these warnings and accept all the inherent risks and danger in racing and testing.

Exclusion of Liability:

I agree to absolve the Course Operator, as well as the landowner, from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my use of the course in any capacity.

Indemnity:

In consideration of the Course Operator granting me use of the land/course, I agree to indemnify them in respect of any actions, suits, proceedings, claims, demands, losses, damages, costs, penalties, fines, whatever arising as a result, directly or indirectly, of my use of the track or any act or omission (including negligence) on the part of the Course Operator.

Should any incident occur in a public area as a result of my failure to comply with the normal track rules or a direction given from an official whereby a successful claim is made under any insurance policy relating to the course and an excess premium or deductible is charged by the insurer of the track I will if required pay the excess or deductible under such insurance policy except to the extent that it is paid by a third party.

Condition of Track:

I acknowledge that I have thoroughly inspected the course and found it to be in safe condition for the activities I intend to undertake. By using the course I indicate acceptance of the track's condition for the activity(s) I will undertake. If an act or occurrence in which I am involved or observe reduces the safety of the course I will immediately notify the Course Operator and warn other course users of the danger and/or increased risk.

I have read, understood, acknowledged, and agree to the above warnings; I have read, understood acknowledged and agree with the Ultimate Rock Crawling (in which I am competing under), and I agree to the above warnings, exclusion of liability, indemnity and I've inspected the course and accept with full knowledge the likelihood of injury and Damage inherent in the Ultimate Rock Crawling Pty Ltd event/series.

I have read and understood the 2022 rules relating to vehicle class and compliance, AMA membership and I confirm that the above entered vehicle complies and is in operational condition.
