IMPORTANT: Registration must be received by the deadline. If you are submitting the registration via US mail, **please allow adequate time for the post office to deliver the registration**. Registrations received after the deadline, even if postmarked before the deadline, cannot be accepted.

- All participants (girls and adults) must be registered Girl Scouts (sorry—no tagalongs).
 - Additionally, all adults participating MUST:
 - Complete a background check
 - Complete Mandated Reporter (AB506) training

ARCHERY AND SLING SHOT PARTICIPATION

- Daisies and Brownie 1 level girls may only participate in sling shots; all other levels may participate in either archery or sling shots.
- Troops who wish to participate in archery or sling shots must indicate this on the registration form. Space on the archery / sling shot range is limited, so spots will be handed out on a first come, first served basis.
- In order to allow the most girls to participate, troops who wish to participate in archery or sling shots must choose one or the other.
- The archery and sling shot events are run by GSCCC council employees as part of the Arnaz Program Center. As such, we must abide by their requirements at all times:
 - ALL girls MUST complete a High Risk Activity Permission Form. This form must be signed by each girl's parent or guardian.
 - The form MUST be submitted at Camporee check-in as part of the check-in packet.

Each girl must have a High Risk Activity Permission Form <u>completely filled out and signed by a parent or guardian</u> and physically turned in to Camporee during check in. Girls without this form will NOT be allowed to participate in archery or sling shots.
