Auditor Travis Morehart summarized the 2021 audit results. First page referenced is page 62 reviewing any findings of the audit. He then reviewed page 51 and 52 discussed the General Fund and 1978 Sales Tax funds. The General Fund increased \$191k. Sales Tax increased \$421k. Page 19 for the Water Sewer which is in good shape. Operations under cash flow statement ended 2021 cash -391k due to increase in repairs of \$286k. Ending the 2021 net increase \$413k increase even removing the projects and ARCA money. Mr. Morehart stated that the Water Sewer still made money even taking out all the repairs and additional money. However, rates need to be reviewed for increase. Mayor Horton stated that we have put in for a rate study. Mr. Morehart said you cannot sit still on your rates because costs keep going up and rates haven't been increased since 2013. Mr. Morehart closed with the statement that the Town is in great shape.

Mayor Horton discussed the application for funds for improvements to the water system. Right now there is a lot of money out there available for water systems. The project we are applying for is to construct a secondary water main from the Bossier Tower directly to our water tower so in the case of a failure to our current water main we can switch over without lose of water for the town. Mayor Horton stated that if we submit engineering plans with the application that will give us more points. This is somewhat of a risk to put money towards a project; however, it will increase our chances for being awarded the grant. Alderman Cathcart felt he needed more information and was unsure of what was being asked of the council to approve. Mayor Horton stated he is not asking for anything I am just informing the council of the funds that are available and we plan to make application anyway for the project. Alderman Cathcart asked that if we spend 50k for engineering to increase our chances to get the grant. Alderman Jones stated that this may be something we need to go ahead and do. A motion was made by Alderman Cathcart and seconded by Alderman Manning to approve paying for engineering for applying for funds to construct a secondary water main.
