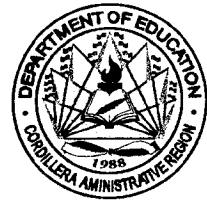




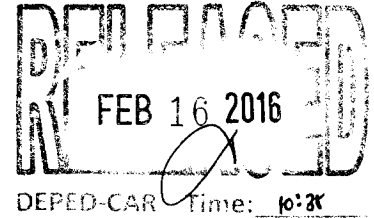

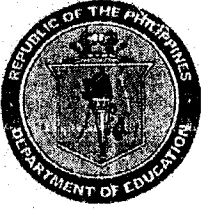
SUBJECT: Construction of Non-DepEd buildings within School Sites
