Military Funeral Honors

"Honoring Those Who Served"

The Department of Defense (DOD) is responsible for providing military funeral honors. "Honoring Those Who Served" is the title of the DOD program for providing dignified military funeral honors to Veterans who have defended our nation.

Upon the family's request, Public Law 106-65 requires that every eligible Veteran receive a military funeral honors ceremony, to include folding and presenting the United States burial flag and the playing of Taps. The law defines a military funeral honors detail as consisting of two or more uniformed military persons, with at least one being a member of the Veteran's parent service of the armed forces. The DOD program calls for funeral home directors to request military funeral honors on behalf of the Veterans' family. However, the Department of Veterans Affairs (VA) National Cemetery Administration cemetery staff can also assist with arranging military funeral honors at VA national cemeteries. Veterans organizations may assist in providing military funeral honors. When military funeral honors at a national cemetery are desired, they are arranged prior to the committal service by the funeral home.

The Department of Defense began the implementation plan for providing military funeral honors for eligible Veterans as enacted in Section 578 of Public Law 106-65 of the National Defense Authorization Act for FY 2000 on Jan. 1, 2000.

WHAT YOU SHOULD KNOW WHEN YOU FILE A CLAIM FOR SERVICE CONNECTION FOR BILATERAL HEARING LOSS AND TINNITUS.

Tinnitus is a noise in the ears, some describe it as a ringing in the ears, and others state it is buzzing, hissing, chirping, whistling or other sounds. The noise can be intermittent or continuous, and can vary in loudness. It is often worse when background noise is low, so you may be most aware of it at night when you're trying to fall asleep in a quiet room.

When filing a claim for bilateral hearing loss and tinnitus it is important to mention what you feel your hearing loss and tinnitus are related to. What incident in service that was so loud that could have damaged your hearing and cause you to have a ringing in your ears. If you had an occupation in service that would be consistent with loud noise exposure then it would be helpful to your claim to link them to your occupation. A single exposure to a sudden extremely loud noise can also cause tinnitus. It is better for your claim if you state the tinnitus has been constant ever since it began in service.

There is no test for tinnitus and you will be asked three questions. 1. Do you experience any noise in the ears? 2. Is the noise in the ears constant or does it come and go? 3. How long have you experienced the noise in the ears?

In order to be service connected for the noise in the ears the examiner will be waiting to hear from you whether you give the following answers: 1. Yes. 2. It is constant. 3. I have experienced it ever since performing my duties in the service (such as aircraft mechanic, sheet metal worker, part of a gun crew, mortar man, engineman or anything that would have exposed you to loud noises in which you had no ear protection).

In 38 CFR 3.159(a)(2) and 38 CFR 3.159(c)(4) the concept of lay evidence is discussed. In the context of hearing loss and tinnitus, the veteran would be competent to provide lay evidence to assert he has hearing loss and tinnitus. Also the Court of Appeals for Veterans Claims in the case of Charles v. Principi said that a veteran is competent to state that he has ringing in his ears and when this phenomenon began.

You will be asked several questions about your exposure to extreme loud noises after service. The key thing to remember is that in service you probably did not have ear protection and after service you probably did.

You will then be asked how long you have noticed the hearing loss and the best possible answer to give is that you feel your hearing was damaged by the same incident that caused you to have ringing in the ears. Do not guess how many years ago that you first noticed the hearing loss because if it doesn't match up with your service your claim will be denied.

Do not take this paperwork to your exam.

WHAT EVERY VETERAN NEEDS TO KNOW

When you receive VA benefits it does not take benefits away from any other veteran.

There is no time limit to file a claim for VA compensation or pension benefits. Veterans serving more than 60 years ago are being awarded benefits everyday.

The number one and two disabilities granted in the Country are bilateral hearing loss and tinnitus (ringing in the ears). Any combat veteran or veteran who had a military occupation that was consistent with exposure to acoustic trauma should file a claim.

Millions of veterans had their records destroyed in the fire at the National Personnel Records Center in St. Louis, MO in 1973. Lost or destroyed records don't mean you can't be granted benefits. It depends on what information is on your Discharge Document.

Most veterans who served in the Battle of the Bulge or Chosin Reservoir are granted total disability benefits from the VA as a result of their cold injuries. If any veteran was exposed to extreme cold temperatures for long periods of time in service they should consider filing a claim.

Any veteran who served on land in Vietnam was exposed to Agent Orange. There are 15 conditions recognized as being related to herbicide exposure. The most common is Type 2 diabetes, prostate cancer, lung cancer and cancer of the larynx. Any of those veterans who have been diagnosed with these disabilities should file a claim for compensation.

Receiving compensation affects what you are entitled to from the VA medical center. Any veteran awarded a 10 percent evaluation is entitled to free inpatient care, outpatient care, eyeglasses and

hearing aids at any VA facility. When a veteran is rated 30 percent or more they are entitled to additional compensation for their dependents. When a veteran is rated 50 percent or more they are entitled to free medication for all conditions whether service connected or not. When a veteran is rated 70 percent a veteran can get free nursing care from the VA. Most veterans who are not gainfully employed and who are rated 60 percent or more can apply for a 100 percent evaluation (individual unemployability benefits). Age is not a factor. A veteran can be 90 years old and still be awarded these benefits.

All wartime veterans are potentially entitled to a pension from the VA depending on their income. Any wartime veteran who is totally disabled or over 65 years old or in receipt of Social Security benefits may be entitled to a VA pension depending on their income and medical expenses. Nursing home care and in-home care are considered medical expenses. Example: Single World War II veteran needs aid and attendance of another person. His income is \$1,520.00 in Social Security benefits. He moves in with his daughter and gives her his income from Social Security to take care of him. His income for VA purposes is reduced to zero because all his income is being used for his care. The VA will award this veteran \$1,519.00 a month in pension benefits.

WARNING TO ALL VETERANS: There are agencies out there that will send strangers to your home to provide services to you in order to get your VA pension benefits. You can get these benefits from the VA without giving your VA pension to these agencies. Our services are free of charge and you don't have to pay an agency \$25-\$35 an hour to complete paperwork on you that we will complete for nothing. These are benefits that you have earned; don't give them to a stranger.


