Covenant Committee Report

As spring arrives in Oklahoma, it brings challenges for the homeowner. Therefore, it is a good time to review the basics of the **covenant landscape requirements** and keep our neighborhood looking great and our investment high. **Landscaping:**

- All homeowners shall keep shrubs, trees, grass and plantings of every kind on their lot, to the curb lines, neatly trimmed, properly cultivated and free from trash, weeds and other unsightly material. If there are designated flowerbeds, please keep free from weeds and grass. Each owner shall replace any plantings, which have been installed on his lot that may die, with equal or like plantings.
- Note: Blowing grass clippings into the street or allowing irrigation water to accumulate in the street damages the neighborhood roads (per the City of OKC). Please advise lawn contractors of this.

More covenants - cited for noncompliance:

- **Trash cans** left out where they can be seen from the street.
- Satellite dishes installed where they can be seen from the street in house front
- Basketball goals not stored out of site when not in use
- Vehicles that are not driven "daily" may not be parked in the driveway or in front of the house. A residence with a three-car garage can have no more than three cars parked in the driveway overnight.

Letters will continue to be sent for notification of noncompliance of covenants. After three notifications and with no correction, the issue will be turned over to our legal representative for resolution.

Your neighbor greatly appreciates your positive response to the covenant letters. They are a tool to keep neighbors informed, to help keep our neighborhood desirable and valuable.



Landscape Committee

Spring is arriving quickly and the landscape committee has already met to develop a plan to enhance the landscaping in the Glenhurst addition. This year we have contracted out the landscape maintenance (mowing, edging, trimming, etc.) separately from the fertilization and

weed control. We hope to end up with a better product and see an improvement in the common areas with this approach of separate contractors, each doing their specialized maintenance. The contractors are Landscape Partners and Don's Pest and Weed Control.

It was decided at our meeting in March to spend the spring dollars in cleaning up existing landscaping. Trimming the trees along MacArthur that are growing into the power lines (before the City does it for us in their "chop" method) is a priority. Removal of the diseased and/or dead cedar trees along 122nd, and removing and/or trimming and anchoring the vines along the neighborhood fence on 122nd is another immediate project. An estimate has been requested from our contractor for the cost to level the grass at the curb line in a few areas to make a cleaner look and allow the irrigation system to pop up and work efficiently. We also need to look into the irrigation system at the 118th entrance and rework that area to increase the water pressure necessary to adequately irrigate that area.

A little later into spring we will be able to tell what has survived in the beds at the entrance signs and determine what needs to be replaced or added.

In the fall, the committee wants to take a hard look into a long-range plan to plant more trees at the entrance signs, and possibly re-work, update and refresh the look along the 122nd and MacArthur right-of-ways. Looking into a grant might be a method to get help with this cost. Another area needing attention is the area along Glenhurst Blvd. from 121st Street south to the north end of the pond. The area along the drainage ditch on the west (gated fence side) and along the neighborhood fence on the east could use some landscaping to "soften" the look.

A big "thank you" to the Davis family for prepping and fertilizing the 28 Nelly Steven Hollies on the common grounds.

OKLAHOMA CITY MUNICIPLE CODE

8-48. Defecating on sidewalks, public parks, alleys, other places open to the public or on certain private property prohibited; possession of waste removal equipment required; prohibition of similar acts.

(a) It shall be unlawful for the owner, keeper, or person having control of any animal to fail to immediately remove and dispose of in a sanitary manner any solid waste deposited by such animal upon any sidewalk, public park, alley, other place open to the public, or from private property before the owner leaves the immediate area where the solid waste was deposited.

(b)It shall be unlawful for the owner, keeper, or person having control of any animal to fail to have in his/her possession the equipment necessary to remove his/her animal's solid waste when accompanied by said animal on public property or public easement.

c).It shall be unlawful for the owner, keeper or person having control of any animal to permit such animal to destroy or damage property of any kind or to deposit solid waste or to commit a similar prohibited act on the private property of a person or the property of the City, including its parks and playgrounds, or any property other than that of the owner of the animal.

GLENHURST SECURITY

The Neighborhood Alliance of Central Oklahoma publishes a monthly newsletter and crime watch report (http://nacok.org/crime-reports). In the current report, one of the statistics we want to see perpetually repeated is "Total incidents reported for Neighborhood Glenhurst = 0." In addition to the Neighborhood Alliance, another excellent resource to research crime reports in the Oklahoma City area is News 9 Crime Tracker (http://www.news9.com/category/161407/crimetracker). The Crime Tracker provides easy access to historical information, and is more graphical and easier to select a specific watch area.

While it is nearly impossible to stop crime, the Glenhurst Neighborhood Patrol is one of the most effective measures to discourage crime in our area. There is a dedicated group of individuals that share the responsibility to watch over our community. The patrol's job is basically just to make prospective vandals or burglars aware that we are watching. On average, there should be at least 10% participation from residents in the Neighborhood Patrol program. There are a number of new homes and neighbors in our community. However, new participation in the Neighborhood Patrol has been very slim. We need more volunteers to share this important duty.

If you want to join the Glenhurst Neighborhood Patrol or just want to find out more information, please contact Steve Smith. The requirement for participation is a one-hour training program conducted by MSgt Robert Skalla of the Oklahoma City Police force. Patrol teams consist of two adults who have attended the training session. The next training sessions are at 7 PM on April 22nd, May 27th and June 24th at the Hefner Police Station on NW 122nd St. just West of Hefner Parkway. Steve Smith, Security Chair
