SPRING 2022 IMPORTANT DATES & INFO

- **Saturday and Sunday April 9&10:** Picture Days with Mr. Paulson at the studio/senior center where we normally have class. Everyone should arrive 5-10 minutes early, dressed and ready to go. Please do not arrive earlier than this as we do not have the space for multiple groups and need time to keep things organized. More instructions on costume care and wear are in this packet. Times listed below.

For Picture Day: Every group should arrive in the costume listed below. Once the group photo is taken, your dancer can change into their other costume for an individual photo (if you choose to order), or they can line up in the costume they are already wearing for their individual picture. (You may choose the costume your child will wear for their individual photo.)

 - 11:30-12:00 PM~ Third Group:** Girls: wear your trunk underwear, tights, pink jazz dress, hairpiece, and ballet shoes ~ Brantley: Jazz outfit with silver vest and tie
 - 12:45-1:15 PM~ Fourth Group:** Wear your trunk underwear, tights, gold/black jazz dress, accessories (hat and binoculars), and ballet shoes
 - 1:30-2:00 PM~ Fifth Group:** Wear your tan underwear, tights, burgundy ballet dress, and ballet shoes

PLEASE NOTE: All dancers are performing at both recitals. Tickets are sold on a first come, first served basis. If you plan to attend both recitals, you must purchase tickets for both. If you (the parent) are only attending one show, that is fine but your dancer still needs to be present to perform. There are 575 seats available per show and may likely sell out. Please have extended family members choose between recitals so everyone can attend! Tickets will not be sold the day of the recital- they must be purchased in advance.
