- Donated partial payment for a shipment of Braille materials for SEKOMU in Tanzania.

Early Intervention: Laying the Foundation for Learning

During the month of December 2016, I became an IASE volunteer and I had the privilege of working with Dean Nga at Ho Chi Minh City University, Department of Special Education and her teachers in the Early Intervention program. The Early Intervention program, a program designed by Dean Nga, a strong visionary leader, was set up to provide education and support to young children who were identified to be at risk of developing behavioral or academic problems.

I had the opportunity to provide information to Dean Nga and the Early Intervention teachers on Executive Function and Self-Regulation and the impact those skills have in a child's life. I modeled how executive function and self-regulation skills could be incorporated into lesson plans and in the implementation of behavior interventions. Upon Dean Nga's request, the teachers and I reviewed the developing of IEP goals and objectives aligned to the BASIC3 Curriculum Framework. The BASIC3 Curriculum Framework had been introduced to the special education department by Craig Goldsberry a year earlier. The BASIC3 program is centered on a functional curriculum that supports students develop independence as adults.

During our time together, the teachers and I engaged in creative and fun activities by role playing different scenarios, designing behavior charts, creating differentiated lesson plan formats, developing effective collaboration strategies and transforming a room space into an engaging student centered learning environment.

My experience working with Dean Nga and the teachers was an uplifting and positive experience. I found all the teachers and assistants involved with the Early Intervention program to be open in exploring new information related to the developmental stages of young children. The dedication of these teachers in meeting the challenges of starting a new program with a clear commitment to providing quality academics, emotional and behavior support to their students is nothing but PHENOMENAL.

Next we went to the National Association for the Blind to deliver a new computer with software to a young lady named Teena. Dependra Manaocha and Prashant Ranjan Verma representing the DAISY Consortium were present. Being able to have lunch with Sanjay, my agent from Culture Holidays, was special at his new restaurant because he gave me a few new Rupee and best wishes for having a safe travel in his country.



My next flight landed in Visakhapatnam situated in eastern India on the Bay of Bengal. I immediately noticed many improvements since the last year and the devastation caused by the cyclone....such as the airport now having a new roof! At Lebenshilfe to celebrate the World Day of the Disabled, I was honored by a Tiger Dance performance, students songs, and a puppet show presented by staff members. IASE GIVING honored the teaching staff with an Appreciation Luncheon at the lovely Daspalla Hotel. Plus I carried Big Keys Keyboards and Key Guards for their new computer room.

Dr. Sarah Devi sends her appreciation to IASE for their continued support over the last 10 years.

My plans were to fly from Visakhapatnam to Cochin via Hyderabad. BUT, fog at the Delhi Airport prevented this from happening. Instead I was diverted to the Chennai Airport located in the southeastern corner of India.

I spent about twelve hours awaiting a flight prior to the approaching cyclone. Again I was saved by my agent Rajeeesh from Globes Travel, who showed up at the Cochin Airport in the middle of the night and made sure I had a driver for the next hour of travel to reach Don Bosco in Cochin which is located in the southwestern corner of India. Father Joe Fernandez greeted me at 2:30 AM and ushered me to my room. The next day I was shown wonderful Indian hospitality and given a tour of the brand new Don Bosco Psycho-Social Support Centre which last year was a dream and today is a huge building. Under the motto of "Better Self, Better World" the staff are offering Counseling, Life-Skills Development, a beautiful library, a new computer room, Martial Arts, and Music including guitar, violin, table and flute lessons. Father Fernandez states, "We gratefully acknowledge the donation from IASE towards the construction of toilets and a bathing facility for our children. We take this opportunity to thank IASE for the support that they have been extending to us for the past several years." I was also taken to the two new girls housing sites and was serenaded at each with Christmas songs. It is always nice to return to meet the girls again and to see them developing into lovely young ladies. Thanks to Don Bosco in Cochin for making this a positive influence in their young lives.

My final visit was to Mumbai and the SPJ Sadhana School and OM Creations. I was hosted by Dr. Radhike Khanna and her parents at their beautiful home. With the expert help of Teacher Tejal Kothari, I was able to use IASE GIVING funds to purchase two embroidery machines, a sound system, a computer and printer, and some chocolate treats. Students at SPJ Sadhana School had huge smiles when they saw the embroidery machine as it was delivered. And the microphones with the sound system brought out the best in the music students. With a microphone in the hand of a special student, all inhibitions of stage fright were washed away. I was the guest at a lovely concert of drumming and song. A visit to the newest venture of Dr. Khanna and OM Creations, located about 1 ½ hours east of Mumbai in a beautiful rural area of rolling hills and many trees, showcased a brand new huge Administrative building. A ceremony involved breaking the coconut, then singing and dancing highlighted by a special dance performance by Nicole. Plans are to have a whole village of 180 women and 180 men living and working to their full potential in this location. The girls who work at OM Creations in Mumbai plus their staff members were in attendance to see the new building and have a walking tour of the site. Then all commenced to the new Radisson Blu Hotel for a luncheon and a bit of dancing to end a lovely day.

A note of appreciation from Sister E. Gaitonde at SPJ Sadhana School relays, "You come as Santa and we are grateful that IASE has gifted us to help improve the skills enhancement of our students. Thanks for understanding our needs." Ranjana Mahadevia, a Trustee of OM Creations, writes, "Thank you for your generous gift. We are very much touched by your generosity. Your compassionate support will enable us in reaching out to more young adults with educational and rehabilitation opportunities to help specially abled women to lead happy and productive lives."

So...many thanks to all of you IASE members who have provided many smiles to the special children...and I add to the staff members who guide them in the daily process of helping all become more productive and better citizens of India and the world.

Below are the suggested changes (additions and replacements printed in red and deletions are crossed out) to our By-Laws and Constitution that will be voted on during our June 27, 2017 General Membership Meeting. **All Job Descriptions for officers and committee members will be posted on the IASE website.**

ARTICLE I

Offices

.... shall maintain in the State of Wisconsin a registered office and a registered agent at such office, and may have ~~other offices within or without the State.~~ **subsidiary offices outside of the State of Wisconsin.**

ARTICLE II

Purpose

IASE is organized under Chapter 181 Nonstock Corporations of the Wisconsin Statutes. The purposes of IASE shall be to: c) Encourage and promote research to advance the field of special education and share that information through our official publications **on the IASE website.** f) **Encourage members to become volunteers to share their experiences, knowledge and skills with teachers, parents, students and the community at the Volunteer Service Project sites in developing countries.** g). To perform any such other legal functions as the Board of Directors may determine by a majority vote.

ARTICLE III

Members

Section III.1 Membership. IASE Membership shall be open to any interested person. ~~Membership shall be granted upon payment of dues and shall run from January 1 to December 31 of each year.~~ All membership dues and fees shall be determined by a vote of the members at the biennial membership meeting.

Section III.1 A. Membership, Individual. A rolling membership shall be granted upon payment of dues for one year at a time and receive newsletters and journals for that period of time.

Section III.1 B. Membership, Institution. A rolling membership shall be granted to a school, organization, ministry, NGO, or agency upon payment of dues for one year and receive newsletters and journals for that period of time. The institution membership fee entitles four of its members to register for the biennial conference as fully paid members.

Section III. 3 Resignation/Termination. Membership shall ~~also terminate upon the death of a member.~~

Section III.4 Removal. By a majority vote of members of the Board, membership of any IASE member may be terminated for cause. ~~The cause being guilty of misconduct, illegal acts or abusive language or for any act of a member likely to be detrimental to the reputation of IASE.~~

Termination for cause shall be defined as being found guilty of any criminal charge involving moral turpitude, being involved in illegal acts or abusive language toward other members which the Board of Directors determines, in their sole discretion, to be detrimental to the reputation of IASE. Board of Director's decision will be final in all respects.

Section III. 6 No Membership Certificates.

No membership certificates of IASE shall be required. However, the Board of Directors may issue membership certificates and/or membership ID cards **on an as needed basis as determined by the directors.**

Section III.9 Privacy statement. IASE does not sell nor barter the membership list

ARTICLE IV

Meeting of Members

Section IV.1 Membership Meetings.

Membership meetings shall not be held in the alternate years (non-biennial conference years), except that in the event that the Board of Directors determines that there are any matters which require membership approval, or if an annual membership meeting is requested, **by 51% of the members,** then the Board of Directors shall call for an annual membership meeting, which meeting shall be held at such time and place as designated by the Board of Directors.... or if an annual membership meeting is requested ~~by any member,~~ then the Board of Directors shall call for an annual membership... meeting, which meeting shall be held at such time and place as designated by the Board of Directors.

Section IV.7 Quorum and Transaction of Business. Unless otherwise provided by law, when a quorum is present at a meeting, a majority of the votes represented thereat shall decide any question brought before such meeting. **Proxy votes will be accepted for any meeting, using the IASE Proxy Form and requesting one of the voting members of the Board to serve as the proxy.**

ARTICLE V

Board of Directors

Section V.2 Number, Tenure and Qualifications.

The number of directors shall be eight (8): President, President-Elect, ~~Immediate Past President,~~ Secretary, Treasurer, and three (3) members-at-large who shall make up the Board.

Section V.7 Notice. ~~If notice be given by telegram, such notice shall be deemed to be delivered when the telegram is delivered to the telegraph company.~~
