AN ORDINANCE AMENDING VILLAGE CODE

(Chapter 7-Public Safety, Subchapter 4-Nuisances)

BE IT ORDAINED by the President and the Board of Trustees of the Village of LILY LAKE, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

§ 1. Amending Village Code

Chapter 7-Public Safety, Subchapter 4-Nuisances, section 761(c) is amended as shown below and new sections 761(g) and 765 are added and the remaining sections of Subchapter 4 are renumbered accordingly:

§ 761(c) *inoperable motor vehicle* means any motor vehicle from which, for a period of more than 14 days, the engine, wheels or other parts have been removed, or on which the engine, wheels or other parts have been altered, damaged or otherwise so treated that the vehicle is incapable of being driven under its own motor power;

* * * * *

§ 761(g) unimproved surface means any surface other than one improved as a driveway or for parking purposes by the addition of gravel, asphalt, or concrete in accordance with the subdivision regulations and zoning ordinance of the village.

* * * * *

§ 765. Parking of any vehicle on unimproved surface

Parking any vehicle on an unimproved surface in the front yard of any lot or parcel of land for more than 10 days is declared a nuisance. Parking any vehicle on an unimproved surface in the front yard or side yard adjacent to a street of any comer lot for more than 10 days is declared a nuisance.

§ 2. Repealer

Any ordinance or any provision of any ordinance in conflict with the provisions of this ordinance is, to the extent of such conflict, repealed.

§ 3. Effective Date

This ordinance is fully effective from and after its passage, approval and publication as provided by law.
