## 2019 DCA Agility. A Mudder's Tale. By Pam Devlin

Here in the Northeast, and perhaps much of the country, agility trials are largely held indoors. The chief reasons are the inconvenience of bad weather and the fear of difficult/dangerous footing. The consistency of conditions and relative safety of indoor trials are a good thing. Who doesn't like to avoid a course covered with snow? I appreciate a venue without direct sun and intense heat. I am a fan of air-conditioning in August.

Two years ago, an agility judge and fellow competitor who is part of my regular training circle lamented about this fact. She insisted that the experience of trialing outdoors was worth the pitfalls. She believed it was a more unique and memorable experience that went beyond Qs and brought people together. I didn't really get it then... but I do now.At our 2019 DCA this past May, there is not one of us running a dog who will forget the cold, the wind or the deep mud. The Qs were rare and well celebrated by all. Sportsmanship, support and comradery was in abundance. We were all soldiers in the same fight.

My trip to DCA was a two day affair. I split the drive so I would not have to be on the road more than 5 hours at a time. Though I have lived in the middle of nowhere for the last 20 plus years and everything is well over an hour from me, I was born and raised in New York City and don't particularly like to drive. I complained like a five year old about my travel to get there... until I met other teams who had been traveling from California, parts of Canada and the like. Teams that were on the road for 5 day just to get there... A very long and expensive trip for such tough conditions and more often than not, no Q.

This year- 2019, DCA was held at the beautiful Cedar Creek Resort in Huron Ohio. A wonderful venue with lovely lawns, blooming fruit trees and songbirds. Many places to walk dogs, wide open pens for safe exercise and off-lead play. A perfect place... unless you arrive during global warming's lingering visit. We missed the bulk of the rain but suffered the after effects. Cold temperatures- 47 degrees when the average is 72, piercing cold wind and deep mud from all the rain. The mud and the soft, soaked lawn became much worse as the trial continued. Constantly trampled on for two days, the footing was precarious. I was never so cold, muddy and wind burned. I was never so thrilled with my Qs or proud of my dog.

It is likely that a future DCA in this same local will choose to hold the agility trial at a nearby indoor facility. A good thing. Very practical and I would prefer a safer more stable environment, I mostly trial indoors for that very reason. I have trialed several times since our 2019 DCA and the venues have been indoors. I've had some great runs and Qs... but none stick in my mind the way the ones at 2019 DCA does. Those memories of friends met, friends made and Qs earned will be sweet forever.

Congratulations to all teams who braved the elements and ran in such challenging conditions- Nanci Hays and Arabella, Sandy Lajoie and Nova, Tod Hebert and Atty- with a 1<sup>st</sup> in premier jumpers and master standard/jumpers on Day I, a 1<sup>st</sup> in premier standard/jumpers, time to beat and master standard/jumpers for DCA High in Trial in both, to Linda McSherry and Felicity- a 1<sup>st</sup> with a clean run in Novice B Jumpers on Day I and a 2<sup>nd</sup> in Novice B jumpers to earn the NAJ title on Day 2, to Sara Pruyne and Luu Luu- a 1<sup>st</sup> in Novice B Fast and 3<sup>rd</sup> in Open Standard. Pam Devlin and Dinah earned the Master Standard Bronze title on Day I with a 2<sup>nd</sup> place and a double Q in master standard/jumpers both in 2<sup>nd</sup> place on Day 2.






