

ORDER-TOWN OF FARMINGTON

A petition, addressed to the Town Board and praying for the establishment of a town sanitary district in the Town of Farmington, having been filed with the Town Clerk, and on due notice a public hearing having been held on said petition, at 1:30 o'clock P. M., on the 14th day of August, 1971, and the bond required by law having been waived;

Now, after consideration of all objections to said proposal and the reasons in favor of it, we, as such board, do hereby declare and find that the said petition is signed by the requisite owners of real estate, as provided in s. 60.302 (1) of the statutes, and that the proposed work is necessary, and that the public health, comfort, convenience and welfare will be promoted by the establishment of such district and the property included in the district will be benefited by the establishment thereof.

NOW, THEREFORE, IT IS HEREBY ORDERED, that a town sanitary district is hereby organized, the corporate name of which shall be Waupaca Chain O'Lakes Sanitary District No. 1 of the Towns of Farmington and Dayton, and the boundaries thereof are hereby established as follows:

All lands lying within 1,000 feet of the shorelines of the lakes within the Towns of Farmington and Dayton commonly known as Waupaca Chain O'Lakes.
