## **BILL 22-13 – OFFENCES CONCERNING PUBLIC PEACE**

# **UPDATE ON COMMISSIONS AND COMMITTEES**

White expressed the excitement on behalf of the PD Activities Committee for the Treats on the Trail on October 29, 2022 from 3-5PM.

Rick Gamboa presented on behalf of the Duquesne Memorial Park Committee. Gamboa expressed that they are still waiting to hear from Harry S. Truman about approval or rejection of the grant. Gamboa stated a desire to have everything prepared ahead of time allowing the project to begin upon approval, if received. Mayor Bill Sherman stated that he would follow up with the city engineers to make sure they did not need anything else at this time or have any questions.

Mayor Bill Sherman received an application for Sonya L. White for the Board of Adjustments. Motion made by Baine, seconded by White to accept Mayor Bill Sherman's appointment of Sonya L. It was determined that Mayor Bill Sherman would contact Voya for clarification.

Motion made by White, seconded by Ellsworth to discontinue any match made by the City of Duquesne to Voya as of the last pay period in November. Voting in favor were Baine, White and Ellsworth. Nays: none. Motion carried.

Mayor Bill Sherman stated the need for a hiring board for the position of City Clerk. Attorney Mike Talley stated that only one council member would be able to be present to prevent a quorum. Mayor Bill Sherman requested that the hiring board be made up of the Mayor, Chief White and an Alderman. Mayor Bill Sherman stated that he would like to advertise the opening for the position of City Clerk. The board agreed that the Mayor should advertise this position.

Motion made by Ellsworth, seconded by White to appoint Flo Dempsey, Janet Stemn and Mayor Bill Sherman as acting Clerks. Voting in favor were Baine, White and Ellsworth. Nays: none. Motion carried.
