- Per PAX per SECTOR only is allowed to request one package only
- Prepaid baggage is only available on GA ticket (126) and operating Flights Domestic and International (All GA Route)
- In case of transit/connecting Flight, Prepaid Baggage shall issue for all sector and shall not be issued for single connecting sector only. For Example:
 - a. Route CGK/XDPS-TIM
 Prepaid Baggage is allowed to all sectors (CGK/XDPS-TIM)
 Prepaid Baggage is NOT allowed for JKT DPS only or DPS-TIM only.
- Prepaid Baggage may be purchased for adult and children only.
 Prepaid Baggage only can be sold above 24 hours before departure. Status of services will be "NO" (No Action Taken) is requested under 24 hours before departure.

G. Changes and Refund

For Voluntary case

Refund is only allow for

- > Totally unused EMD Prepaid Baggage (Refund shall not be applied for party weight used of EMD Prepaid Baggage)
- ➤ Submission before date of flight departure

 Refund for unused Prepaid Baggage's EMD shall be submitted at the latest 24 hours (twenty four hours) from the date of departure. EMD coupon status must still Open "O" so check in / ticketing staff need to disassosiate the EMD first to keep the coupon status is OPEN.



e.g Pax have flight schedule on 17 October 2020 the request shall be submitted maximum on 16 October 2020.

- > 25 % penalty from basic fare of Prepaid Baggage rate shall be implied for refund.
- > In case of Voluntary reroute, if the new Prepaid Baggage rate is lower than original rate, no residual value shall be refunded.
- > In case of Voluntary reroute, if the new Prepaid Baggage rate is higher than original rate, additional charge shall apply.
- No Change of penalty fee shall apply in case reroute and reissue.
- For EMD issuance where the ticket was issued at the Travel Agent (other than Garuda Indonesia Ticketing Office) document shall be refunded at:
- > ---- Passenger's ticket shall be refunded at original issuing office
- > ---- EMD Prepaid Baggage shall refunded at Garuda Indonesia Ticketing Office

2. For Involuntary case

- "Involuntary Refund " for EMD Prepaid Baggage means a refund of unused EMD due to some of the following circumstances caused by Airline (Flight Cancelation, Flight schedule Change, Failed of re-accommodating, over or under carriage, Offloading, Misconnection, Safety or Legal reason, Force Major) refund of EMD Prepaid Baggage can be processed at the GA ATO or CTO
- > Involuntary Refund when there is a condition refund of unused EMD due to reroute condition caused by Airline, user is allowed to do reissue with no additional cost
