DEPARTMENT HEAD REPORTS:

a. Assessor – Board of Assessment Meeting, Thursday, May 27, 2021. Additionally, the state approved our assessment rate at 98%.

b. Hwy Superintendent BeGell reported that they Hauled Item 4, Repaired storm damage, Graded the following roads; Gosper, Gafney, Miller Hill, Lodge, Cemetery, Reservoir Hill, Ackerson, Hallett, Rouse, Chappell and Towner Road (150 feet). Met with numerous people including: B&W, Vantage Equipment, Superior, Sedam Tire, Soil and Water, and Steuben County. Gearing up for major project that is scheduled to start June 14, 2021 (Irish Hill and Mose Road). Expect to be fully reimbursed by CHIPS. Considering purchasing 8 rear tires before prices increase and while we can still get 10% off.

c. Town Clerk, Town Justice, DCO and Bookkeepers reports were read as submitted. Town Clerk noted that there were 25 expired dog licenses at the end of April 2021.
