### Merchandise

The Artist has the full right to sell merchandise at the event and may request an area and tables for this purpose.

### Advertising

- The Artist and the Client agree to equally split advertising costs, not to exceed \$300 per party. Advertising may include posters, flyers, newspaper ads, radio or television interviews, and press releases.
- The Artist will:
  - Add the event to [www.dannyelvis.com](http://www.dannyelvis.com) and the Danny Elvis Show Facebook page.
  - Mail up to 250 post cards to Danny Elvis Show fans closest to your community.
  - Email news subscribers on the Monday, Wednesday, and Friday before the performance.
  - Supply the Client with up to 50 (fifty) 11 x 17 color posters to display in the community, billable at actual cost.
  - Supply the Client with up to 250 post cards to mail to guests, free of charge (postage is the responsibility of the Client).

## Tickets

- The Artist receives the other 50% of the funds collected for ticket sales, after expenses.

- The Artist receives all funds collected for Danny Elvis and the Legends merchandise sales.

## Setup

- Performance setup will be the responsibility of the Artist (includes backdrops, stage arrangement, lighting, sound equipment, and instruments).
- Client will provide \_\_\_\_\_ {tables, chairs, etc.}.

## Cancellation

- If the Client cancels the performance, the Client is responsible for any non-refundable advertising costs incurred by the Client or Daniel R. Wagner and also any non-refundable deposits for the venue or catering.
- The Artist may cancel the performance at any time due to an Act of God.

This contract is enforceable according to the laws and regulations of the state of North Dakota.
