A. Discussion and possible action regarding: Approval of the March 2021 Financial Reports. (Mindy)

- 1. The revenue for March was \$6,086.01; the total expenses were \$16,304.29 for a total net loss of \$10,218.28. The Cash on hand for March was; the Warrant account-Operations \$95,357.20; the NBA-Payroll account \$10,130.10; the Petty cash \$96.00 for a total of \$105,583.30.
- 2. Kayla Carr made a motion to approve the financials as presented; Jim Fox 2^{nd} the motion; Carr-Yea; Fox-Yea; Knowles-Yea; Motion carried.

B. Discussion and possible action regarding: Approval of a Resolution declaring certain assets as surplus and providing for their disposal.

- 1. Richard Knowles read the resolution out loud to the public. The items included 2 boats, 2 trailers, 1 iPhone, communication equipment radios and chargers, 1 1992 ladder truck, and other miscellaneous items under \$250 dollars. Then it was opened up for discussion. Jim Fox asked what is the communication equipment and Chief Cunningham responded that there was a lot of stuff that was donated to YFD and that was recently expired that made its way here from the tribe and it is equipment that it is not used. The radios might be worth \$200 to \$300 a piece and we do have some interested parties. Jim Fox then asked about the 1992 Ladder Truck. Chief Cunningham responded it's a Ladder truck sitting at Station 2 which is not even serviceable and it is not even in service and this department does not even have the money to fix the truck, so our recommendation is to get rid of it and to make some money from it. Jim Fox asked about the miscellaneous items. Chief Cunningham stated they are items that have been placed in the connex which it is full of supplies that are out dated and have been replaced by the previous administration and its old stuff that has been stock plied out there like old water packs, which together we would get less than \$250 dollars for.
- 2. Jim Fox made a motion to move forward with the sale of these items as mentioned and to approve the resolution stating the same; Kayla Carr 2^{nd} the motion; Carr-Yea; Fox-Yea; Knowles-Yea; Motion carried.
